Duty Cycle Correction During 100msec


Each function key sends a different series of characters, but each packet period (11.4msec) never exceeds a series of 4 long (900 μ sec) and 10 short (300 μ sec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered 4x900 μ sec+10x300 μ sec per 11.4msec=57.8% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.

Remarks:





Figure C [Short Pulse]





Inner Circuit Top View




Inner Circuit Bottom View
