This guidance applies to both licensed and unlicensed devices wherever the FCC rules call for conducted output measurements. Guidance is provided for in-band, out-of-band and spurious emission measurements.

This guidance does not apply to the multiple transmitters included in a composite device, such as a device that combines an 802.11 modem with a cell phone in one enclosure with each driving its own antenna.









Test Procedure for Power Spectral Density

The In-Band power spectral density was measured using the measure and sum approach per FCC KDB 662911 (D01 Multiple Transmitter Output v01.)

Measure and sum the spectra across the outputs. With this technique, spectra are measured at each output of the device at the required resolution bandwidth. The individual spectra are then summed mathematically in linear power units. Unlike in-band power measurements, in which the sum involves a single measured value (output power) from each output, measurements for compliance with PSD limits involve summing entire spectra across corresponding frequency bins on the various outputs. Consistency is maintained for any device with N transmitter outputs to be certain the individual outputs are all aligned with the same span and same number of points. In this instance, the linear power spectrum value within the first spectral bin of output 0 is summed with that in the first spectral bin of output 1, and the first spectral bin of output 2, and so on up to the Nth output to obtain the true value for the first frequency bin of the summed spectrum. 6.1.2. Radiated Emission Testing

FCC, Part 15 Subpart C §15.407(b)(2), §15.205(a)/15.209(a)

Test Procedure

Testing was performed in a 3-meter anechoic chamber. Preliminary radiated emissions were measured on every azimuth and with the receiving antenna in both horizontal and vertical polarizations. Preliminary emissions were recorded with in Spectrum Analyzer mode, using a maximum peak detector while in peak hold mode. Depending on the frequency band spanned a notch filter and/or waveguide filter was used to remove the fundamental frequency.

Emissions nearest the limits were chosen for maximization and formal measurement using a CISPR compliant receiver. Emissions above 1000 MHz are measured utilizing a CISPR compliant average detector with a tuned receiver, using a bandwidth of 1 MHz. Emissions from 30 MHz – 1000 MHz are measured utilizing a CISPR compliant quasi-peak detector with a tuned receiver, using a bandwidth of 120 kHz. Only the highest emissions relative to the limit are listed.

Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Loss, and subtracting Amplifier Gain from the measured reading. All factors are included in the reported data.

FS = R + AF + CORR - FO

FS = Field Strength

R = Measured Spectrum analyzer Input Amplitude

AF = Antenna Factor

CORR = Correction Factor = CL - AG + NFL

CL = Cable Loss

AG = Amplifier Gain

FO = Distance Falloff Factor

NFL = Notch Filter Loss or Waveguide Loss

6.1.3. Digital Emissions (30M-1 GHz)

FCC, Part 15 Subpart C §15.205/ §15.209

Test Procedure

Testing 30M-1 GHz was performed in a 3-meter anechoic chamber using a CISPR compliant receiver. Preliminary radiated emissions were measured on every azimuth and with the receiving antenna in both horizontal and vertical polarizations. To further maximize emissions the receive antenna was varied between 1 and 4 meters. The emissions are recorded with receiver in peak hold mode. Emissions closest to the limits are measured in the quasi-peak mode with the tuned receiver using a bandwidth of 120 kHz. Only the highest emissions relative to the limit are listed. The anechoic chamber test set-up is identified in Section 6 Test Set-Up Photographs.

The EUT had two methods of powering on ac/dc converter and Power over Ethernet (POE). Both modes were tested for emissions below 1GHz.

Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Loss, and subtracting Amplifier Gain from the measured reading. In this test facility, the Antenna Factor, Cable Loss, and Amplifier Gains are loaded into the Rohde & Schwarz Receiver and the corrected field strength can be read directly on the receiver.

FS = R + AF + CORR

where:

FS = Field Strength
R = Measured Receiver Input Amplitude
AF = Antenna Factor
CORR = Correction Factor = CL – AG + NFL
CL = Cable Loss
AG = Amplifier Gain

For example:

Given a Receiver input reading of $51.5dB\mu V$; Antenna Factor of 8.5dB; Cable Loss of 1.3dB; Falloff Factor of 0dB, an Amplifier Gain of 26dB and Notch Filter Loss of 1dB. The Field Strength of the measured emission is:
