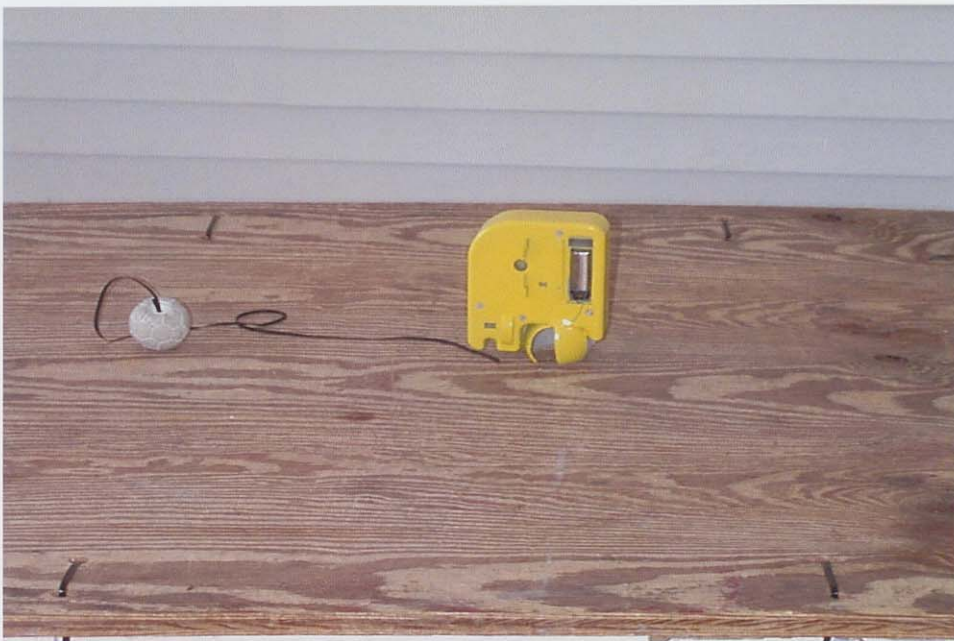

Total Input Power & Harmonics

Total Input Power to final Radio Frequency Stage per FCC Part 15.219 was measured to be 81.0 mW which is 19 mW below the allowable 100 mW limit. We then measured the field strength of the fundamental and found it to be (52.5) dB μ V/m at (3) meters. This amplitude is below the limit stated in the general radiated emissions (15.209). Once the field strength of the fundamental was established, the harmonics were each measured and compared to a limit which was set at (20) dB below the measured fundamental level.

Magnetic loop antenna is active and includes a preamplifier.

The test methodology followed during the collection of the data included within this technical report was ANSI C63.4:1992.

The EUT was powered with (120) VAC / (60) Hz during the collection of data included within.

The data is compared to the FCC Part 15 Class B limits.

The "EMI" instrumentation is capable of calculating the final emission level based on the following formula:

Level at the receiver (dB μ V) + Antenna Correction Factor (dB/M) + Cable Loss (dB) - Preamp Gain (dB) = Actual Level in dB μ V/M.
