





Duty Cycle Correction During 100msec


Each function key sends a different series of characters, but each packet period (33msec) never exceeds a series of 26 long (525 μ sec) or short (525 μ sec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered 26x525 μ sec per 33msec=41.4% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.

Remarks:

Duty Cycle Correction = 20Log(0.414) =-7.6dB





Figure C [Short Pulse]


