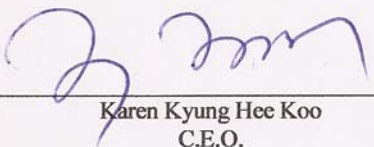
In authorizing UL Korea as our agent, we still recognize that we are responsible to:
