Calculation

Given

$$E = \sqrt{\frac{30 \times P \times G}{d}} \quad \& \quad S = \frac{E^2}{3770}$$

Where

E = Field Strength in Volts / meter

P = Power in Watts

G=Numeric antenna gain

d=*Distance in meters*

S=Power Density in milliwatts / square centimeter

Combining equations and re-arranging the terms to express the distance as a function of the remaining variables yields:

$$d = \sqrt{\frac{30 \times P \times G}{3770 \times S}}$$

Changing to units of mW and cm, using:

$$P(mW) = P(W) / 1000$$
 and

$$d(cm) = 100 * d(m)$$

Yields

$$d = 100 \times \sqrt{\frac{30 \times (P/1000) \times G}{3770 \times S}} = 0.282 \times \sqrt{\frac{P \times G}{S}}$$

d = distance in cm

P = Power in mW

G = Numeric antenna gain

Maximum Permissible Exposure (2.4 GHz Band)

S = Maximum power density (mW/cm²)

P = Power input to the antenna (mW). = 56.10

G = Numeric power gain of the antenna = 1.58

R = Distance to the center of the radiation of the antenna (20cm = limit for MPE) = 0.02^2

The maximum permissible exposure (MPE) for the general population is 1.00 mW/cm².

$$(56.10 * 1.58) / (4\pi * 0.02^2) = 0.0176 \text{ mW/cm}^2$$

The power density at 20cm does not exceed the 1 mW/cm² limit. Therefore, the exposure condition is compliant with FCC rules.
