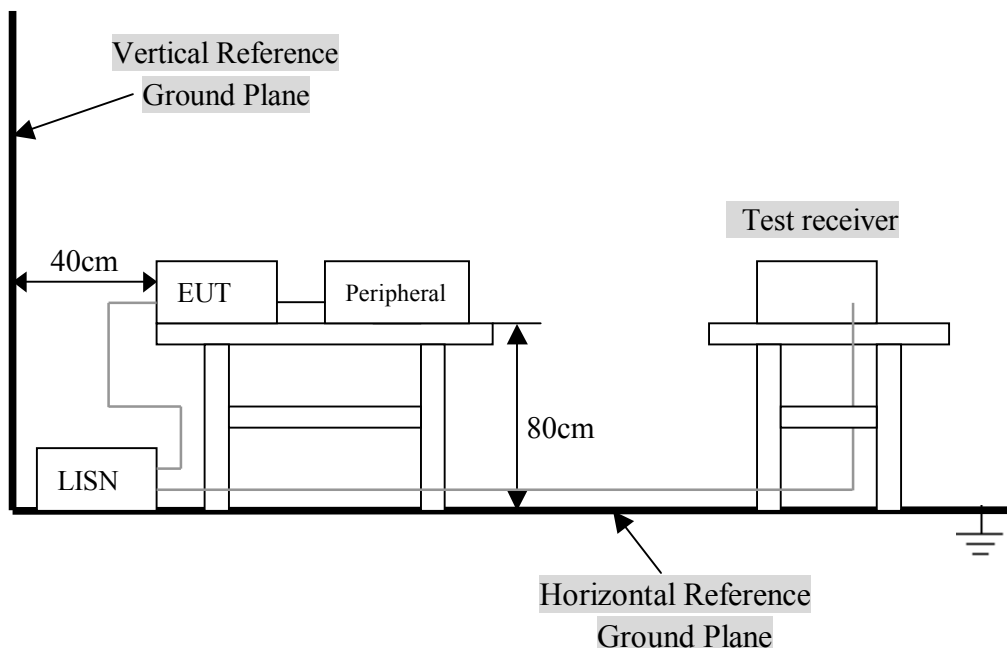

4.2 Test Procedure

The EUT and simulators are connected to the main power through a line impedance stabilization network (L.I.S.N.). This provides a 50 ohm/50uH coupling impedance for the measuring equipment. The peripheral devices are also connected to the main power through a LISN that provides a 50ohm/50uH coupling impedance with 50ohm termination.

Both sides of A.C. line are checked for maximum conducted interference. In order to find the maximum emission., the relative positions of equipment and all of the interface cables must be changed according to ANSI C63.4:2001 on conducted measurement. Conducted emissions were invested over the frequency range from 0.15MHz to 30MHz using a receiver bandwidth of 9kHz.

4. 4 Configuration of the EUT

The EUT was configured according to ANSI C63.4-2001. EUT was used DC 5V (Power by Battery). The operation frequency is from 2414MHz~2468MHz. Enable the signal transmitted from the external antenna from EUT to receiver. All interface ports were connected to the appropriate peripherals. All peripherals and cables are listed below.

Note:

- 1) Below 1GHz, the channel 1, 2, 3 and 4 were pre-tested, The channel 4, worst case one, was chosen for conducted and radiated emission test.
- 2) Above 1GHz, the channel 1, 2, 3 and 4 were tested individually.

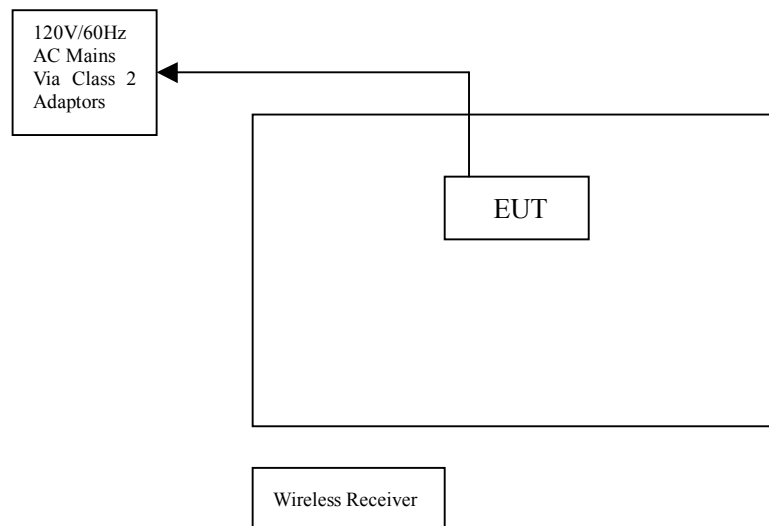

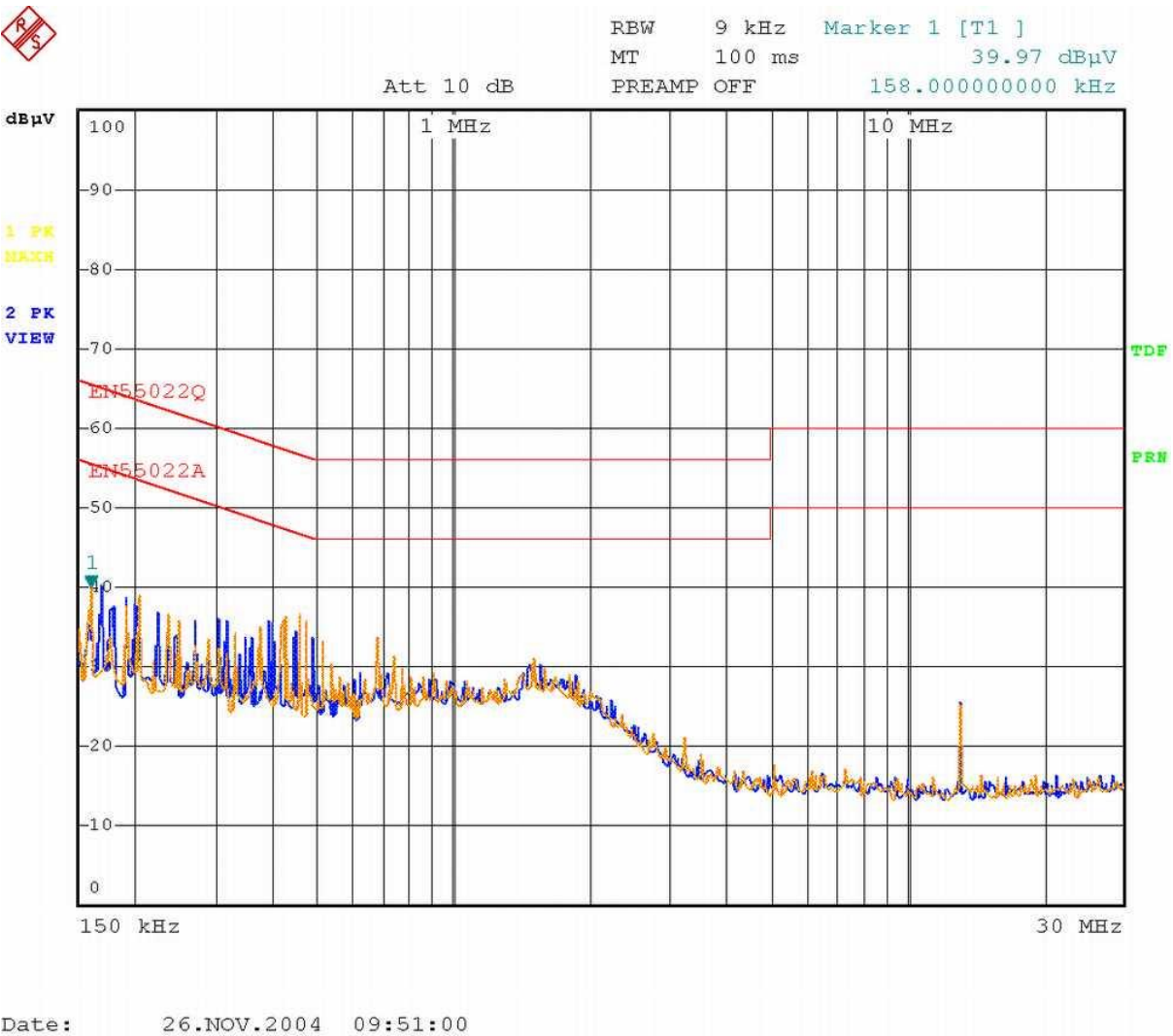

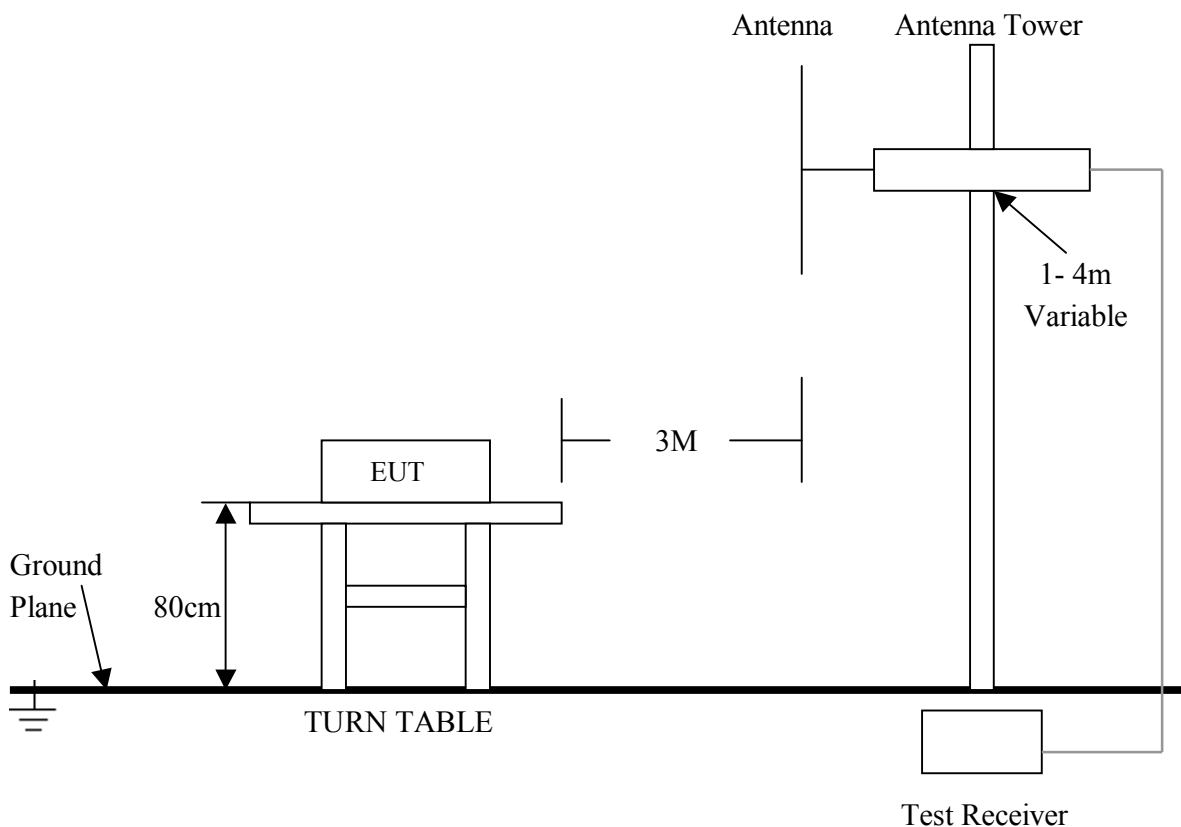
5.1 Test Equipment

5.2 Test Procedure

1. The EUT was tested according to ANSI C63.4 - 2001. The radiated test was performed at Ke Mei Ou Laboratory .This site is on file with the FCC laboratory division, Registration No. 125782.
2. The EUT, peripherals were put on the turntable which table size is 1m x 1.5 m, table high 0.8 m. All set up is according to ANSI C63.4-2001.
3. The frequency spectrum from 30 MHz to 1 GHz was investigated. All readings from 30 MHz to 1 GHz are quasi-peak values with a resolution bandwidth of 120 KHz. All readings are above 1 GHz , peak values with a resolution bandwidth of 1 MHz . Measurements were made at 3 meters.
4. The antenna high is varied from 1 m to 4 m high to find the maximum emission for each frequency.
5. Maximizing procedure was performed on the six (6) highest emissions to ensure EUT compliance is with all installation combinations. All data was recorded in the peak detection mode. Quasi-peak readings was performed only when an emission was found to be marginal (within -4 dB of specification limit), and are distinguished with a "QP" in the data table.
6. The antenna polarization: Vertical polarization and Horizontal polarization.

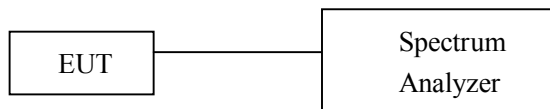

6.2 Test Procedure

1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
2. Position the EUT without connection to measurement instruments. Turn on the EUT and connect its antenna terminal to measurement instrument via a low loss cable. Then set it to any one measured frequency within its operating range and make sure the instrument is operated in its linear range.
3. Measure the highest amplitude appearing on spectral display and set it as reference level. Plot the graph with marking the highest point and edge frequency.
4. Repeat above procedures until all measured frequencies were complete.

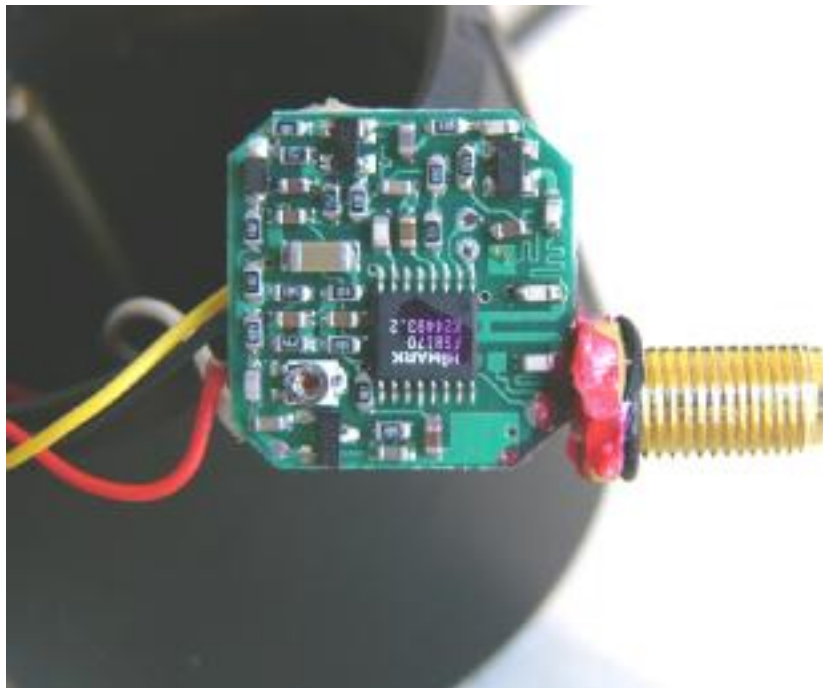
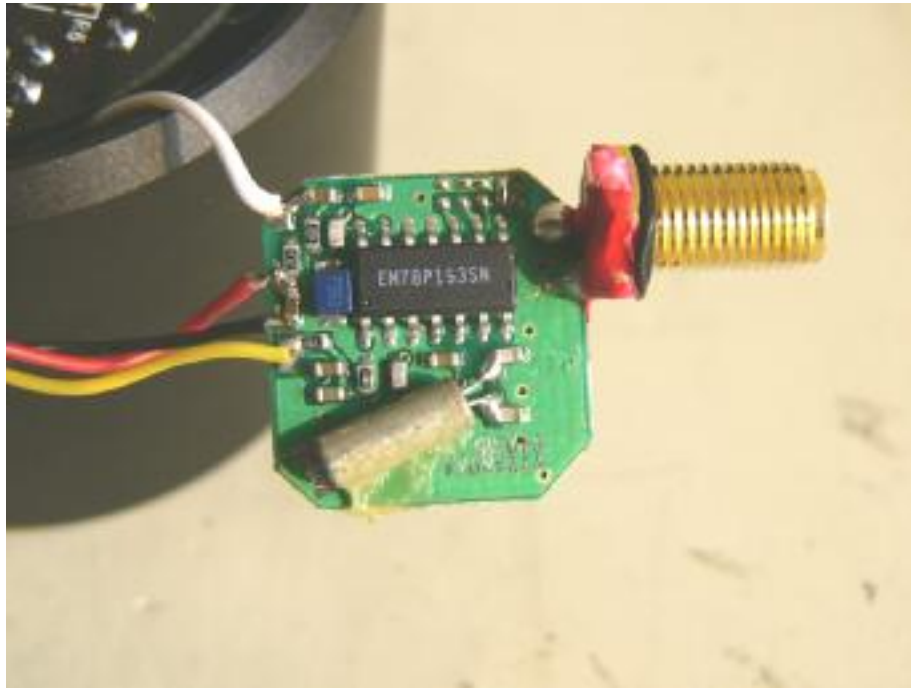

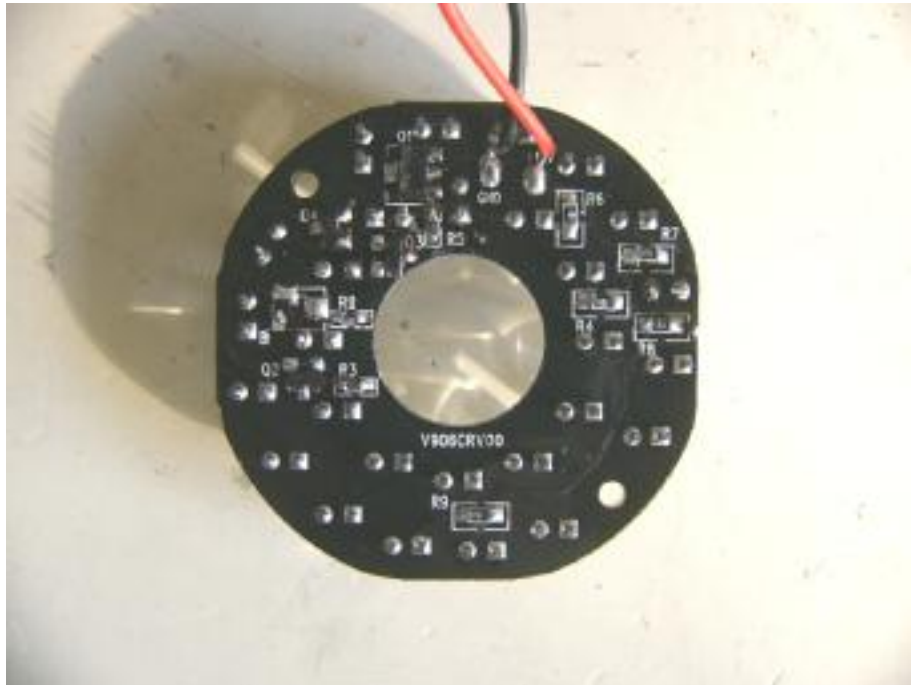
Main & RF board component side
