2 Test Configuration of Equipment Under Test

2.1 RF Output Power

Preliminary tests were performed in different data rate and recorded the RF output power in the following table:

Remark:

1. All the test data for each data rate were verified, but only the worst case was reported.
2. The data rate was set in 3Mbps for all the test items due to the highest RF output power.
3. The EUT is programmed to transmit signals continuously for all testing.

2.2 Test Mode

The EUT has been associated with peripherals pursuant to ANSI C63.4-2003 and ANSI C63.10-2009 and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction (150 KHz to 30 MHz), radiation (9 KHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower).


Pre-scanned tests, X, Y, Z in three orthogonal panels, were conducted to determine the final configuration from all possible combinations.



For Bluetooth function, the RF utility, "ADB" was installed in EUT which was programmed in order to make the EUT into the engineering modes to contact with Bluetooth base station for continuous transmitting and receiving signals.



2. The RF output of EUT was connected to the spectrum analyzer by a low loss cable.
3. Set to the maximum power setting and enable the EUT transmit continuously.
4. Enable the EUT hopping function.
5. Use the following spectrum analyzer settings: Span = the frequency band of operation; RBW \geq 1% of the span; VBW \geq RBW; Sweep = auto; Detector function = peak; Trace = max hold.
6. The number of hopping frequency used is defined as the number of total channel.





3.2 Hopping Channel Separation Measurement

3.2.1 Limit of Hopping Channel Separation

Frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 KHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater.






Channel Separation Plot on Channel 00 - 01




Channel Separation Plot on Channel 39 - 40




Channel Separation Plot on Channel 00 - 01




Channel Separation Plot on Channel 39 - 40




Channel Separation Plot on Channel 00 - 01




Channel Separation Plot on Channel 39 - 40


Channel Separation Plot on Channel 77 - 78




3DH5 Dwell Time (One Pulse) Plot on Channel 39





20 dB Bandwidth Plot on Channel 00





20 dB Bandwidth Plot on Channel 00






20 dB Bandwidth Plot on Channel 00




20 dB Bandwidth Plot on Channel 39

3.5 Peak Output Power Measurement

3.5.1 Limit of Peak Output Power

Section 15.247 (b) The maximum peak conducted output power of the intentional radiator shall not exceed the following: (1) For frequency hopping systems operating in the 2400-2483.5 MHz band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5725-5850 MHz band: 1 watt. For all other frequency hopping systems in the 2400-2483.5 MHz band 0.125 watts. The power limit for 1Mbps is 1watt, and for 2Mbps, and 3Mbps are 0.125 watts.






Peak Output Power Plot on Channel 00




Peak Output Power Plot on Channel 39




Peak Output Power Plot on Channel 00




Peak Output Power Plot on Channel 39




Peak Output Power Plot on Channel 00




Peak Output Power Plot on Channel 39

3.6 Conducted Band Edges Measurement

3.6.1 Limit of Band Edges

In any 100 KHz bandwidth outside the intentional radiation frequency band, the radio frequency power shall be at least 20 dB below the highest level of the radiated power. In addition, radiated emissions which fall in the restricted bands must also comply with the radiated emission limits.



3.6.3 Test Procedures

1. The testing follows the guidelines in Band-edge Compliance of RF Conducted Emissions of FCC Public Notice DA 00-705 Measurement Guidelines.
2. Set to the maximum power setting and enable the EUT transmit continuously.
3. Set RBW = 300KHz ($\geq 1\%$ span=30MHz), VBW = 300KHz (\geq RBW). Band edge emissions must be at least 20 dB down from the highest emission level within the authorized band as measured with a 300KHz RBW. The attenuation shall be 30 dB instead of 20 dB when RMS conducted output power procedure is used.
4. Enable hopping function of the EUT and then repeat step 2. and 3.
5. Record the results in the test report.





High Band Edge Plot on Channel 78





High Band Edge Plot on Channel 78







Hopping Mode High Band Edge Plot





In any 100 KHz bandwidth outside the intentional radiation frequency band, the radio frequency power shall be at least 20 dB below the highest level of the radiated power. In addition, radiated emissions which fall in the restricted bands must also comply with the radiated emission limits.



3.7.3 Test Procedure

1. The testing follows the guidelines in Spurious RF Conducted Emissions of FCC Public Notice DA 00-705 Measurement Guidelines
2. The transmitter output was connected to the spectrum analyzer via a low lose cable.
3. Set to the maximum power setting and enable the EUT transmit continuously.
4. Set RBW = 100 KHz, VBW = 300KHz, scan up through 10th harmonic. All harmonics / spurs must be at least 20 dB down from the highest emission level within the authorized band as measured with a 100 KHz RBW.
5. Record the results in the test report.





Conducted Spurious Emission Plot between 2 GHz ~ 25 GHz







3.8 Radiated Band Edges and Spurious Emission Measurement

3.8.1 Limit of Radiated Band Edges and Spurious Emission

In any 100 KHz bandwidth outside the intentional radiator frequency band, all harmonics/spurious must be at least 20 dB below the highest emission level within the authorized band. In addition, radiated emissions which fall in the restricted bands must also comply with the FCC section 15.209 limits as below.

3.8.3 Test Procedures


1. The testing follows the guidelines in Spurious Radiated Emissions of FCC Public Notice DA 00-705 Measurement Guidelines and fulfills ANSI C63.4-2003 and the guidelines in ANSI C63.10-2009 test site requirement.
2. The EUT was placed on a turntable with 0.8 meter above ground.
3. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
4. For each suspected emission, the EUT was arranged to its worst case and then tune the Antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level to comply with the guidelines.
5. Set to the maximum power setting and enable the EUT transmit continuously.
6. Use the following spectrum analyzer settings:
 - (1) Span shall wide enough to fully capture the emission being measured;
 - (2) Set RBW=100 KHz for $f < 1 \text{ GHz}$, RBW=1MHz for $f > 1 \text{ GHz}$; VBW \geq RBW; Sweep = auto; Detector function = peak; Trace = max hold for peak
 - (3) For average measurement: use duty cycle correction factor method per 15.35(c).
Duty cycle = On time/100 milliseconds
On time = $N_1 * L_1 + N_2 * L_2 + \dots + N_{n-1} * L_{n-1} + N_n * L_n$
Where N_1 is number of type 1 pulses, L_1 is length of type 1 pulses, etc.
Average Level = Peak Level + $20 * \log(\text{Duty cycle})$
7. Corrected Reading: Antenna Factor + Cable Loss + Read Level - Preamp Factor = Level




For radiated emissions below 30MHz

For radiated emissions above 1GHz







2. The EUT was placed 0.4 meter from the conducting wall of the shielding room was kept at least 80 centimeters from any other grounded conducting surface.
3. Connect EUT to the power mains through a line impedance stabilization network (LISN).
4. All the support units are connecting to the other LISN.
5. The LISN provides 50 ohm coupling impedance for the measuring instrument.
6. The FCC states that a 50 ohm, 50 microhenry LISN should be used.
7. Both sides of AC line were checked for maximum conducted interference.
8. The frequency range from 150 KHz to 30 MHz was searched.
9. Set the test-receiver system to Peak Detect Function and specified bandwidth with Maximum Hold Mode.





3.10 Antenna Requirements

3.10.1 Standard Applicable

If directional gain of transmitting antennas is greater than 6dBi, the power shall be reduced by the same level in dB comparing to gain minus 6dBi. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the FCC rule.
