



Appendix D – CDMA2000 1xRTT Test Modes

Test Summary:

The EUT supports IS95 2G networks, CDMA2000 1xRTT for Cellular, AWS and PCS band. The maximum output power is chosen for SAR testing for worst case scenario.

Based on all the uplink channels using the same modulation type, BPSK, and those maximum output power are very closer, above test modes could reflect compliance under all operational modes.
