ANNEX A: MEASUREMENT RESULTS

A.1 OUTPUT POWER

A.1.1 Summary

During the process of testing, the EUT was controlled via Rhode & Schwarz Digital Radio Communication tester (CMU-200) to ensure max power transmission and proper modulation.

This result contains peak output power and EIRP measurements for the EUT.

In all cases, output power is within the specified limits.

A.1.2 Conducted

A.1.2.1 Method of Measurements

The EUT was set up for the max output power with pseudo random data modulation.

The power was measured with Rhode & Schwarz Spectrum Analyzer FSU (peak)

These measurements were done at 3 frequencies, 1852.4 MHz, 1880.0MHz and 1907.6MHz for WCDMA Band II;826.4MHz, 836.6MHz and 846.6MHz for WCDMA Band \overline{V} . (bottom, middle and top of operational frequency range).

A.1.3 Radiated

A.1.3.1 Description

This is the test for the maximum radiated power from the EUT.

Rule Part 24.232(b) specifies, "Mobile/portable stations are limited to 2 watts e.i.r.p. Peak power" and 24.232(c) specifies that "Peak transmit power must be measured over any interval of continuous transmission using instrumentation calibrated in terms of an rms-equivalent voltage." Rule Part 22.913(a) specifies "Maximum ERP. The effective radiated power (ERP) of base transmitters and cellular repeaters must not exceed 500 Watts. The ERP of mobile transmitters and auxiliary test transmitters must not exceed 7 Watts."

A.1.3.2 Method of Measurement

The measurements procedures in TIA-603C-2004 are used.

- 1. In an anechoic antenna test chamber, a half-wave dipole antenna for the frequency band of interest is placed at the reference centre of the chamber. An RF Signal source for the frequency band of interest is connected to the dipole with a cable that has been constructed to not interfere with the radiation pattern of the antenna. A known (measured) power (P_{in}) is applied to the input of the dipole, and the power received (P_r) at the chamber's probe antenna is recorded.
- 2. The substitution method is used. Substitution values at each frequency are measured before and saved to the test software. A "reference path loss" is established as A_{Rpl}=Pin Pr. The A_{Rpl} is the attenuation of "reference path loss", and including the gain of receive antenna, the cable loss and the air loss.

The measurement results are obtained as described below:

 $Power(EIRP)=P_{Mea}+A_{Rpl}$

- 3. The EUT is substituted for the dipole at the reference centre of the chamber and a scan is performed to obtain the radiation pattern.
- 4. From the radiation pattern, the co-ordinates where the maximum antenna gain occurs are identified.
- 5. The EUT is then put into continuously transmitting mode at its maximum power level.
- 6. Power mode measurements are performed with the receiving antenna placed at the coordinates determined in Step 3 to determine the output power as defined in Rule 24.232 (b) and (c). The "reference path loss" from Step1 is added to this result.
- 7. This value is EIRP since the measurement is calibrated using a half-wave dipole antenna of known gain (2.15 dBi) and known input power (Pin).
- 8. ERP can be calculated from EIRP by subtracting the gain of the dipole, ERP = EIRP -2.15dBi.
- 9. The test system should be checked before test by a standard comb signal source. The signal source put on the position, instead of the EUT. The test result should be compared with the test result before. If the test result is similar with the initial one, then the test system can work stably.

A.2 EMISSION LIMT

A.2.1 Measurement Method


The measurements procedures in TIA-603C-2004 are used.

The spectrum was scanned from 30 MHz to the 10th harmonic of the highest frequency generated within the equipment, which is the transmitted carrier that can be as high as 1910 MHz. The resolution bandwidth is set 1MHz as outlined in Part 24.238. The spectrum was scanned with the mobile station transmitting at carrier frequencies that pertain to low, mid and high channels of the WCDMA Band $\rm II$, WCDMA Band $\rm V$.

The procedure of radiated spurious emissions is as follows:

a) Pre-calibration

With pre-calibration method, the Radiated Spurious Emissions(RSE) is calculated as, RSE=Rx (dBuV) +CL (dB) +SA (dB) +Gain (dBi) -107 (dBuV to dBm) The SA is calibrated using following setup.




b) System check

The test system should be checked before test by a standard comb signal source. The signal source put on the position, instead of the EUT. The test result should be compared with the test result before. If the test result is similar with the initial one, then the test system can work stably. c) EUT test

EUT was placed on a 1.5 meter high non-conductive stand at a 3 meter test distance from the receive antenna. A receiving antenna was placed on the antenna mast 3 meters from the test item for emission measurements. The height of receiving antenna is 1.5m. The test setup refers to figure below. Detected emissions were maximized at each frequency by rotating the test item and adjusting the receiving antenna polarization. The radiated emission measurements of all non-harmonic and harmonics of the transmit frequency through the 10th harmonic were measured with peak detector and 1MHz bandwidth.





A.2.2 Measurement Limit

Sec. 24.238 Emission Limits.

(a) On any frequency outside a licensee's frequency block (e.g. A, D, B, etc.) within the USPCS spectrum, the power of any emission shall be attenuated below the transmitter power (P, in Watts) by at least 43+10Log(P) dB. The specification that emissions shall be attenuated below the transmitter power (P) by at least 43 + 10 log (P) dB, translates in the relevant power range (1 to 0.001 W) to -13 dBm. At 1 W the specified minimum attenuation becomes 43 dB and relative to a 30 dBm (1 W) carrier becomes a limit of -13 dBm. At 0.001 W (0 dBm) the minimum attenuation is 13 dB, which again yields a limit of -13 dBm. In this way a translation of the specification from relative to absolute terms is carried out.

A.2.3 Measurement Results

Radiated emissions measurements were made only at the upper, middle, and lower carrier frequencies of the WCDMA Band $\rm II~(1852.4~MHz, 1880.0MHz$ and 1907.6MHz) , WCDMA Band $\rm V~(826.4MHz, 836.6MHz)$ and 846.6MHz) . It was decided that measurements at these three carrier frequencies would be sufficient to demonstrate compliance with emissions limits because it was seen that all the significant spurs occur well outside the band and no radiation was seen from a carrier in one block of the WCDMA Band $\rm II$, WCDMA Band $\rm V$ into any of the other blocks. The equipment must still, however, meet emissions requirements with the carrier at all frequencies over which it is capable of operating and it is the manufacturer's responsibility to verify this.

The substitution method is used. Substitution values at each frequency are measured before and saved to the test software. A "reference path loss" is established and the A_{Rpl} is the attenuation of "reference path loss", and including the gain of receive antenna, the gain of the preamplifier, the cable loss and the air loss.

The measurement results are obtained as described below:



Radiated spurious emission limit :-13dBm.









A.2.3.3 RADIATED SPURIOUS EMISSIONS-Channel 9538: 30MHz - 2GHz











A.2.3.7 Radiated spurious emission (18GHz-20GHz)




A.2.3.8 RADIATED SPURIOUS EMISSIONS-EUT in Idle Mode: 30MHz – 2GHz











Radiated spurious emission limit :-13dBm.









A.2.3.15 RADIATED SPURIOUS EMISSIONS-Channel 4233: 30MHz - 1GHz

NOTE: peak above the limit line is the Carrier frequency @ ch-4233




















(WCDMA Band II: 30MHz-1GHz)




(WCDMA Band II: 1GHz-4GHz)






(WCDMA Band II: 4GHz-18GHz)




(WCDMA Band II: 18GHz-26.5GHz)




(WCDMA Band V: 30MHz-1GHz)




(WCDMA Band V: 1GHz-4GHz)

A.4 FREQUENCY STABILITY

A.4.1 Method of Measurement

In order to measure the carrier frequency under the condition of AFC lock, it is necessary to make measurements with the EUT in a "call mode". This is accomplished with the use of R&S CMU200 DIGITAL RADIO COMMUNICATION TESTER.

- 1. Measure the carrier frequency at room temperature.
- 2. Subject the EUT to overnight soak at -30°C.
- 3. With the EUT, powered via nominal voltage, connected to the CMU200 and in a simulated call on channel 9400 for WCDMA Band $\rm II$, channel 4183 for WCDMA Band $\rm V$ measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming.
- 4. Repeat the above measurements at 10°C increments from -30°C to +50°C. Allow at least 1 1/2 hours at each temperature, unpowered, before making measurements.
- 5. Remeasure carrier frequency at room temperature with nominal voltage. Vary supply voltage from minimum voltage to maximum voltage, in 0.1Volt increments remeasuring carrier frequency at each voltage. Pause at nominal voltage for 1 1/2 hours unpowered, to allow any self-heating to stabilize, before continuing.
- 6. Subject the EUT to overnight soak at +50°C.
- 7. With the EUT, powered via nominal voltage, connected to the CMU200 and in a simulated call on the centre channel, measure the carrier frequency. These measurements should be made within 2 minutes of Powering up the EUT, to prevent significant self-warming.
- 8. Repeat the above measurements at 10 C increments from +50°C to -30°C. Allow at least 1 1/2 hours at each temperature, unpowered, before making measurements.
- 9. At all temperature levels hold the temperature to +/- 0.5°C during the measurement procedure.

A.4.2 Measurement Limit

A.4.2.1 For Hand carried battery powered equipment

According to the JTC standard the frequency stability of the carrier shall be accurate to within 0.1 ppm of the received frequency from the base station. This accuracy is sufficient to meet Sec. 24.235, Frequency Stability. The frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block. As this transceiver is considered "Hand carried, battery powered equipment" Section 2.1055(d)(2) applies. This requires that the lower voltage for frequency stability testing be specified by the manufacturer. This transceiver is specified to operate with an input voltage of between 4.8VDC and 5.2VDC, with a nominal voltage of 5.0VDC. Operation above or below these voltage limits is prohibited by transceiver software in order to prevent improper operation as well as to protect components from overstress. These voltages represent a tolerance of -10 % and +12.5 %. For the purposes of measuring frequency stability these voltage limits are to be used.

A.4.2.2 For equipment powered by primary supply voltage

According to the JTC standard the frequency stability of the carrier shall be accurate to within 0.1 ppm of the received frequency from the base station. This accuracy is sufficient to meet Sec. 24.235, Frequency Stability. The frequency stability shall be sufficient to ensure that the



fundamental emission stays within the authorized frequency block. For this EUT section 2.1055(d)(1) applies. This requires varying primary supply voltage from 85 to 115 percent of the nominal value for other than hand carried battery equipment.




WCDMA Band II Channel 9262-Occupied Bandwidth (99%)




Channel 9400-Occupied Bandwidth (99%)








Channel 4183-Occupied Bandwidth (99%)








Channel 9400-Occupied Bandwidth (-26dBc BW)








Channel 4183-Occupied Bandwidth (-26dBc BW)






HIGH BAND EDGE BLOCK-C (WCDMA Band II) -Channel 9538




WCDMA Band V LOW BAND EDGE BLOCK-A (WCDMA Band $\,V$)-Channel 4132

A.8 CONDUCTED SPURIOUS EMISSION

A.8.1 Measurement Method

The following steps outline the procedure used to measure the conducted emissions from the EUT.

- Determine frequency range for measurements: From CFR 2.1057 the spectrum should be investigated from the lowest radio frequency generated in the equipment up to at least the 10th harmonic of the carrier frequency.
- 2. Determine EUT transmit frequencies: below outlines the band edge frequencies pertinent to conducted emissions testing.












