1 - GENERAL INFORMATION

1.1 Product Description for Equipment Under Test (EUT)

The **SHANGHAI EAST PEARL LIGHTING CO., LTD.**, model: **10113,10115,10120,10125,10213,10215,10220,10225,40113,40115,40120,40125,50113,50115,50120,50123,50125,50213,50215,50220,50223,50225**, or the "EUT" as referred to in this report is an Energy saving lamp.

Its details are presented in Appendix B of this report as reference.

1.2 Objective

This report is prepared on behalf of **SHANGHAI EAST PEARL LIGHTING CO., LTD.** in accordance with Part 2, Subpart J, and Part 18, Subparts A and B of the Federal Communication Commissions rules.

The objective of the manufacturer is to demonstrate compliance with FCC Part 18 ISM Consumer equipment limits for RF lighting devices.

1.4 Test Methodology

All measurements contained in this report are conducted with FCC Measurement Procedure MP-5, technical requirements for Methods of Measurement of Radio-Noise Emissions from ISM Equipment.

All radiated and conducted emissions measurements are performed at Bay Area Compliance Laboratory Corp. The radiated tests are performed at an antenna-to-EUT distance of 3 meters.

1.5 Test Facility

The Open Area Test site used by Sichuan Bay Area Compliance Laboratory Corporation to collect radiated and conducted emission measurement data is at Xinmiao District, Wuhou Main Street, Chengdu City, Sichuan Province, P. R. C.

Test site at Sichuan Bay Area Compliance Laboratory Corporation has been fully described in reports submitted to the Federal Communication Commission (FCC). The details of these reports have been found to be in compliance with the requirements of Section 2.948 of the FCC Rules on February 11 and December 10, 1997. The facility also complies with the radiated and AC line conducted test site criteria set forth in ANSI C63.4-1992 and FCC MP-5.

The Federal Communications Commission and Voluntary Control Council for Interference have the reports on file and listed under FCC file 31040/SIT 1300F2 and VCCI Registration No.: C-1298 and R-1234. The test site has been approved by the FCC and VCCI for public use and listed in the FCC Public Access Link (PAL) database.

Additionally, Bay Area Compliance Laboratory Corporation is a National Institute of Standards and Technology (NIST) accredited laboratory, under the National Voluntary Laboratory Accredited Program

(NVLAP). The scope of the accreditation covers the FCC Method - 47 CFR Part 15 - Digital Devices, IEC/CISPR 22: 1998, and AS/NZS 3548: Electromagnetic Interference - Limits and Methods of Measurement of Information Technology Equipment test methods under NVLAP Lab Code 200167-0.

2.1 Justification

The EUT is configured for testing in a typical fashion (as normally used by a typical user).

The Energy saving lamp is used in normal lighting at 120V/60Hz AC.

2.2 EUT Exercise Program

The sequence used is as follows:

The EUT will light after being screwed into the lamp holder and being connected with power supply.

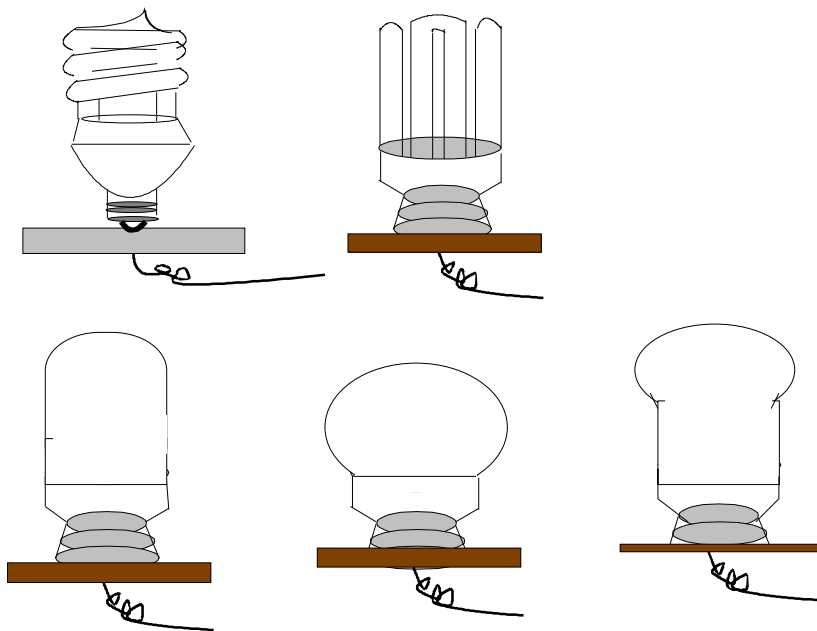
2.3 Schematics/Block Diagram

The EUT's block diagram is presented in Appendix A of this report as reference.

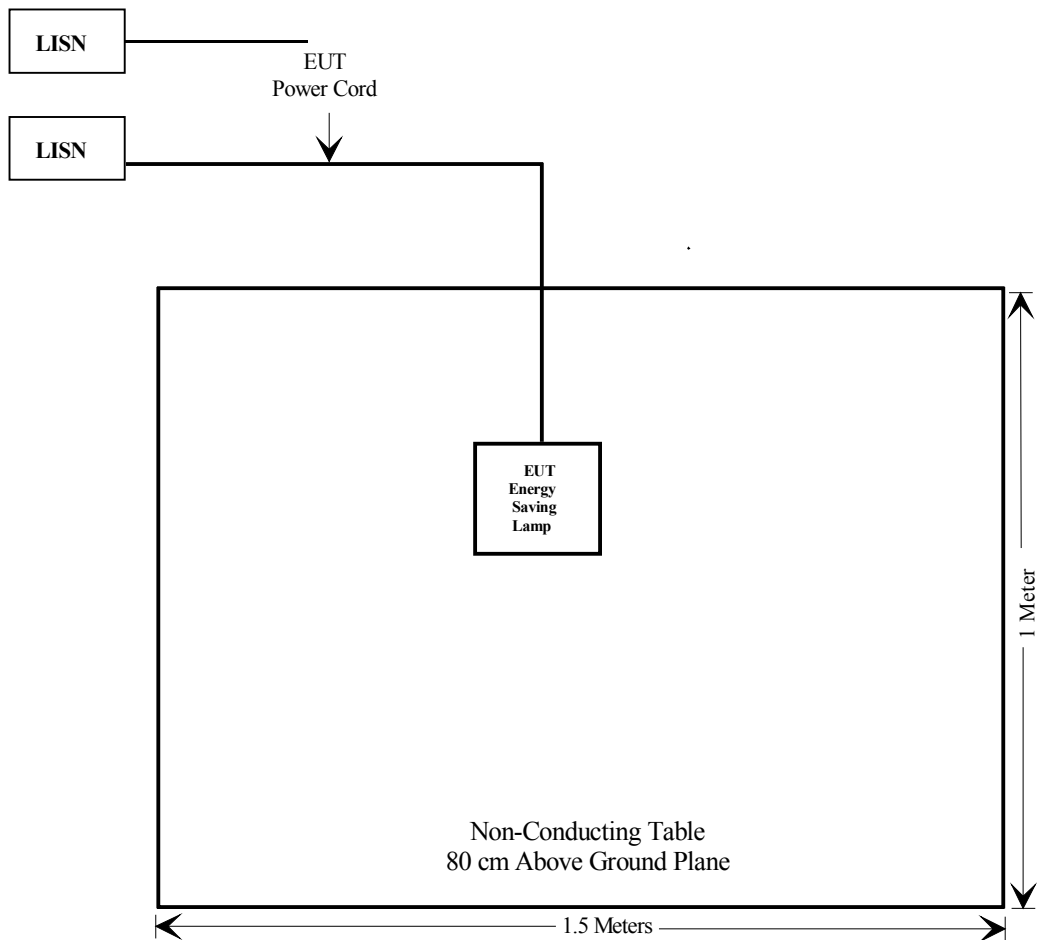
2.4 Equipment Modifications

No modifications are made by BACL Corp. to ensure the EUT complies with the applicable limits and standards.

3 - CONDUCTED EMISSIONS TEST

3.1 Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMI. The factors contributing to uncertainties are spectrum analyzer, cable loss, and LISN.

Based on NIS 81, The Treatment of Uncertainty in EMI Measurements, the best estimate of the uncertainty of any conducted emissions measurement at BACL is ± 2.4 dB.

3.2 EUT Setup

The measurement is performed at the Open Area Test Site, using the same setup per FCC MP-5 measurement procedure.

The EUT is tested independently.

The EUT is placed on the side of test table.

The power supply used by the EUT is connected to a 120VAC/ 60Hz power source.

3.3 Spectrum Analyzer

The spectrum analyzer is configured during the conduction test is as follows:

Start Frequency.....	450 kHz
Stop Frequency.....	30 MHz
Sweep Speed.....	Auto
IF Bandwidth.....	9 kHz
Video Bandwidth.....	100 kHz
Quasi-Peak Adapter Bandwidth	9 kHz
Quasi-Peak Adapter Mode.....	Normal

3.4 Test Procedure

During the conducted emission test, the power cord of the EUT is connected to the auxiliary outlet of the LISN.

Maximizing procedure is performed on the six (6) highest emissions to ensure EUT compliance using all installation combination. All data is recorded in the peak detection mode. Quasi-peak readings are only performed when an emission is found to be marginal (within -4 dB μ V of specified limitations). Quasi-peak readings are distinguished with a "Qp".

Final test data for this test configuration is recorded in the table listed under section 3.6 of this report.

3.5 Summary of Test Results

According to the data in section 3.6, the EUT, complied with the FCC 18 Conducted margin for a RF lighting device-Consumer Equipment limits and these test results is deemed satisfactory evidence.

4 - RADIATED EMISSIONS TEST

4.1 Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in field of EMI. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.

Based on NIS 81, The Treatment of Uncertainty in EMI Measurements, the best estimate of the uncertainty of a radiation emissions measurement at BACL is ± 4.0 dB.

4.2 EUT Setup

The radiated emission tests are performed in the open area 3 meters test site for the final test configuration, using the setup accordance with the ANSI C63.4 – 1992 or FCC MP-5. The specification used is according to FCC Part 18 Consumer Equipment limits for the final test configuration.

The EUT is placed on the center of the test table.

The power supply used by the EUT is connected to a 120VAC/ 60Hz power source.

4.3 Spectrum Analyzer Setup

According to FCC Rules, 47 CFR 18.309, the tested performed from 30MHz to 1000MHz.

During the radiated emission test, the spectrum analyzer is set with the following configurations:

4.4 Test Procedure

For the radiated emissions test, Maximizing procedure is performed on the twelve (12) highest emissions to ensure EUT is compliant with all installation combinations.

All data is recorded in the peak detection mode. Quasi-peak readings performed only when an emission is found to be marginal (within -4 dB μ V of specified limitations), and are distinguished with a "Qp" in the data table.

Therefore, the final test data for this configuration is recorded and represented in the table(s) listed under section 4.7 of this report.

4.5 Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain from the Amplitude reading. The basic equation is as follows:

$$\text{Corr. Ampl.} = \text{Indicated Reading} + \text{Antenna Factor} + \text{Cable Factor} - \text{Amplifier Gain}$$

The "**Margin**" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of -7dB μ V means the emission is 7dB μ V below the maximum limit for lighting devices- ISM Consumer Equipment. The equation for margin calculation is as follows:

$$\text{Margin} = \text{Corr. Ampl.} - \text{Consumer Equipment Limit}$$

4.6 Summary of Test Results

According to the data in section 4.7, the EUT, complied with the FCC Part 18 standards for the final test and these test results are deemed satisfactory evidence of compliance with ICES-003 of the Canadian Interference-Causing Equipment Regulations.
