

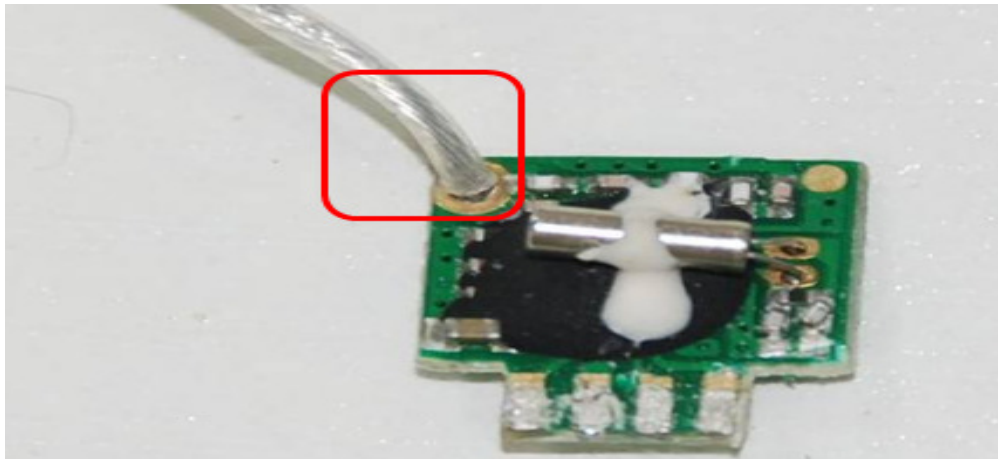

The antenna is an integrated antenna integrated on the main PCB and no consideration of replacement. The best case gain of the antenna is 2.45 dBi.

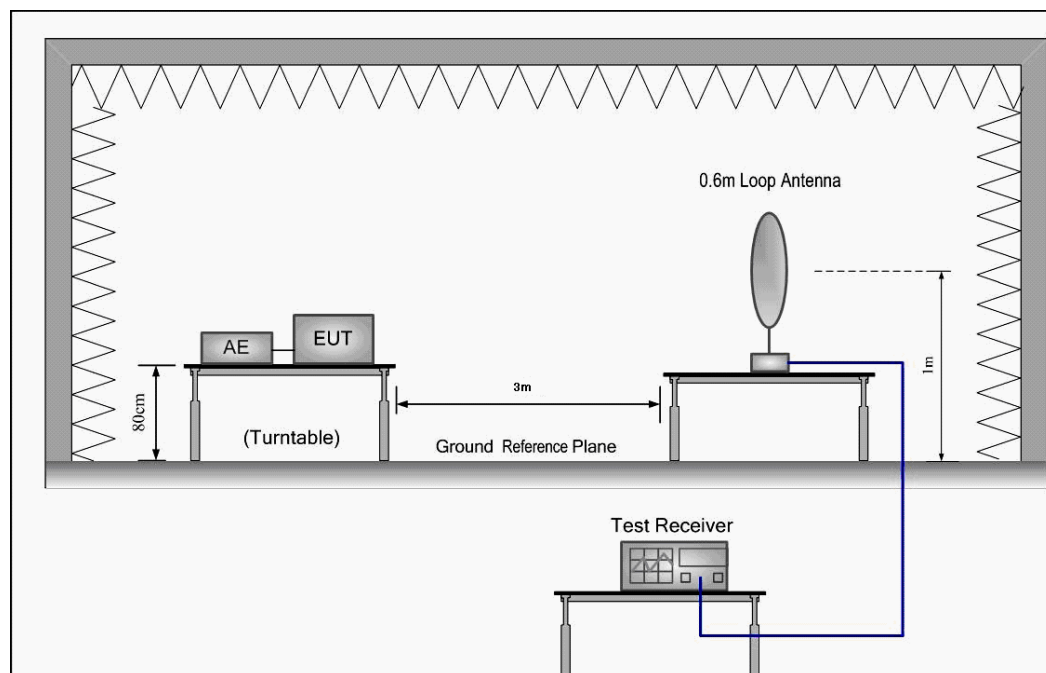
For testing performed with the loop antenna, testing was performed in accordance to ANSI C63.10. The centre of the loop was positioned 1 m above the ground and positioned with its plane vertical at the specified distance from the EUT, During testing the loop was rotated about its vertical axis for maximum response at each azimuth and also investigated with the loop positioned in the horizontal plane.

2) 30 MHz to 1 GHz emissions:

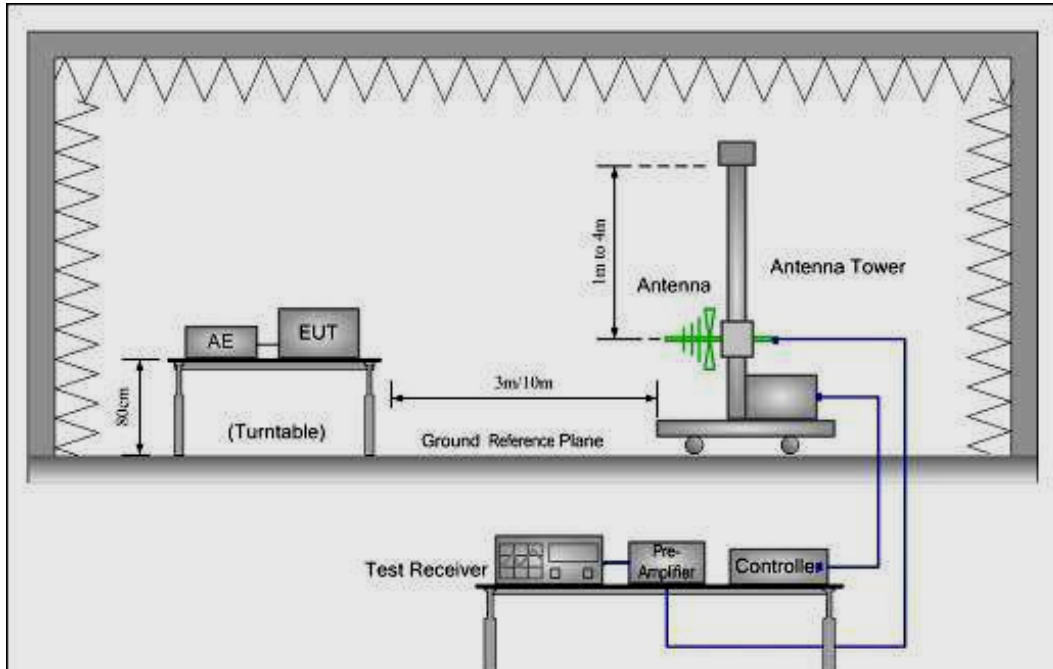
For testing performed with the bi-log type antenna, testing was performed in accordance to ANSI C63.10. The measurement is performed with the EUT rotated 360°, the antenna height scanned between 1m and 4m, and the antenna rotated to repeat the measurement for both the horizontal and vertical antenna polarizations.

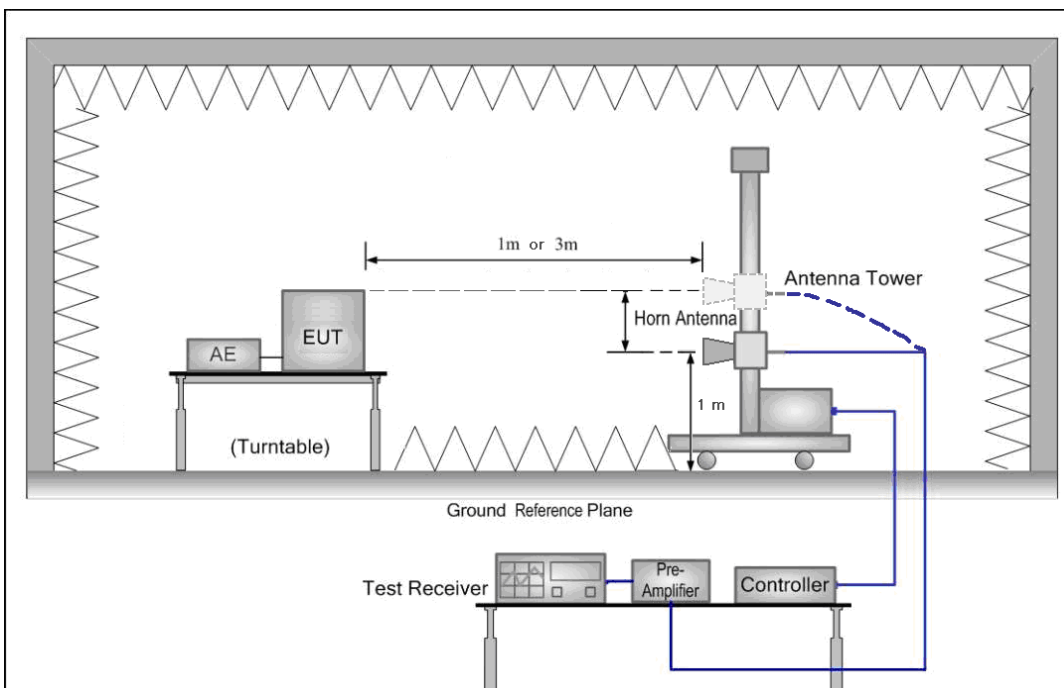

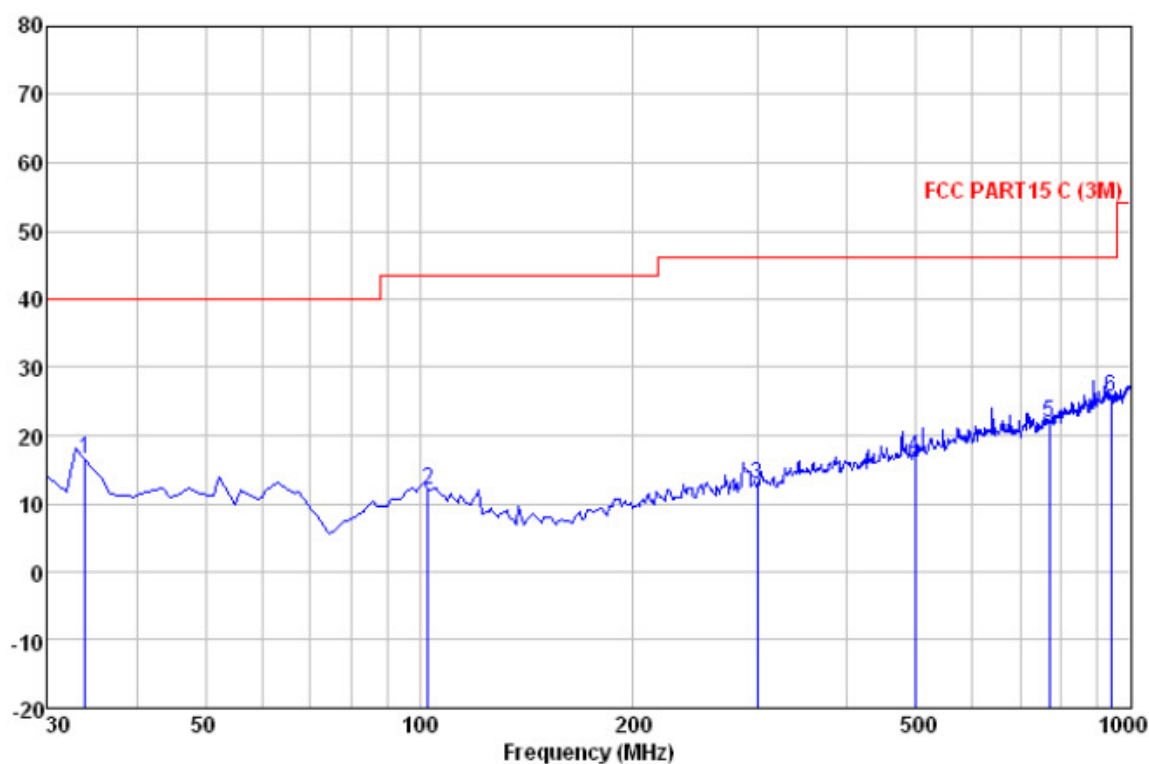

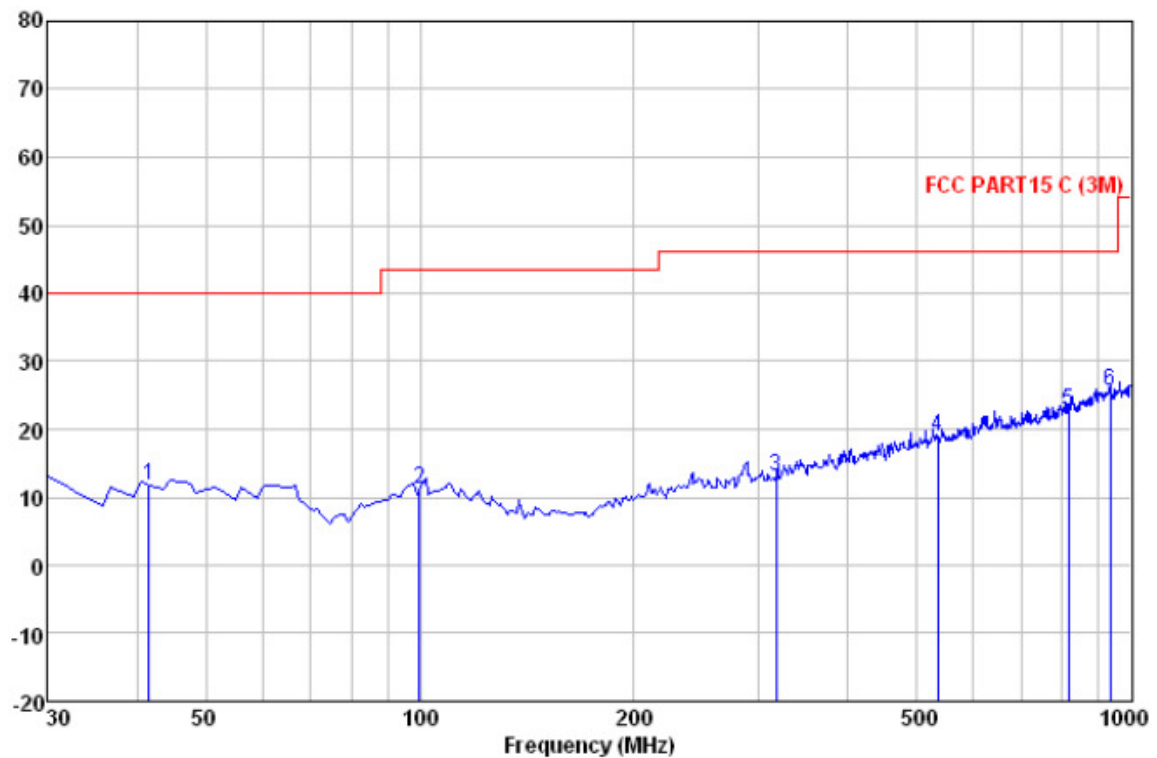

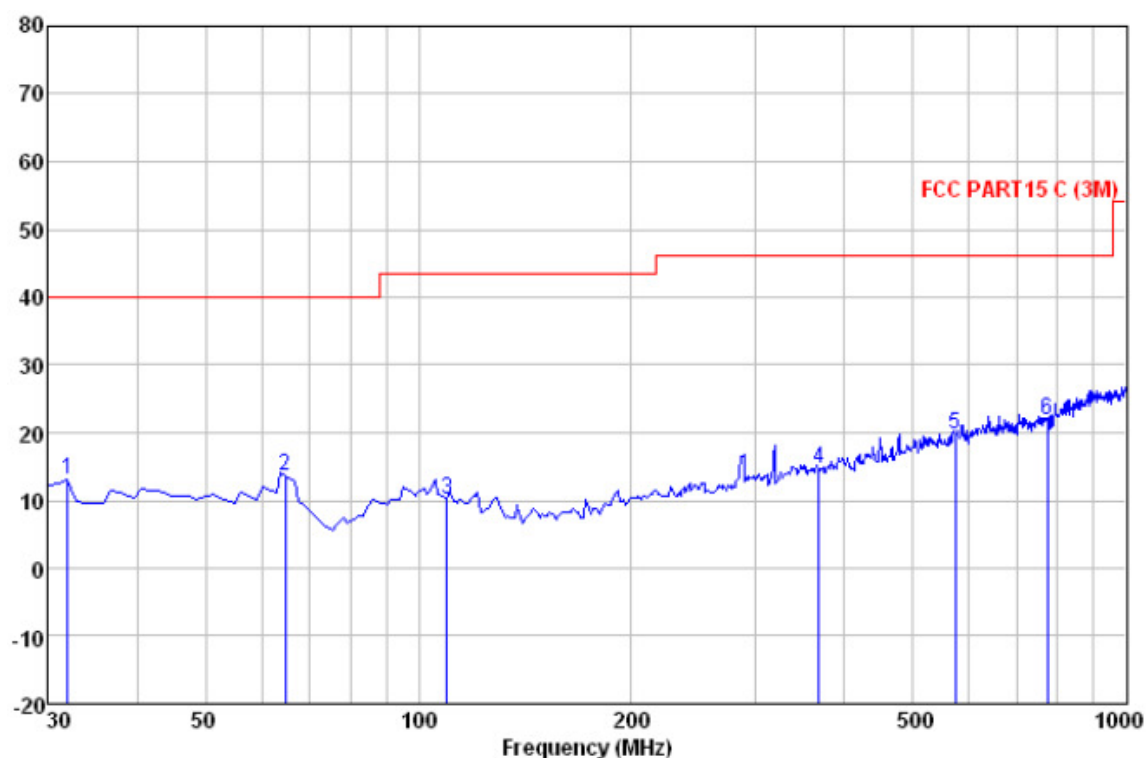

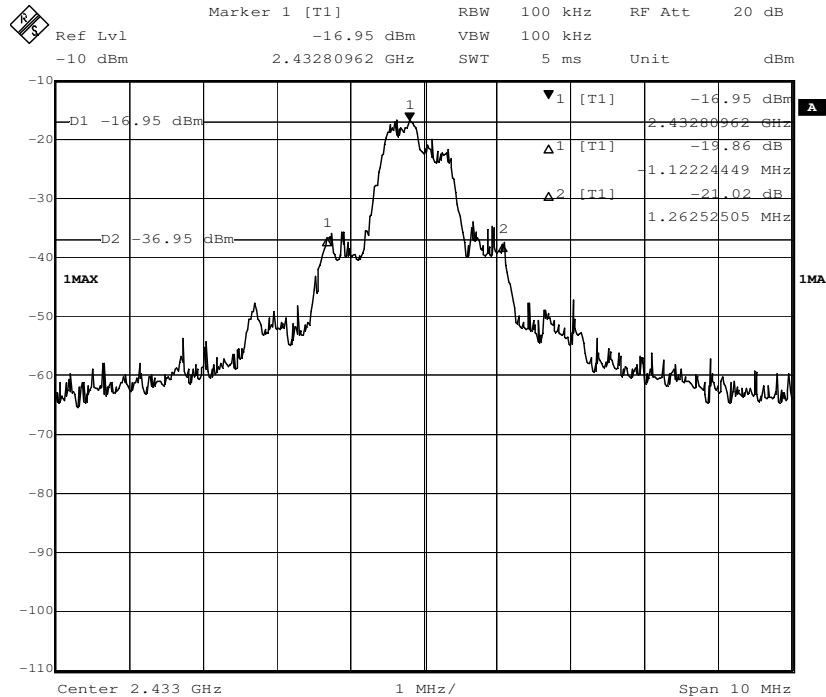

1. Test in the lowest frequency 2.402 GHz

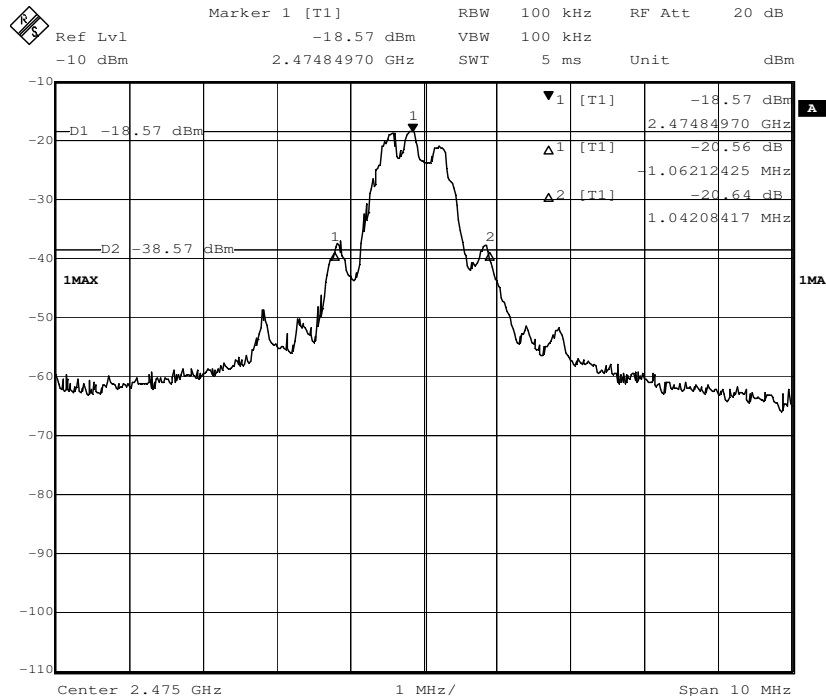




2. Test in the middle frequency 2.433 GHz
