Question #2: Need to revise POA, it refers to old agent name.

Question #3: Test setup photos do not matching the DUT, please clarify.

Question #4: User manual p9 stated that "For body worn operation, this phone has been tested and meets the FCC RF exposure guidelines when used with an accessory that contains no metal and that position the antenna of the GSM phone a minimum of 1.5cm from the body. The SAR values of this GSM phone are 1.52mW/g (body) and 0.347mW/g (head). Use of other accessories may not ensure compliance with the FCC RF exposure guidelines." The specified SAR value is not consistent with measured vale in the SAR report. Please correct.

Question #5: EMC test report p22, Please explain if this device has GPRS 10 to 15 classe and how it work.
