



## 2. EUT DESCRIPTION

The EUT is an 802.11b WLAN Mini PCI Card operating in the 2400 – 2483.5 MHz band with a peak output power of 19.36dBm (86.3 mW) has a peak antenna gain of 0.48dBi. The EUT is tested with two hosts computers as below:

The host computer #1 is a HP model CRVSA-02T1-75.

The host computer #2 is a HP model PP2180.

One set of RF conducted emissions measurement were made on the radio card, and radiated and line conduction emissions measurements were made with the radio installed in each host computer.

### **3. TEST METHODOLOGY**

The tests documented in this report were performed in accordance with ANSI C63.4/1992, FCC CFR 47 Part 2 and FCC CFR 47 Part 15.

### **4. FACILITIES AND ACCREDITATION**

#### **4.1. FACILITIES AND EQUIPMENT**

The open area test sites and conducted measurement facilities used to collect the radiated data are located at 561F Monterey Road, Morgan Hill, California, USA. The sites are constructed in conformance with the requirements of ANSI C63.7, ANSI C63.4 and CISPR Publication 22.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

## 5. CALIBRATION AND UNCERTAINTY

### 5.1. MEASURING INSTRUMENT CALIBRATION

The measurement instruments utilized to perform the tests documented in this report have been calibrated in accordance with the manufacturer's recommendations, and are traceable to national standards.

### 5.2. MEASUREMENT UNCERTAINTY

Where relevant, the following measurement uncertainty levels have been estimated for tests performed on the apparatus:

Radiated Emission, 30 to 200 MHz	+/- 3.3 dB
Radiated Emission, 200 to 1000 MHz	+4.5 / -2.9 dB
Radiated Emission, 1000 to 2000 MHz	+4.5 / -2.9 dB
Power Line Conducted Emission	+/- 2.9 dB

Uncertainty figures are valid to a confidence level of 95%.





## 7. APPLICABLE LIMITS AND TEST RESULTS

### 7.1. 6 dB BANDWIDTH

#### LIMIT

§15.247 (a) (2) For direct sequence systems, the minimum 6 dB bandwidth shall be at least 500 kHz.

#### TEST PROCEDURE

The transmitter output is connected to a spectrum analyzer. The RBW is set to 100 kHz and the VBW is set to 100 kHz. The sweep time is coupled.







## 7.2. OUTPUT POWER

### PEAK POWER LIMIT

§15.247 (b) The maximum peak output power of the intentional radiator shall not exceed the following:

§15.247 (b) (3) For systems using digital modulation in the 902-928 MHz, 2400-2483.5 MHz , and 5725-5850 MHz bands: 1 watt.

§15.247 (b) (4) Except as shown in paragraphs (b)(3) (i), (ii) and (iii) of this section, if transmitting antennas of directional gain greater than 6 dBi are used the peak output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1) or (b)(2) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

The maximum antenna gain is –0.65 dBi, therefore the limit is 30 dBm.

### AVERAGE POWER LIMIT

None; for reporting purposes only.

### TEST PROCEDURE

The transmitter output is connected to a power meter. The power meter is set to simultaneously read peak power and average power.






The cable assembly insertion loss of 11 dB (including 10 dB pad and 1 dB cable) was entered as an offset in the power meter to allow for direct reading of power.

### 7.3. MAXIMUM PERMISSIBLE EXPOSURE

#### LIMITS

§15.247 (b) (5) Systems operating under the provisions of this section shall be operated in a manner that ensures that the public is not exposed to radio frequency energy levels in excess of the Commission's guidelines. See §1.1307(b)(1) of this chapter.

#### CALCULATIONS

Given

$$E = \sqrt{(30 * P * G) / d}$$

and

$$S = E^2 / 3770$$

where

E = Field Strength in Volts / meter

P = Power in Watts

G = Numeric antenna gain

d = distance in meters

S = Power Density in milliwatts / square centimeter

Combining equations and rearranging the terms to express the distance as a function of the remaining variables yields:

$$d = \sqrt{((30 * P * G) / (3770 * S))}$$

Changing to units of mW and cm, using:

$$P (\text{mW}) = P (\text{W}) / 1000 \text{ and}$$

$$d (\text{cm}) = 100 * d (\text{m})$$

yields

$$d = 100 * \sqrt{((30 * (P / 1000) * G) / (3770 * S))}$$

$$d = 0.282 * \sqrt{(P * G / S)}$$

where

d = distance in cm

P = Power in mW

G = Numeric antenna gain

S = Power Density in mW / cm<sup>2</sup>

Substituting the logarithmic form of power and gain using:

$$P \text{ (mW)} = 10^{\frac{1}{10}} (P \text{ (dBm)}) \text{ and}$$

$$G \text{ (numeric)} = 10^{\frac{1}{10}} (G \text{ (dBi)}) \text{ and}$$

yields

$$d = 0.282 * 10^{\frac{1}{10}} ((P + G) / 20) / \sqrt{S} \quad \text{Equation (1)}$$

where

d = MPE distance in cm

P = Power in dBm

G = Antenna Gain in dBi

S = Power Density Limit in mW / cm<sup>2</sup>

Equation (1) and the measured peak power is used to calculate the MPE distance.

## 7.4. PEAK POWER SPECTRAL DENSITY

### LIMIT

§15.247 (d) For direct sequence systems, the peak power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8 dBm in any 3 kHz band during any time interval of continuous transmission.

### TEST PROCEDURE

The transmitter output is connected to a spectrum analyzer, the maximum level in a 3 kHz bandwidth is measured with the spectrum analyzer using RBW = 3 kHz and VBW  $\geq$  3KHz, sweep time = span / 3 kHz, and video averaging is turned off. The PPSD is the highest level found across the emission in any 3 kHz band.







## 7.5. CONDUCTED SPURIOUS EMISSIONS

### LIMITS

§15.247 (c) In any 100 kHz bandwidth outside the frequency band in which the spread spectrum intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).


**SPURIOUS EMISSIONS, LOW CHANNEL (802.11b MODE)**










**SPURIOUS EMISSIONS, MID CHANNEL (802.11b MODE)**









**SPURIOUS EMISSIONS, HIGH CHANNEL (802.11b MODE)**

§15.205 (b) Except as provided in paragraphs (d) and (e), the field strength of emissions appearing within these frequency bands shall not exceed the limits shown in Section 15.209. At frequencies equal to or less than 1000 MHz, compliance with the limits in Section 15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1000 MHz, compliance with the emission limits in Section 15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in Section 15.35 apply to these measurements.

§15.209 (a) Except as provided elsewhere in this Subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table:

\*\* Except as provided in paragraph (g), fundamental emissions from intentional radiators operating under this Section shall not be located in the frequency bands 54-72 MHz, 76-88 MHz, 174-216 MHz or 470-806 MHz. However, operation within these frequency bands is permitted under other sections of this Part, e.g., Sections 15.231 and 15.241.

§15.209 (b) In the emission table above, the tighter limit applies at the band edges.

### **TEST PROCEDURE**

The EUT is placed on a non-conducting table 80 cm above the ground plane. The antenna to EUT distance is 3 meters. The EUT is configured in accordance with ANSI C63.4. The EUT is set to transmit in a continuous mode.

For measurements below 1 GHz the resolution bandwidth is set to 100 kHz for peak detection measurements or 120 kHz for quasi-peak detection measurements. Peak detection is used unless otherwise noted as quasi-peak.

For measurements above 1 GHz the resolution bandwidth is set to 1 MHz, then the video bandwidth is set to 1 MHz for peak measurements and 10 Hz for average measurements.

The spectrum from 30 MHz to 26 GHz is investigated with the transmitter set to the lowest, middle, and highest channels.


The frequency range of interest is monitored at a fixed antenna height and EUT azimuth. The EUT is rotated through 360 degrees to maximize emissions received. The antenna is scanned from 1 to 4 meters above the ground plane to further maximize the emission. Measurements are made with the antenna polarized in both the vertical and the horizontal positions.






#### RESTRICTED BANDEDGE (b MODE, LOW CHANNEL, HORIZONTAL)







**RESTRICTED BANDEDGE (b MODE, LOW CHANNEL, VERTICAL)**







**RESTRICTED BANDEDGE (b MODE, HIGH CHANNEL, HORIZONTAL)**




