Here are the replies to your questions on the above application.

1. The Dell Host computer users manual does not contain any RF Exposure notices/information or notice to use the 5.15-5.25GHz band indoor. Please update the Host Users Manual to include this required information.

<CCS ANSWER:> Broadcom will request that Dell include the following statement in the Siberia User Guide.

Caution: Exposure to Radio Frequency Radiation.

To avoid the possibility of exceeding the FCC radio frequency exposure limits, human proximity to the antennae should not be less than 20 cm (8 inches). This device must not be co-located or operating in conjunction with any other antenna or transmitter, unless authorized by FCC.

2. The label exhibit submitted shows a new label for the module, but does not provide a label exhibit for the outside of the host indicating that 'this device contains FCC ID: QDS-BRCM1022. Please provide confirmation that the module labeling requirements will be followed or provide a sample of the host label.
