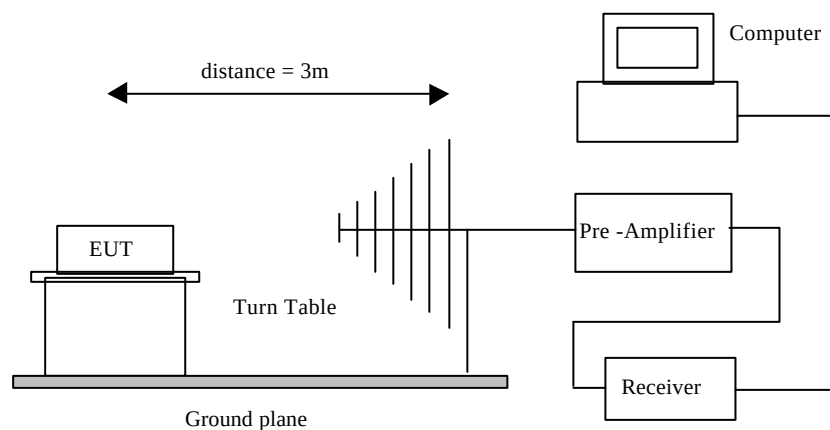

Test Method:

The sample was placed 0.8m above the ground plane on the OATS *. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigate all operating modes, rotated about all 3 axis (X, Y & Z) to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.

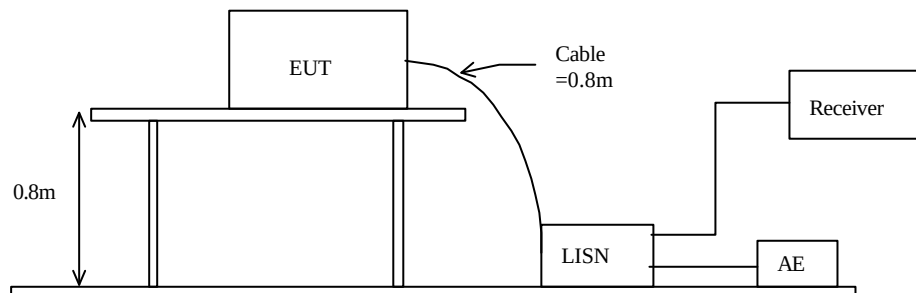

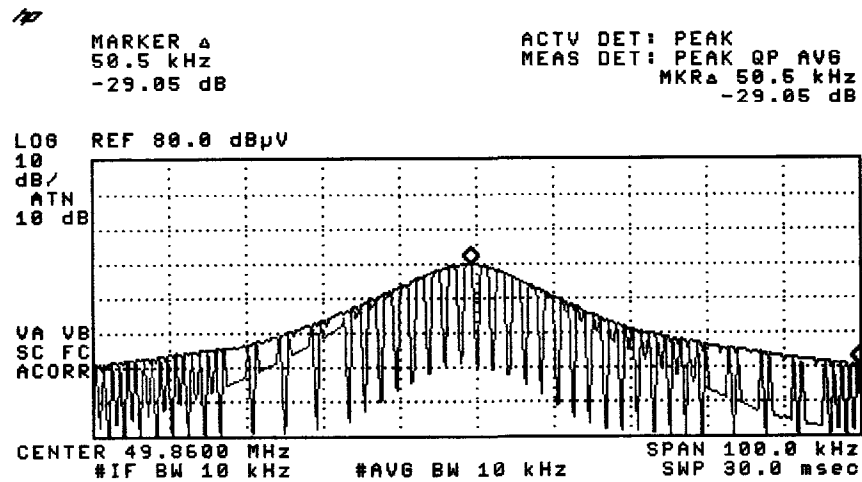

Appendix B**Duty Cycle Correction During 100msec**

Each function key sends a different series of characters, but each packet period (18.825msec) never exceeds a series of 4 long (900µsec) and 22 short (300µsec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worse case transmit duty cycle would be considered $4 \times 900\mu\text{sec} + 22 \times 300\mu\text{sec}$ per 18.825msec = 54.2% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.

Remarks:

$$\text{Duty Cycle Correction} = 20\text{Log}(0.542) = -5.3\text{dB}$$

Figure A [Pulse Train]

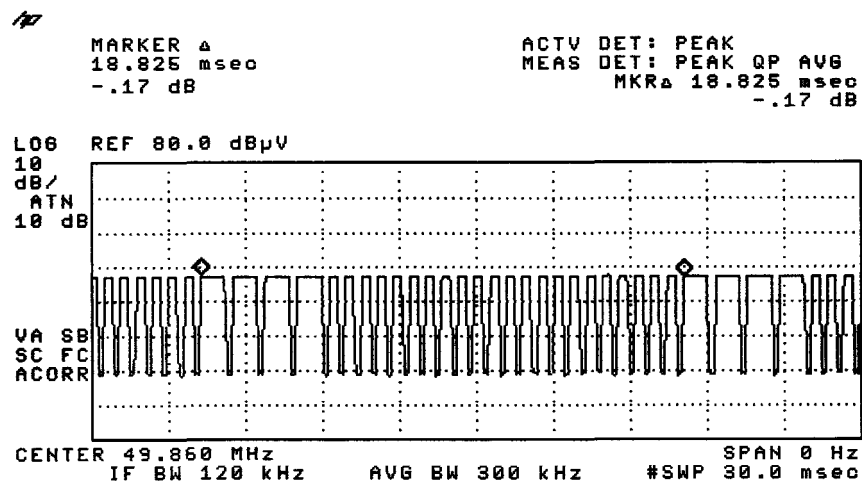


Figure B [Long Pulse]

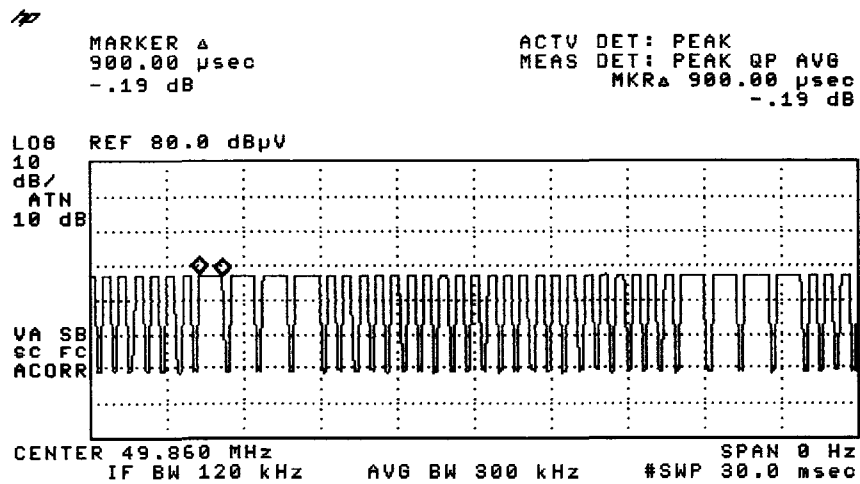
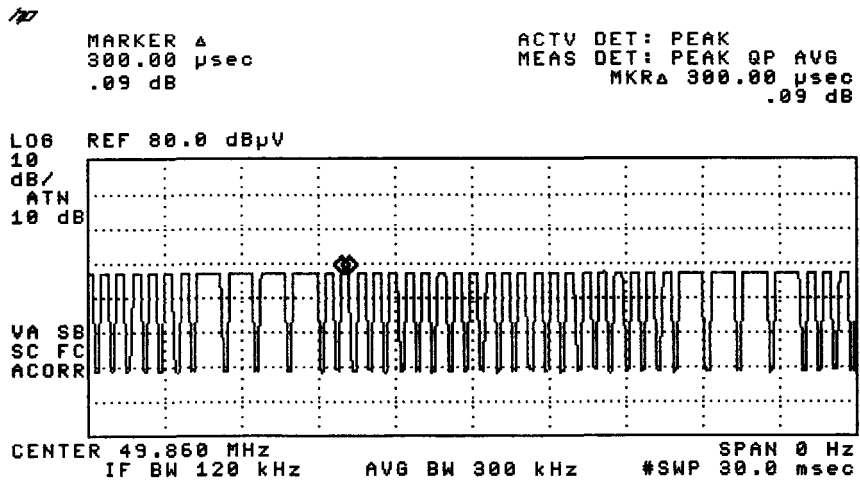


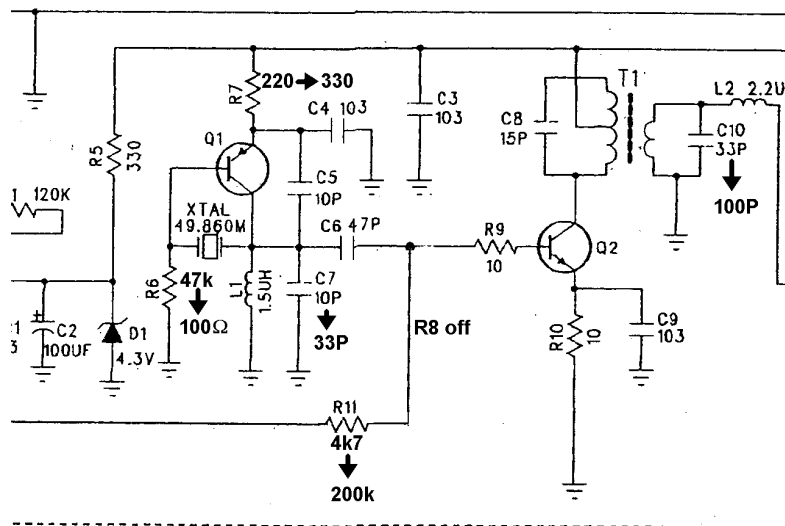
Figure C [Short Pulse]

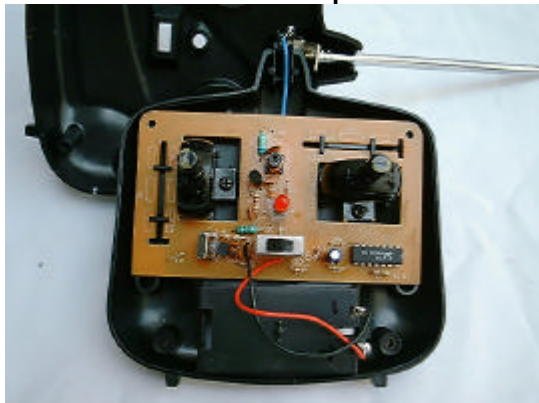
Front View of the product



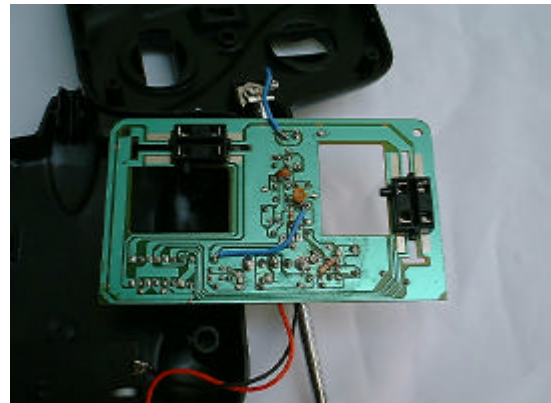
Rear View of the product
