

#### **6.2** Test Procedure

- 1. The EUT was tested according to ANSI C63.4:2003. The frequency spectrum from 150kHz to 30MHz was investigated.
- 2. The maximised peak emissions from the EUT was scanned and measured for both the Live and Neutral Lines. Quasi-peak & average measurements were performed if peak emissions were within 6dB of the average limit line.


The conducted emission tests were performed using the setup accordance with the ANSI C63.4:2003, The specification used in this report was the FCC Part15 Paragraph 15.207 limits.



#### **6.4 EUT Operating Condition**

#### 7.2 Measurement Uncertainty

All measurements involve certain levels of uncertainties, especially in the field of EMC. The factors contributing to uncertainties are spectrum analyzer, cable loss, antenna factor calibration, antenna directivity, antenna factor variation with height, antenna phase center variation, antenna factor frequency interpolation, measurement distance variation, site imperfections, mismatch (average), and system repeatability.


Based on ANSI C63.4:2003, The Treatment of Uncertainty in EMC Measurements, the best estimate of the uncertainty of a radiation emissions measurement at SMQ EMC Laboratory is +4.0 dB.

#### 7.3 Test Procedure

- 1. For the radiated emissions test, since the EUT does not have a power source, there was no connection to AC outlets.
- 2. Maximizing procedure was performed on the six (6) highest emissions to ensure EUT is compliant with all installation combinations.
- 3. All data was recorded in the peak detection mode. Quasi-peak readings was performed only when an emission was found to be marginal (within -4 dB $\mu$ V of specification limits), and are distinguished with a "Qp" in the data table.
- 4. The EUT was under normal mode during the final qualification test and the configuration was used to represent the worst case results.

#### 7.4 Radiated Test Setup

The radiated emission tests were performed in the 3m Semi- Anechoic Chamber test site, using the setup accordance with the ANSI C63.4:2003, The specification used in this report was the FCC Part15 Paragraph 15.209, Paragraph 15.235 limits.



#### 7.5 Spectrum Analyzer Setup

#### 7.6 Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain from the Amplitude reading. The basic equation is as follows:

Corr. Ampl. = Indicated Reading + Antenna Factor + Cable Factor - Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of  $-7dB\mu V$  means the emission is  $7dB\mu V$  below the maximum limit for Class B. The equation for margin calculation is as follows:

Margin = Corr. Ampl. – Class B Limit

#### 7.10 Radiated Emissions Test Result

Formula of conversion factors:the field strength at 3m was egtablished by adding The meter reading of the spectrum analyer (which is set to read in units of dBuV) To the antenna correction factor supplied by the antenna manufacturer. The antenna Correction factors are stared in terms of dB. The gain of the pressletor was accounted For in the spectrum analyser meter reading.


#### 8.1 Requirement

The field strength of any emissions appearing between the band edges and up to 10 kHz above and below the band edges shall be attenuated at least 26 dB below the level of the unmodulated carrier or to the general limits in § 15.209, whichever permits the higher emission levels.

#### **8.2** Method measurement:

A small sample of the transmitter outure was fed into the spectrum analyzer and the attached plot was taken. The vertical scale is set to 10dB per division.






