Gentlemen:

SmartSynch Communications Corporation ("SmartSynch"), in conjunction with its parent company SmartSynch, Inc. ("SSI"), has purchased the CreataLink™2 XT transmitter module product line from Motorola and hereby requests approval for a change in equipment identification to the certification for the transmitter modules, currently under FCC ID: E9698109, as set forth in the Federal Communications Commission's Rules and Regulations Part 2, Sections 2.929(d) and 2.933.

Per these rules, a new application is required which is comprised of this letter and attached exhibits. Since SmartSynch intends to build and market the transferred products without any modifications in design, circuitry or construction, test and measurement results are not submitted with this request per section 2.933(b).

As background information, FCC ID: E9698109 and, subject to approval, FCC ID: QHC0001, is a Frequency Modulation Communications Transceiver having two frequency conversions and is designed for the reception of one fixed frequency within the range of 929 to 941 MHz and transmission in the range of 896 to 902 MHz.

This radio equipment is intended for use in the common carrier paging system, PCS system and SMR system.

The information presented below is included per the requirements of sections 2.933 and 2.983.

Description of Transfer in Control: 2.931(d), 2.933(a)

On March 11, 2002, SmartSynch and SSI purchased the CreataLink[™]2 XT product line from Motorola, Inc. pursuant to an asset purchase agreement. The assets purchased included Motorola's entire finished goods inventory of CreataLink[™]2 XT products, parts inventory for CreataLink[™]2 XT and the technology necessary for SmartSynch to continue the manufacture, sale and distribution of CreataLink[™]2 XT products.

- How Equipment Differs from Original Equipment: 2.933(b)(3)
 - SmartSynch has made no alterations to the existing design, circuitry or construction of the product. All existing design elements including PCB layouts, schematics and components will be used exactly as produced currently.

2) The manufacturing equipment, processes, and software used by Motorola in the production of the products are included in the transfer of ownership and, therefore, will product an identical product.

Additionally:

 Motorola manufacturing personnel have trained the new manufacturer who is ISO9001 certified.

Conclusion:

Equipment will not differ in any way from the previously certified product.

Applicability of Originally Submitted Test Results: 2.933(b)(4)

By virtue of using identical designs, components, manufacturing equipment, software and processes, the original test results submitted continue to be representative of and applicable to the product bearing the changed FCC identifier.
