### 4.3 Test Procedure & Measurement Data

#### 4.3.1 Radiated Emissions

**Test Requirement:** FCC Part15 C  
**Test Method:** Based on FCC Part15 C Section 15.227  
**Test Date:** 24 April 2004  
**Measurement Distance:** 3m (Semi-Anechoic Chamber)  
**Requirements:** Carrier frequency will not exceed 80dBuV/m AT 3m.  
 Out of band emissions shall not exceed:  
 40.0 dBμV/m between 30MHz & 88MHz  
 43.5 dBμV/m between 88MHz & 216MHz  
 46.0 dBμV/m between 216MHz & 960MHz  
 54.0 dBμV/m above 960MHz  
**Detector:** Peak Scan (120kHz resolution bandwidth)

Test Procedure: The procedure used was ANSI Standard C63.4-2001. The receive was scanned from 30MHz to 1000MHz. When an emission was found, the table was rotated to produce the maximum signal strength. An initial pre-scan was performed for in peak detection mode using the receiver. The EUT was measured for both the Horizontal and Vertical polarities and performed a pre-test three orthogonal planes. The worst case emissions were reported.

## 4.3.2 Occupied Bandwidth

Test Requirement: FCC Part 15 C

Test Method: Based on FCC Part 15 C Section 15.227:


Operation within the band 26.96 – 27.28 MHz

Test Date: 24 April 2004

Requirements: The field strength of any emissions which appear outside of this band shall not exceed the general radiated emission limits in Section 15.209.

Method of measurement: The useful radiated emission from the EUT was detected by the spectrum analyser with peak detector. The vertical Scale is set to  $-10\text{dB}$  per division. The horizontal scale is set to  $5\text{KHz}$  per division.

The graph as below, represents the emissions take for this device.



**The results: The unit does meet the FCC Part 15 C requirements.**
