HUAWEI EM730 Module is subscriber equipment in the GSM/UMTS system. The frequency band is 850M. The EM730 implements such functions as RF signal receiving / Transmitting, UMTS/EDGE/GPRS/GSM protocol processing and data service etc. Externally it provides USB interface (to connect to the notebook etc.), USIM card interface. It has an internal antenna. EM730 uses Qualcomm MSM6246 chipset and Zero-IF technologies.

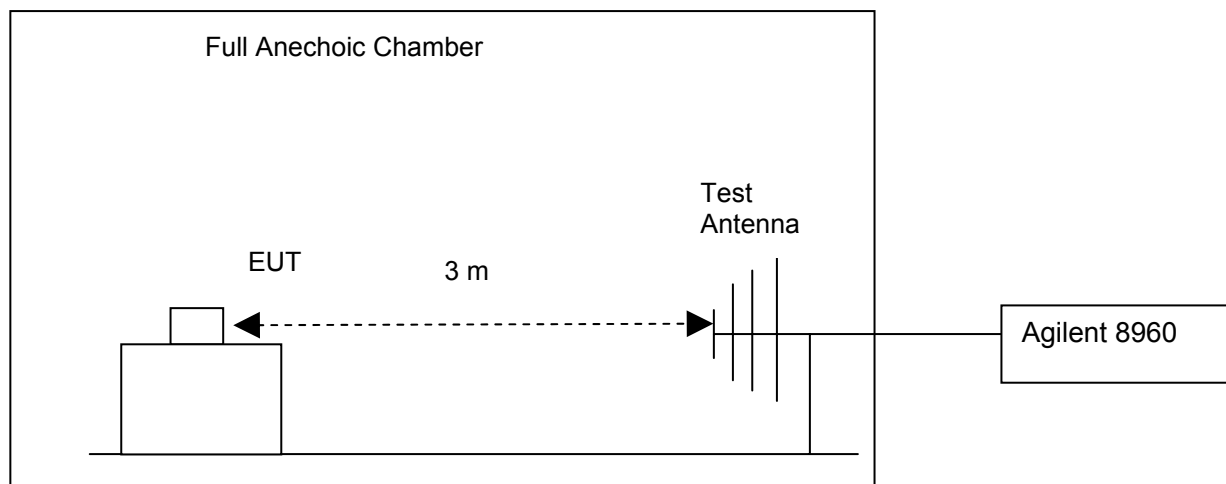
#### 6.1.3 Test Method and Setup

- For transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, ERP shall be measured when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in 2.1033(c)(8). Connect the HUAWEI EM730 Module to the wireless communication tester Agilent 8960 via the air interface. The band is set as 850M.
- Test the Radiated maximum output power by the 8960 received from test antenna.

- (c) Use substitution method to verify the maximum output power. The EUT is substituted by a dipole antenna. The dipole is connected to a signal generator. And then adjust the output level of the signal generator to get the same received power recorded in step (b) on Agilent 8960, and record the power level of Signal Generator. Of course, the cable loss at the test frequency should be compensated.

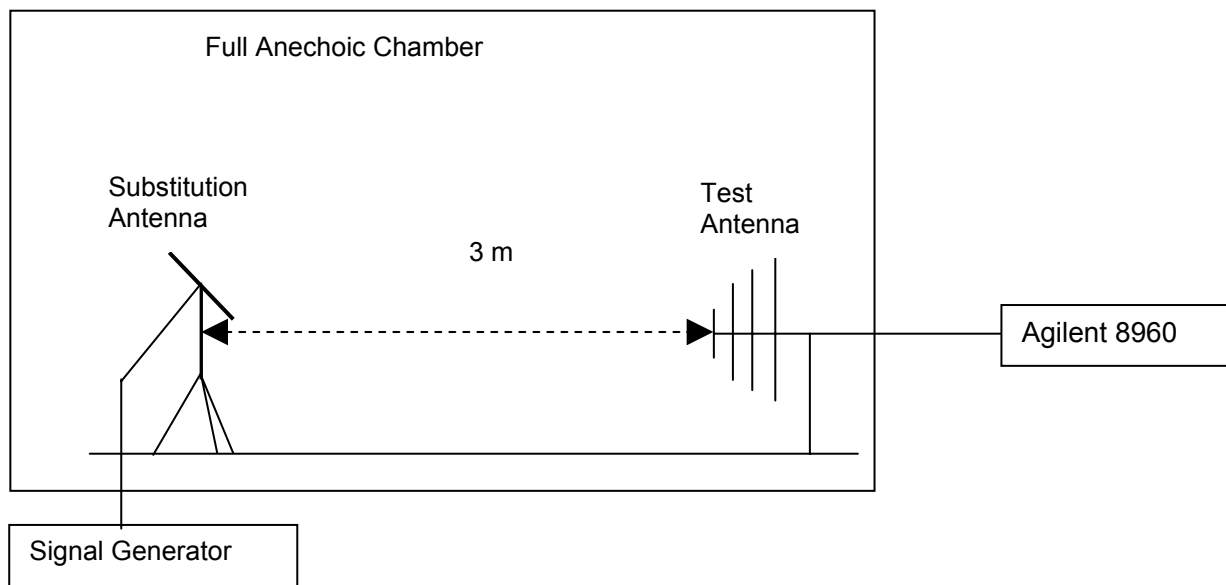


Figure 1. Test Set-up

Connect the HUAWEI EM730 Module to the wireless communication tester CMU200 via the antenna connector. The band class is set as US Cellular.

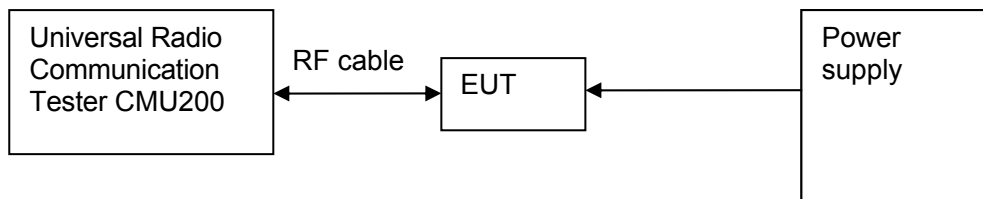


Figure 2. Test Set-up

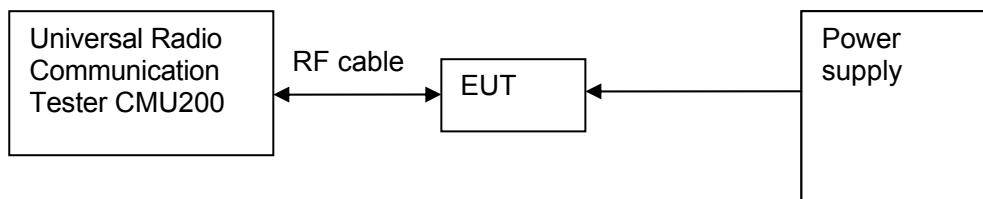


Figure 3. Test Set-up

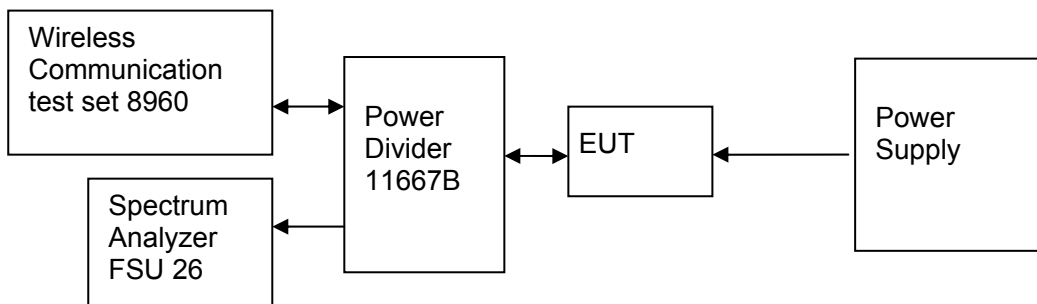


Figure 4. Test Set-up

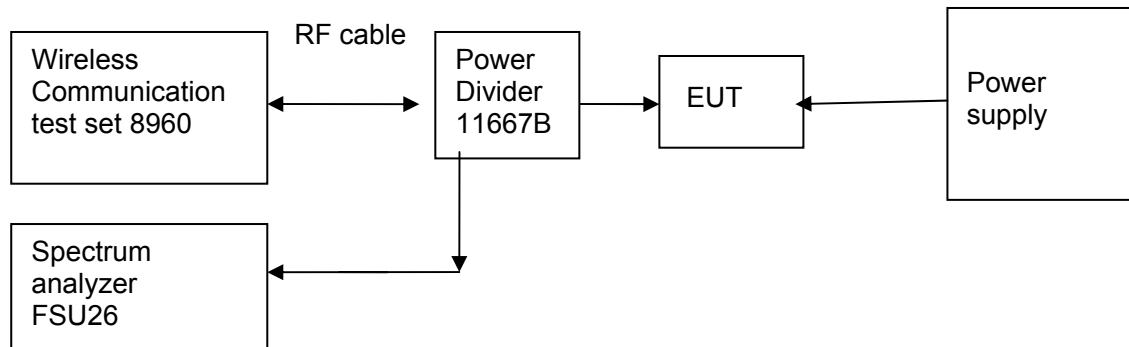


Figure 5. Test Set-up

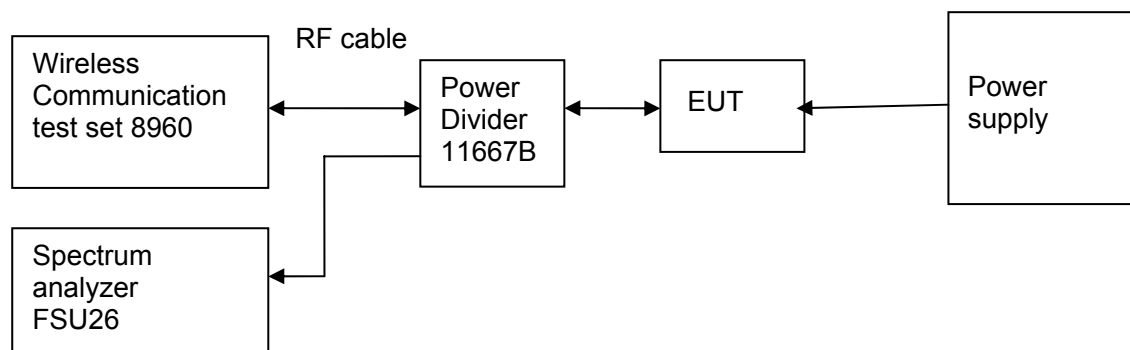


Figure 6. Test Set-up

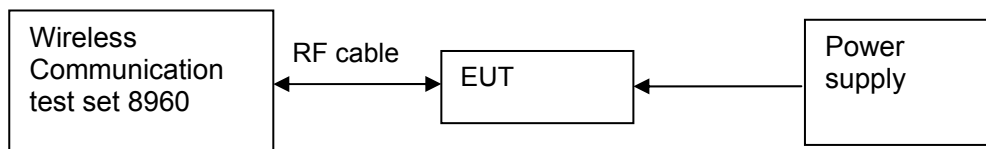


Figure 7. Test Set up

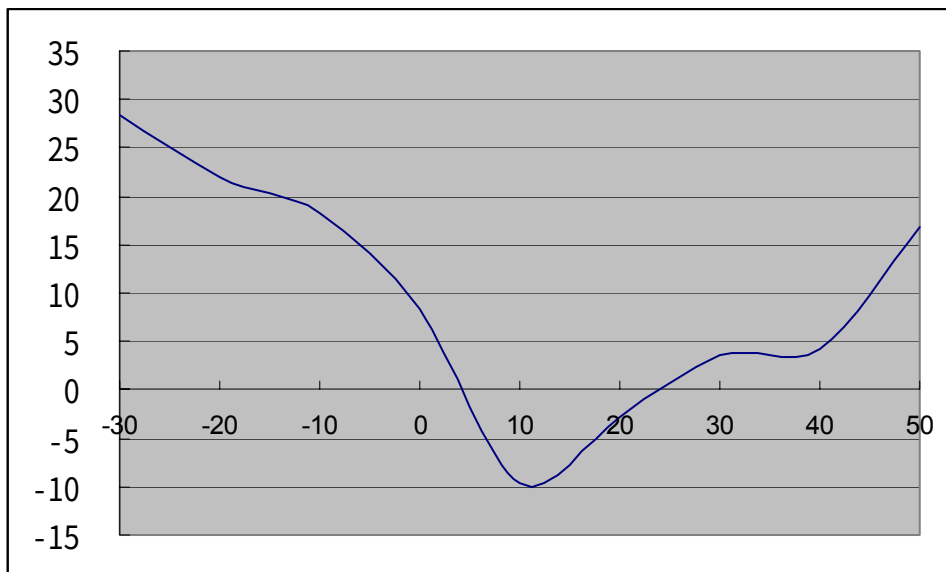


Figure 8. GPRS Mode Test Graph

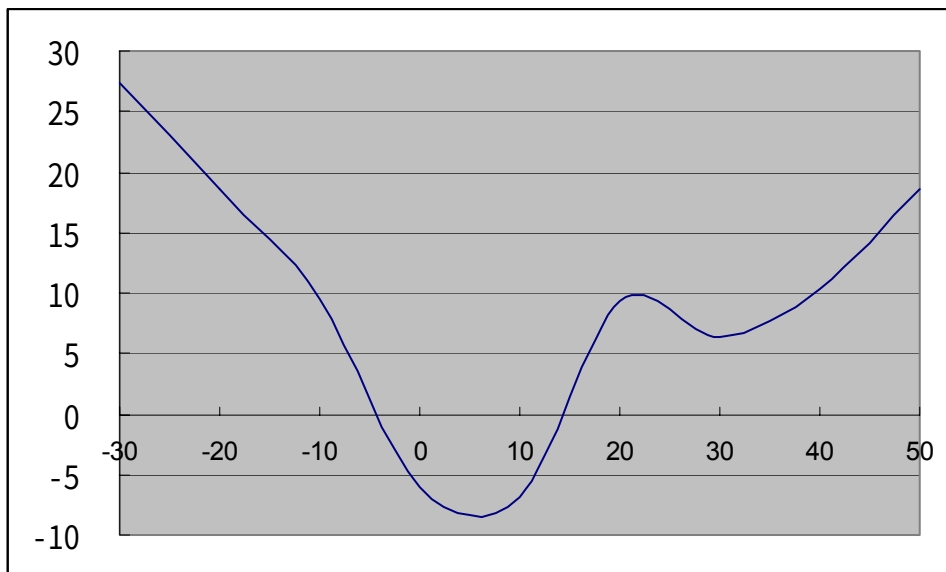


Figure 9. EDGE Mode Test Graph

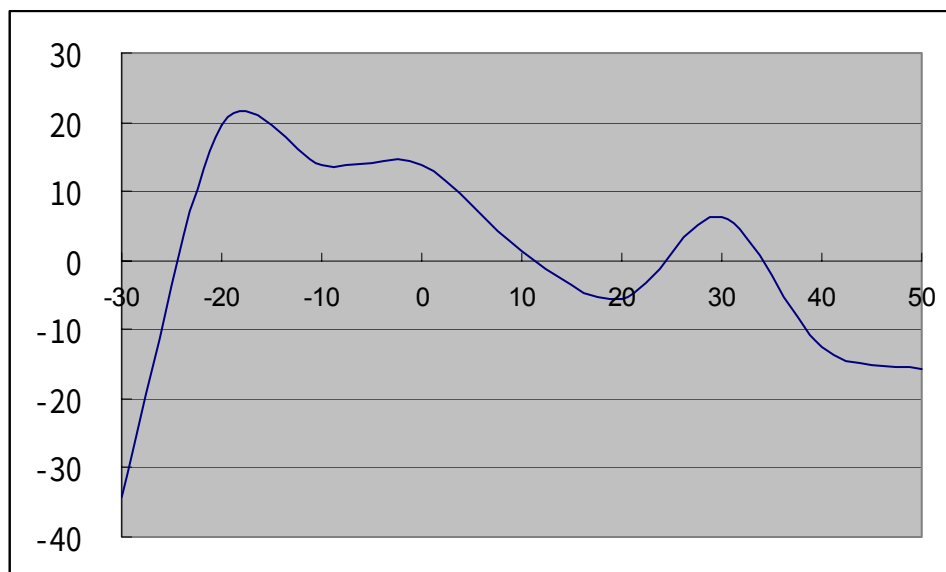


Figure 10. WCDMA Mode Test Graph
