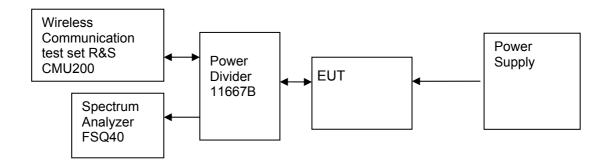


Figure 1. Test Set-up

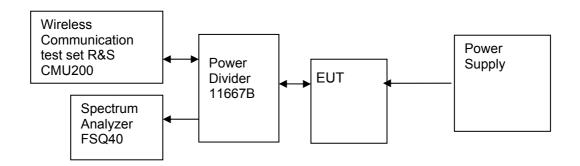


Figure 2. Test Set-up

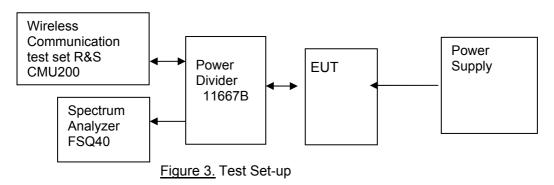

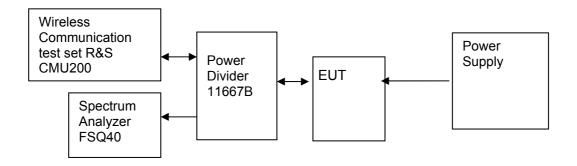


Figure 4. Test Set-up

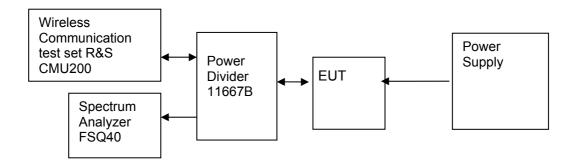


Figure 5. Test Set-up

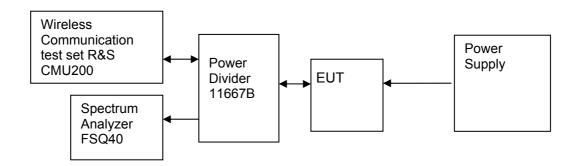


Figure 6. Test Set-up

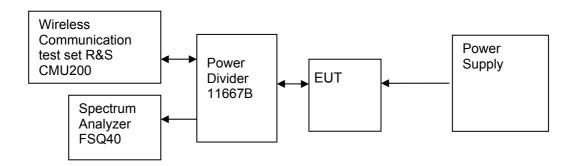


Figure 7. Test Set-up

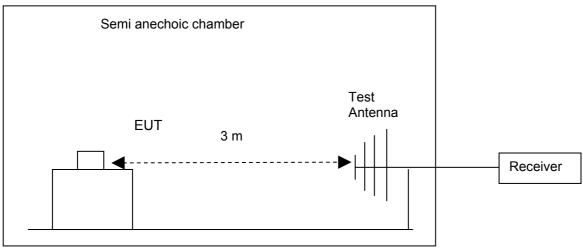


Figure 8. Test Set up

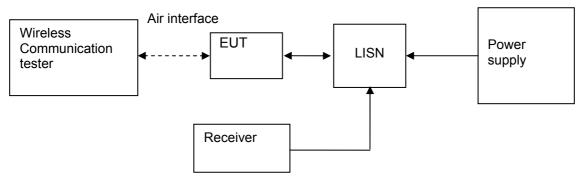


Figure 9. Test Set-up
