Pursuant to § 0.457 and 0.459 of the Commission's Rules (CFR 47), and § 552 (b) (4) of the Freedom of Information Act, Tecore, Inc. D/B/A Tecore Networks hereby requests confidential treatment of certain information accompanying this application. 

Internal Photos (#5) contain proprietary information that is supplied to any designated 3<sup>rd</sup> technical expert only under non-disclosure provisions.

The request for Long-Term Confidentiality of the User's Manual (#6) is submitted because of the highly technical nature of the manual and of the product. The **QLJMRU-060785** system operates in RF spectrum licensed from the FCC. The configuration, maintenance, and support of the system require highly-trained technical personnel trained by the Grantee, and **QLJMRU-060785** is serviceable by only the Grantee or a designated 3<sup>rd</sup> technical expert under non-disclosure protections. The User's Manual (#6) contains proprietary information that is supplied to any designated 3<sup>rd</sup> Party technical expert only under non-disclosure provisions.
