1 General Information

1.1 General Description

The equipment under test (EUT) is a transmitter for 12" RC Movie Daleks and 12" RC TV Daleks. It operates at 49.860MHz which is controlled by a crystal. The EUT is powered by a 9V size battery. There are two control buttons on the EUT. When the left-forward, left-backward, right-forward or right-backward button is pressed, it will transmit different radio control signal to receiver.

The brief circuit description is listed as follows:

- U1, Q3 and associated circuit act as an encoder.
- Y1, Q1 and associated circuit act as an oscillator.
- Q2 and associated circuit act as a RF amplifier.

2 Description of the radiated emission test

2.1 Test Procedure

Radiated emissions measurements are investigated and taken pursuant to the procedures of ANSI C63.4 - 2003.

The equipment under test (EUT) was placed on a non-conductive turntable with dimensions of 1.5m x 1m and 0.8m high above the ground. 3m from the EUT, a broadband antenna mounting on the mast received the signal strength. The turntable was rotated to maximize the emission level. The antenna was then moving along the mast from 1m up to 4m until no more higher value was found. Both horizontal and vertical polarization of the antenna were placed and investigated.

For below 30MHz, a loop antenna with its vertical plane is placed 3m from the EUT and rotated about its vertical axis for maximum response at each azimuth about the EUT. And the centre of the loop shall be 1 m above the ground.

The device was rotated through three orthogonal axes to determine which attitude and configuration produce the highest emission during measurement.

2.2 Test Result

The harmonic emissions meeting the requirement of section 15.209 are based on measurements employing the CISPR quasi-peak detector below 1000MHz and average detector for frequencies above 1000MHz.

* Emissions appearing within the restricted bands shall follow the requirement of section 15.205.

It was found that the EUT meet the FCC requirement.

5.1 Bandwidth

The plot on saved in TestRpt2.pdf shows the fundamental emission is confined in the specified band. The field strength of any emission appearing between the band edges and up to 10 kHz above and below the band edges (49.81 and 49.91 MHz) is at least 26dB below the carrier level. It meets the requirement of Section 15.235(b).

5.2 Duty cycle

The duty cycle is simply the on-time divided by the period:

The duration of one cycle = 70.88ms

Effective period of the cycle = $4 \times 1.60 \text{ms} + 58 \times 0.53 \text{ms}$

= 37.14ms

Duty Cycle = 37.14ms/ 70.88ms

= 0.52

Therefore, the average factor is found by $20 \log_{10} 0.52 = -5.6 dB$
