





### Experience True Plug "n" Play

#### Plugging In




1. Connect the male plug connector into the earphone jack of your fa128.
2. Connect the USB connector into the USB port of your computer.  
(The Status LED will glow red when the connection is complete.)
3. The fa128 will show up as a removable disk in "My Computer" on your PC. Charging will automatically begin. It takes about 150 minutes to completely recharge a fully discharged battery. (The Status LED will glow green once the battery is fully charged.)

### Charging the fa128 with the Optional AC Power Adapter

Note: Your MP3 player has a rechargeable battery that is automatically recharged through the USB port on your PC. The charging method illustrated below is OPTIONAL.



1. Connect the end of the USB cable to the earphone jack of the fa128.
2. Plug the USB end of the USB cable into the DC to USB Adapter.
3. Connect the to the optional AC Power Adapter to the DC to USB Charging Adapter. (Use power adapters that have a 4.5-5.5 VDC 100mA output and a (+) - (-) plug configuration.)

### Q & A on the fa128 Power System

When do I recharge the battery?	When the LED flashes red during playback, it indicates that the battery needs recharging. You must recharge the batteries before using your player.
Status LED	During the recharging process the LED will glow red. When the battery is fully charged the LED will glow green.
Charging Problem	If the Status LED is neither red nor green when connected to the PC, <b>STOP CHARGING IMMEDIATELY</b> . Unplug and reconnect unit. If the problem persists contact Freestyle Audio Customer Care.

\* Your fa128 must be recharged (Status LED will glow green) prior to its initial use.



## Getting Ready

### Transfer Your Tunes to the fa128

To transfer files to the MP3 Player:

1. Make sure the MP3 Player is powered on and connected to a USB port on your PC.
2. Double click on "My Computer" and locate the MP3 tracks you want to download.
3. Select the desired track(s).
  - Click once to select a single track.
  - Shift-click or Ctrl-click to select multiple tracks.



4. Drag and drop the selected tracks to the Removable disk window.  
The Status Led will flash red as the files are down loading.

**DO NOT DISCONNECT USB CABLE WHILE FILES ARE DOWN LOADING.**

Note: Only files having a MPEG 1/2 audio layer 3 format can be played (\*.mp3)

### Transfer Your Data Files to the fa128

You can also copy data file(s) to your fa128 in the same manner illustrated above and use it as a removable disk. You should always back up your music and data files.

## Time to Play

### Listening to Your Tunes

#### **Power On / Playback**

With the earbuds connected, press and hold the (▶) button for about one second. A beep will sound when the unit powers on in playback mode (Status LED will flash green). Your tunes will automatically start playing.

**Note:** If earbuds are not connected the Status LED will alternately flash red and green and then power down (off).

#### **Power Off / Stop**

Press and hold the (■) button for about one second. A beep will sound and the player will stop and power down (off). Please note that the unit will automatically turn off if the earbuds are disconnected from the player.

#### **Replay Current Track (from Beginning)**

Pressing the (◀◀) button after 10 seconds of playback into the current track (a beep will sound) will cause the player to begin playback of the current track from its beginning.

#### **Next Track**

Pressing the (▶▶) button (a beep will sound) will cause the player to begin playback of the next track from its beginning. Keep repeating to step forward through your tracks.

#### **Previous Track**

Pressing the (◀◀) button within 10 seconds of playback (a beep will sound) will cause the player to begin playback of the previous track from its beginning. Keep repeating to step backward through your tracks.




