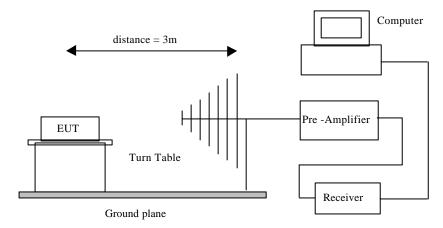

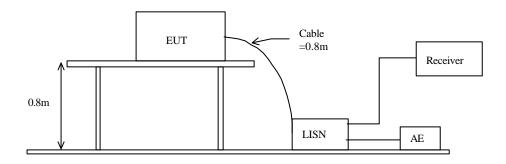

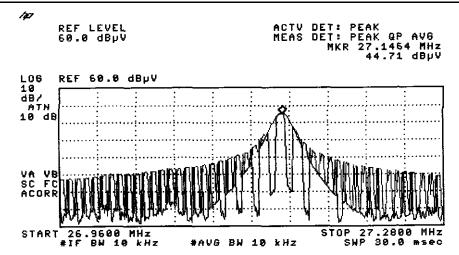

#### **Duty Cycle Correction During 100msec**

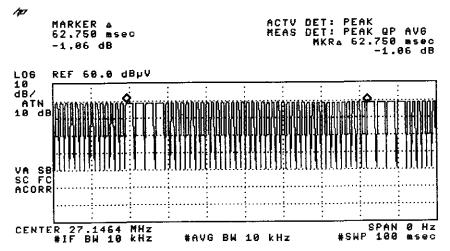
Each function key sends a different series of characters, but each packet period (62.75msec) never exceeds a series of 4 long (1.875msec) and 40 short (625μsec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered 4x1.875msec+40x625μsec per 62.75msec=51.7% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.

#### Remarks:

Duty Cycle Correction = 20Log(0.517) =-5.7dB

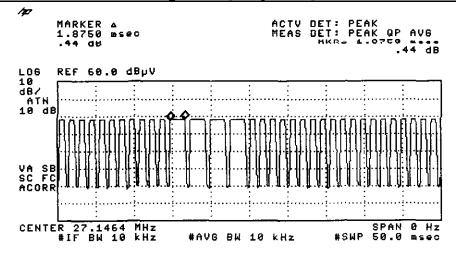

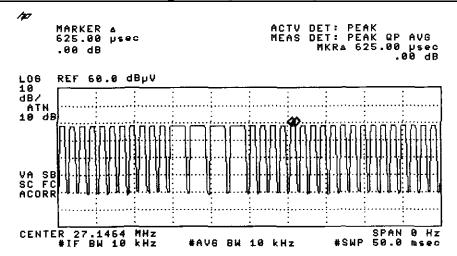
