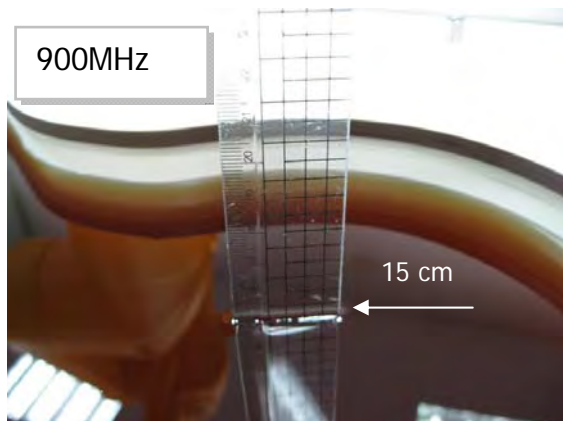

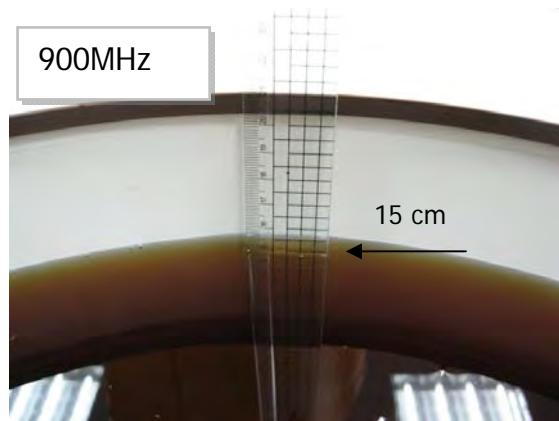

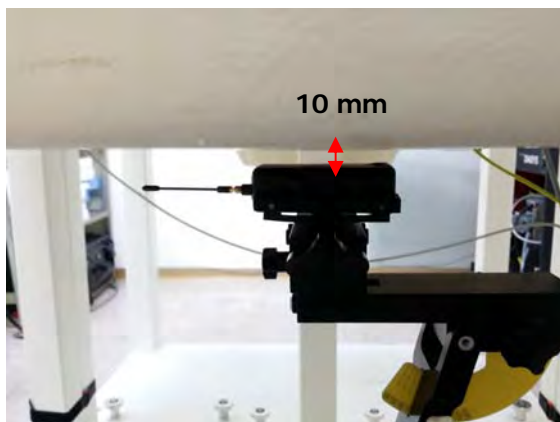


Fig.3 EUT Back side to flat phantom

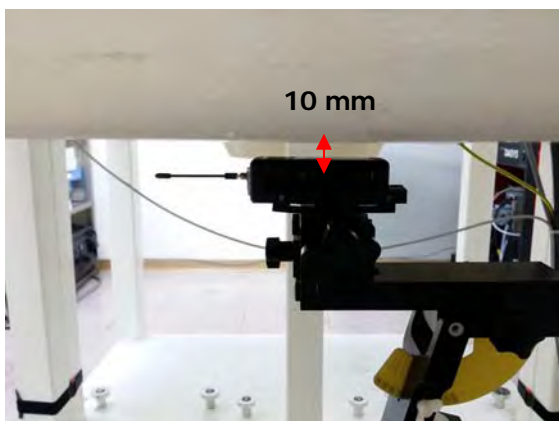
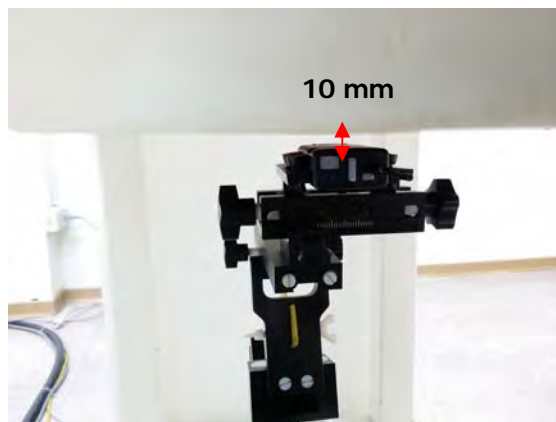


Fig.4 EUT Front side to flat phantom

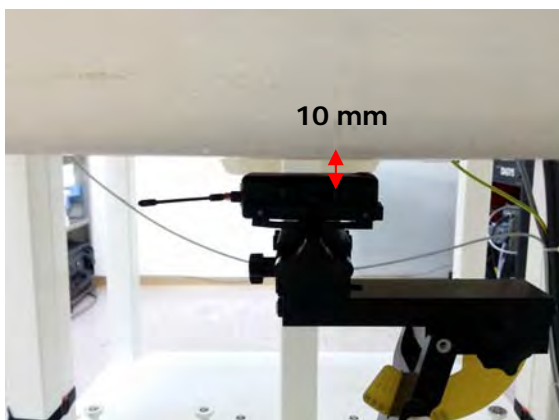


Fig.5 Face mode_1 (45°)

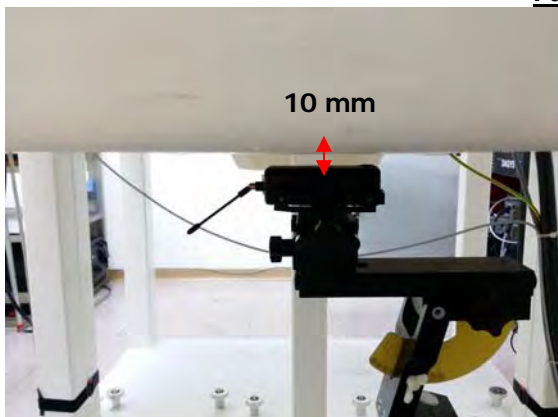


Fig.6 Face mode_2 (45°)

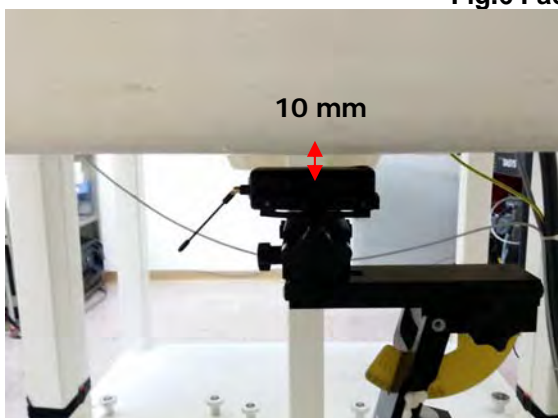
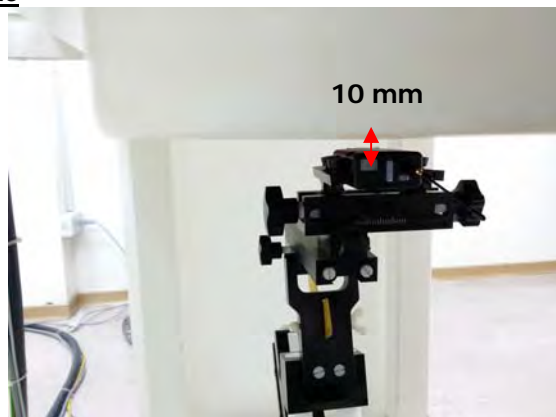


Fig.7 Face mode_3 (45°)

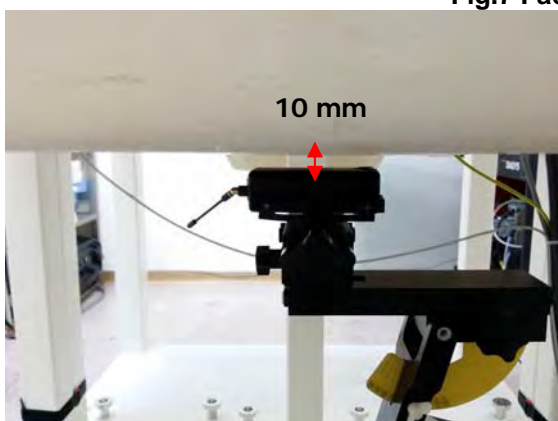
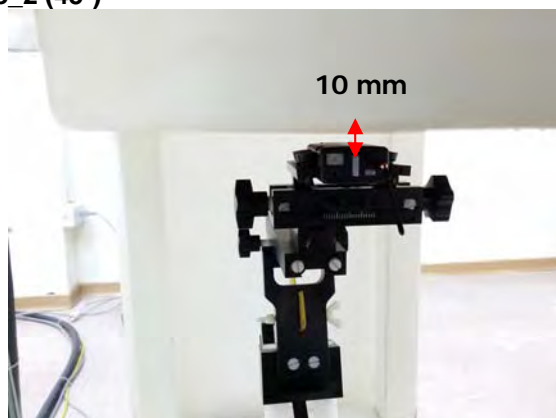
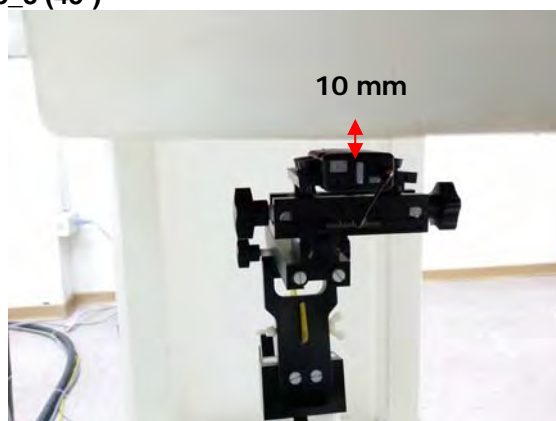


Fig.8 Face mode_4 (45°)

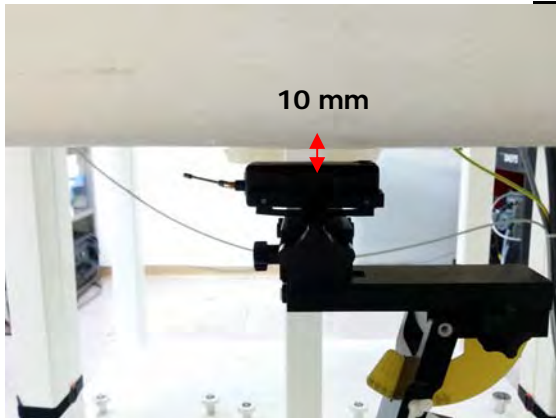


Fig.9 Face mode_5 (45°)

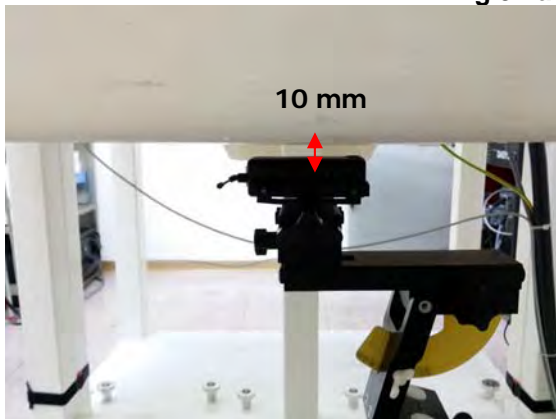
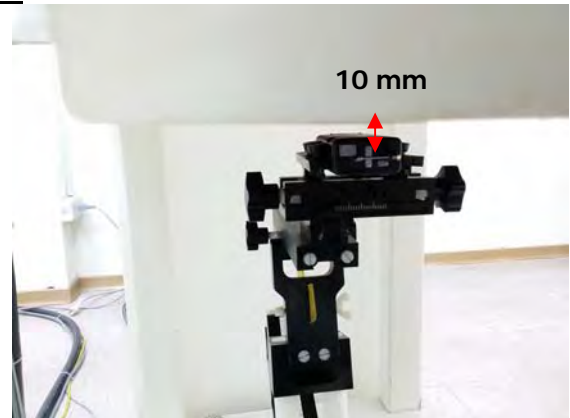


Fig.10 Face mode_1 (90°)

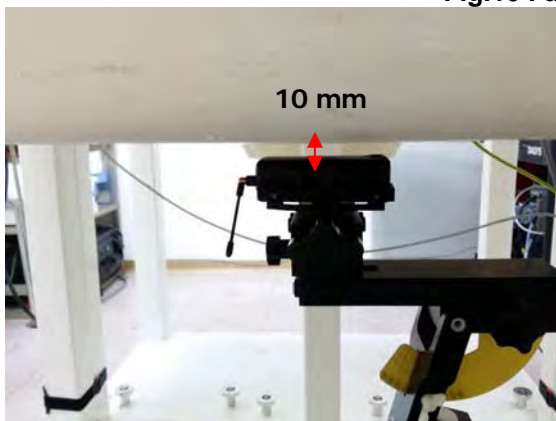
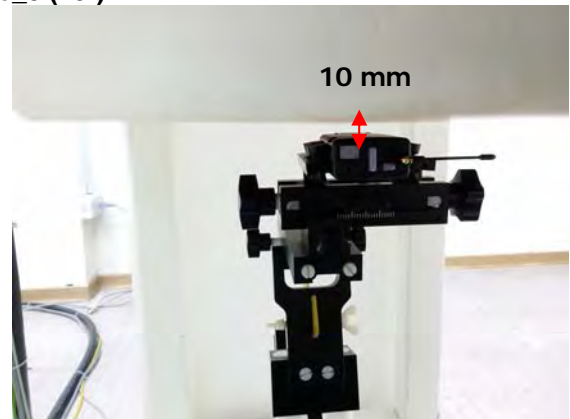
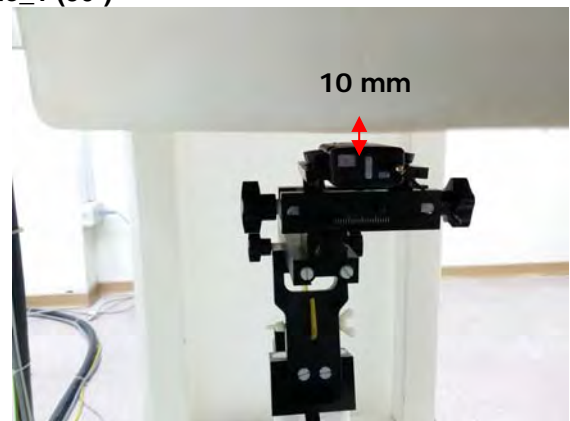


Fig.11 Face mode_2 (90°)

Fig.12 Face mode_3 (90°)

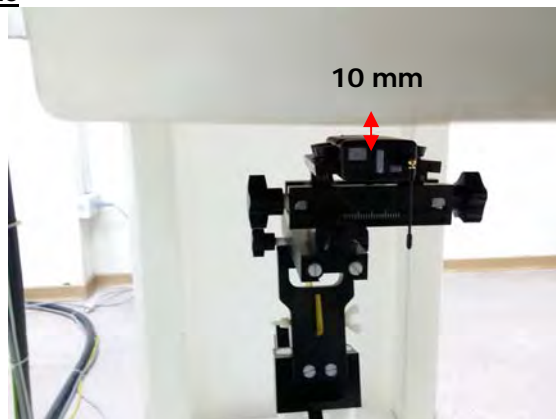


Fig.13 Face mode_4 (90°)

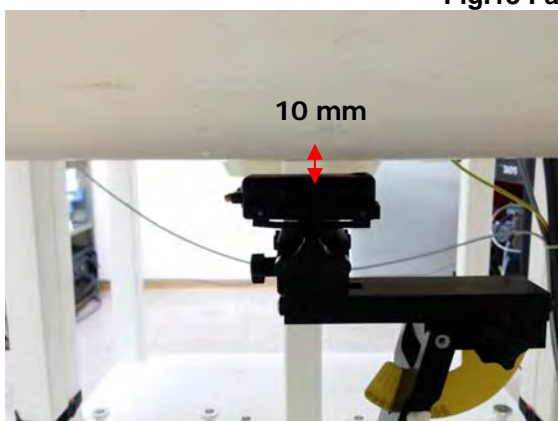
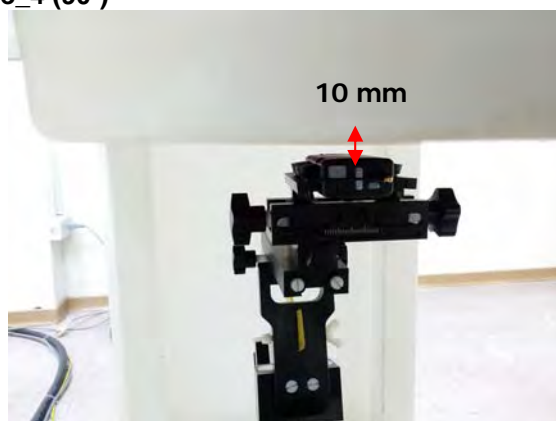


Fig.14 Face mode_5 (90°)

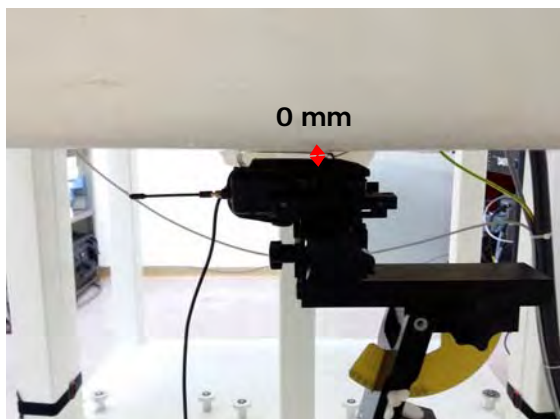


Fig.15 EUT Back side to flat phantom

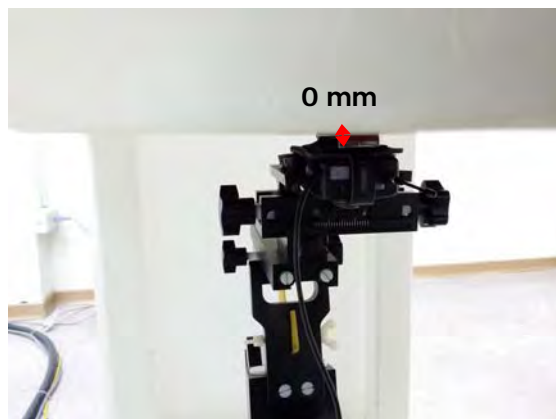


Fig.16 EUT Front side to flat phantom

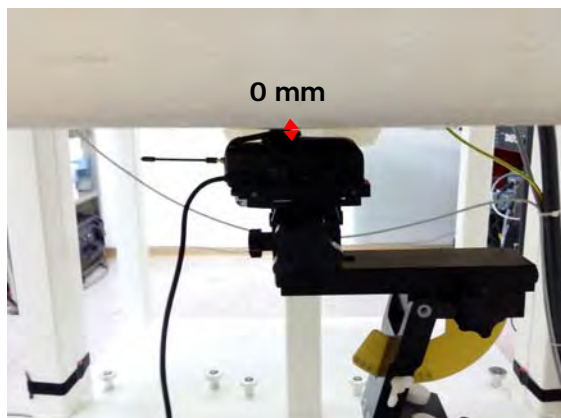
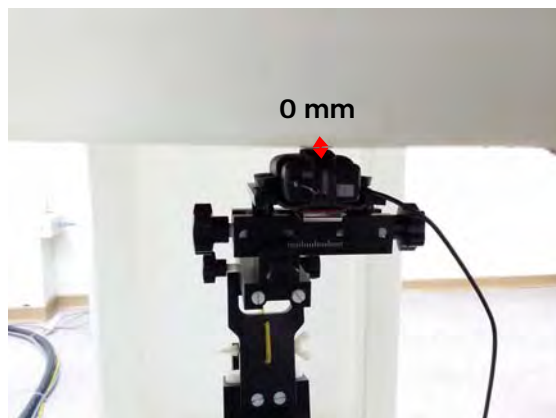


Fig.17 Body mode_1 (45°)

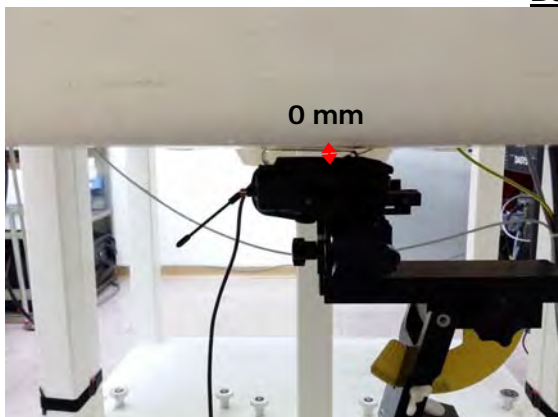


Fig.18 Body mode_2 (45°)

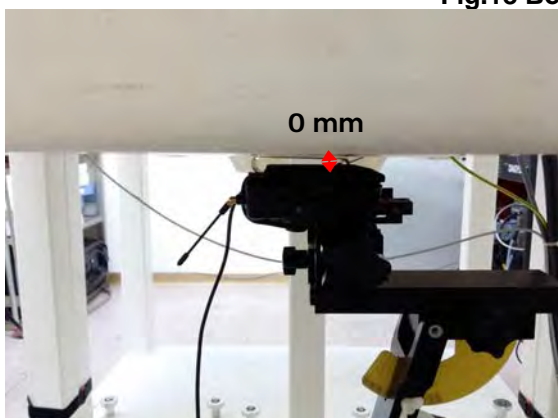
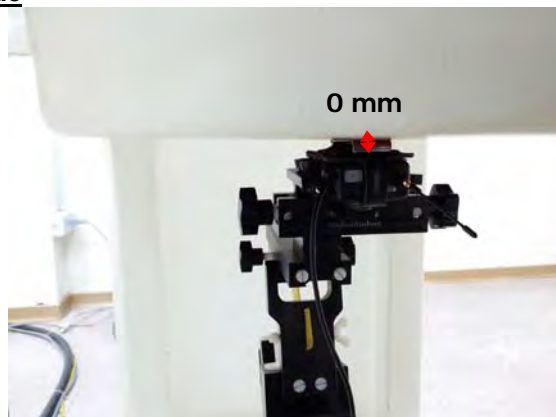


Fig.19 Body mode_3 (45°)

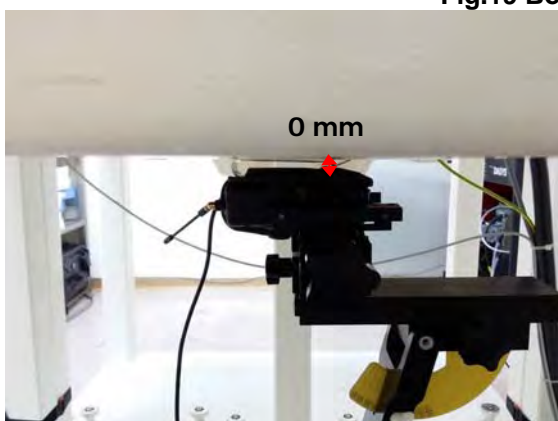
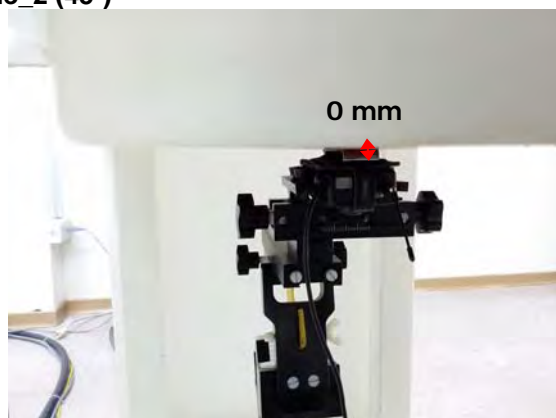
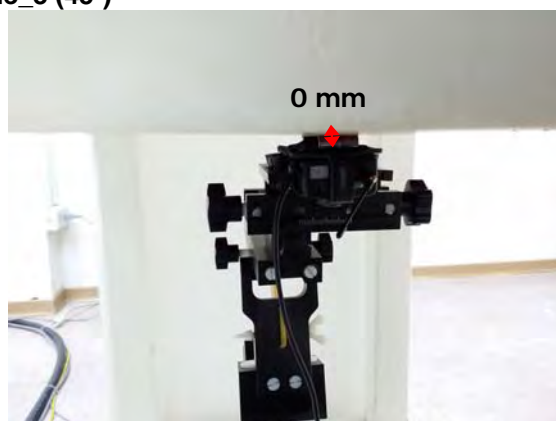


Fig.20 Body mode_4 (45°)

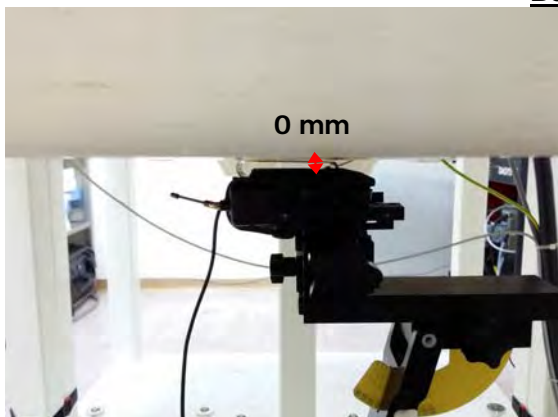


Fig.21 Body mode_5 (45°)

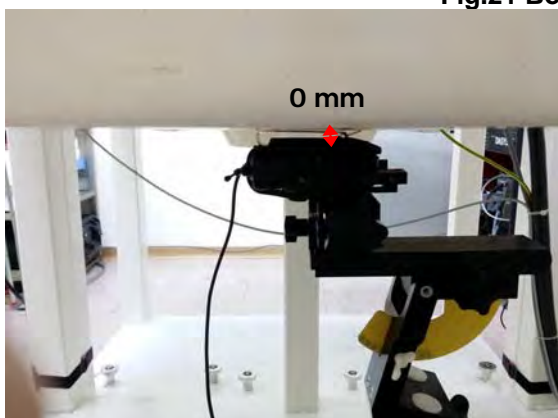
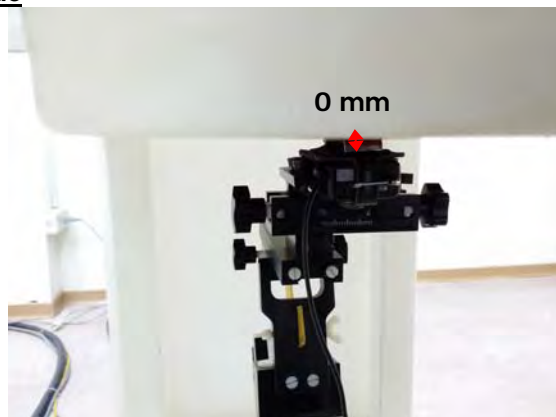


Fig.22 Body mode_1 (90°)

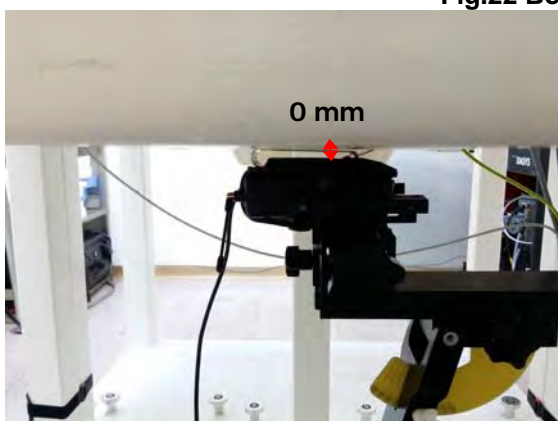
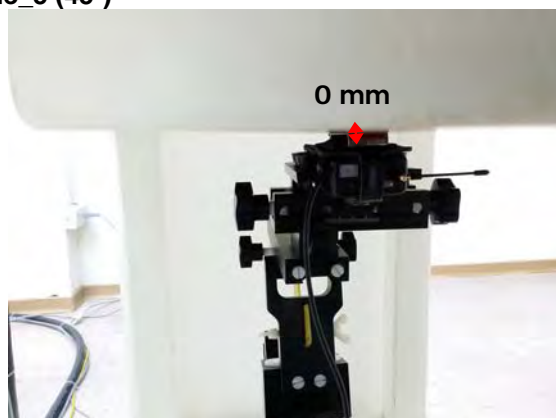


Fig.23 Body mode_2 (90°)

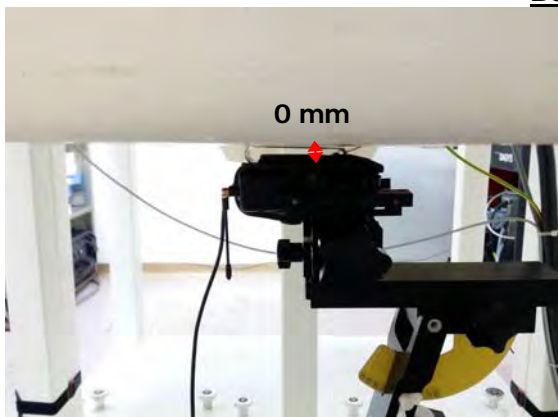


Fig.24 Body mode_3 (90°)

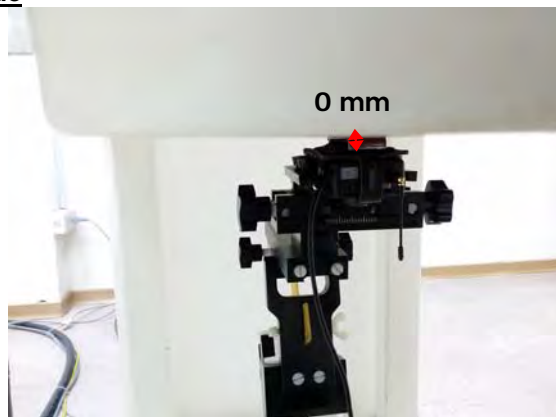


Fig.25 Body mode_4 (90°)

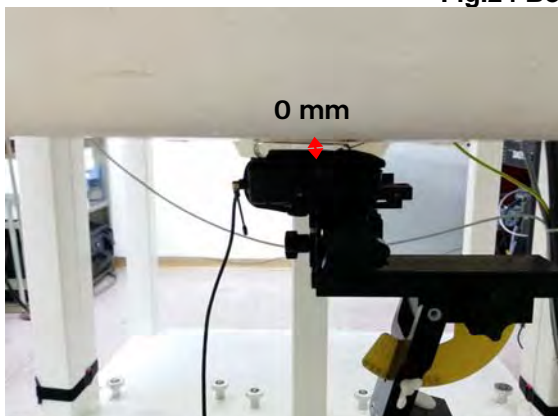
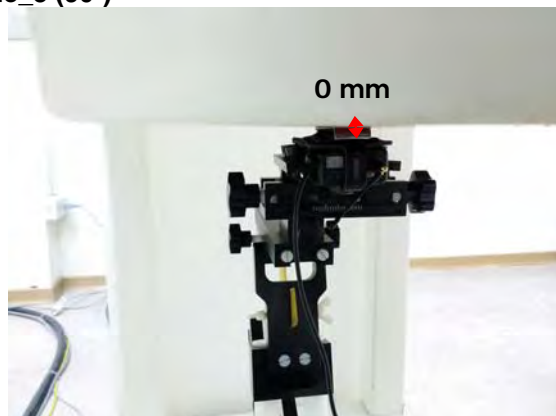


Fig.26 Body mode_5 (90°)
