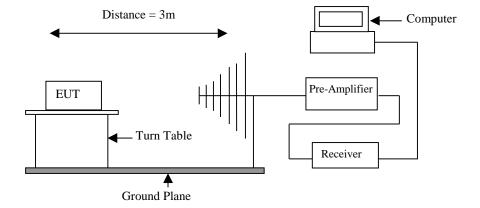

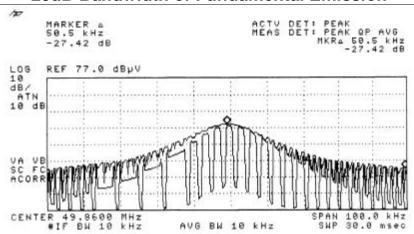

#### **Duty Cycle Correction During 100msec**

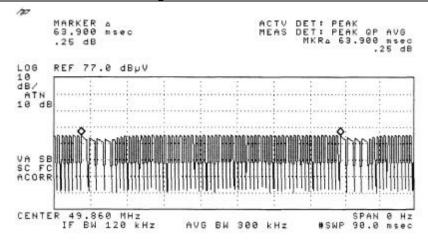
Each function key sends a different series of characters, but each packet period (63.9msec) never exceeds a series of 4 long (1.425msec) and 56 short (525 $\mu$ sec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered 4x1.425msec+525 $\mu$ sec per 63.9msec=54.9% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

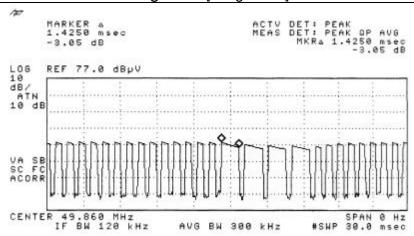

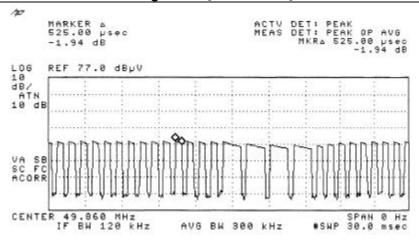
