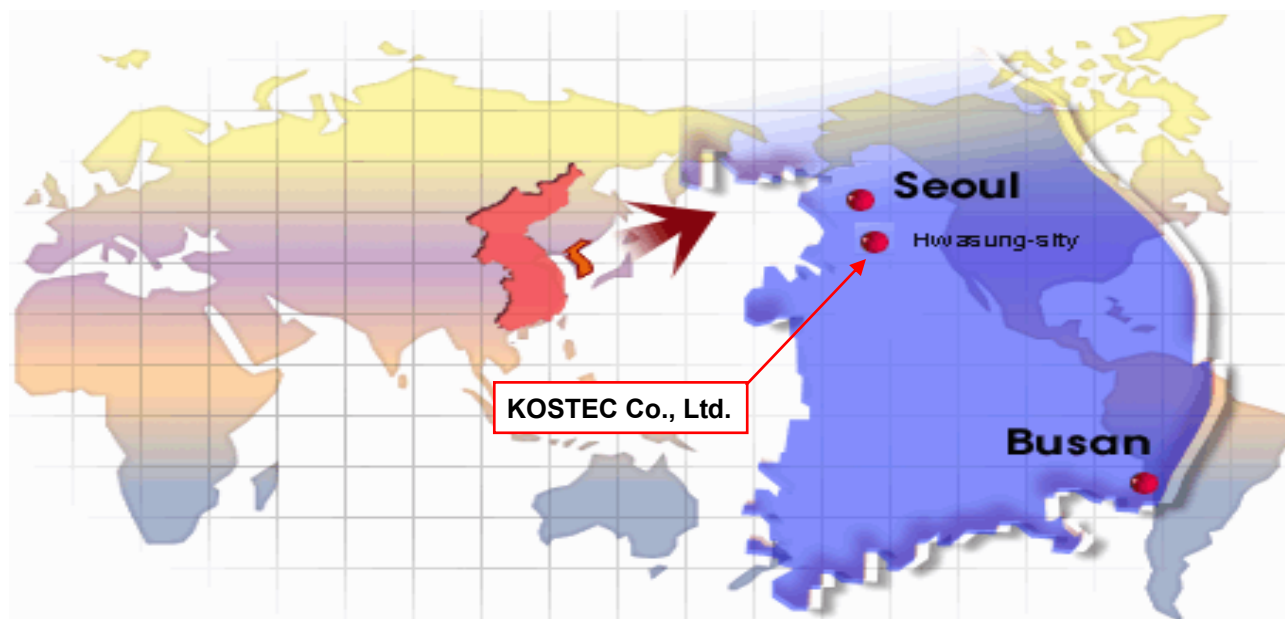

The measurements were taken in continuous transmit mode using the test mode which controlled by Broadcom Blue Tool. The test command and the test Jig and cables were provided by the applicant.



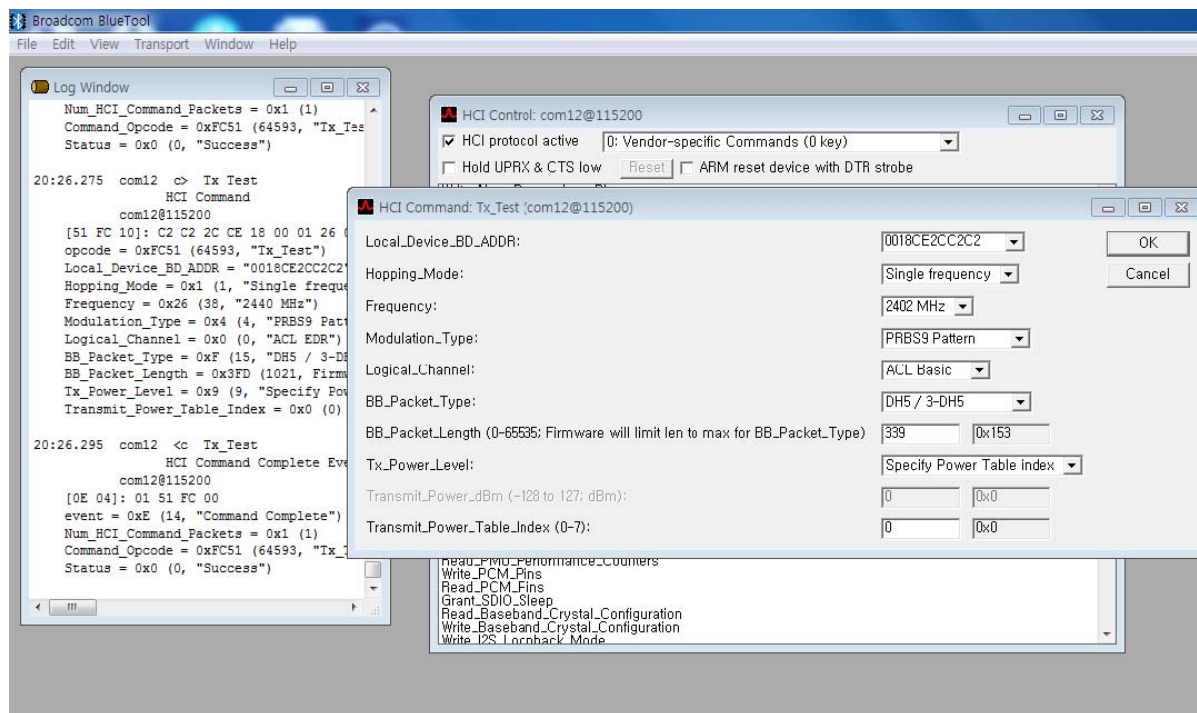
### 3.6 Parameters of Test Software Setting

## 5. MEASUREMENT RESULTS

### 5.1 Peak Output Power

#### 5.1.1 Standard Applicable [FCC §15.247(b)(1)]

For frequency hopping systems operating in the 2 400 ~ 2 483.5 MHz band employing at least 75 non-overlapping hopping channels, and all frequency hopping systems in the 5 725 ~ 5 850 MHz band : 1 Watt.  
For all other frequency hopping systems in the 2400 ~ 2483.5 MHz band: 0.125 watts.

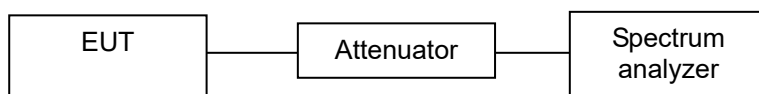
#### 5.1.3 Measurement Procedure

ANSI C63.10 (2013) : Filing and Measurement Guidelines for Frequency Hopping Spread Spectrum Systems. The peak output power was measured using the marker to peak function of the spectrum analyzer.

The spectrum analyzer is set to the as follows :

- Span : approximately 5 times the 20 dB bandwidth
- RBW : > 20 dB bandwidth of the emission being measured
- VBW ≥ RBW.
- Sweep time = auto
- Detector = peak.
- Trace mode = max hold.
- Allow trace to fully stabilize.

## 5.2 20 dB Bandwidth

### 5.2.1 Standard Applicable [FCC §15.247(a)(1)]

Operation under the provisions of this Section is limited to frequency hopping and digitally modulated intentional radiators that comply with the following provisions:

(1) Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. ## 5.6 Conducted Spurious Emissions (Band-edge)

### 5.7.3 Measurement Procedure

The measurements procedure of the Spurious RF Radiated emissions is as following describe method.

1. The EUT was placed on the top of a rotating table (0.8 meters for below 1 GHz and 1.5 meters for above 1 GHz) above the ground at a 3 meter camber. The table was rotated 360 degree to determine the position of the highest radiation.
  2. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna master.
  3. The antenna height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both Horizontal and vertical polarizations of the antenna are set to make the measurement.
  4. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotating table was turned from 0 - 360 degrees to find the maximum reading.
  5. The measuring receiver was set to peak detector and specified bandwidth with max hold function.
  6. Low, Middle and high channels were measured, and radiation measurements are performed in X, Y, Z axis positioning. And found the worst axis position and only the test worst case mode is recorded in the report.
- The measurement results are obtained as described below:

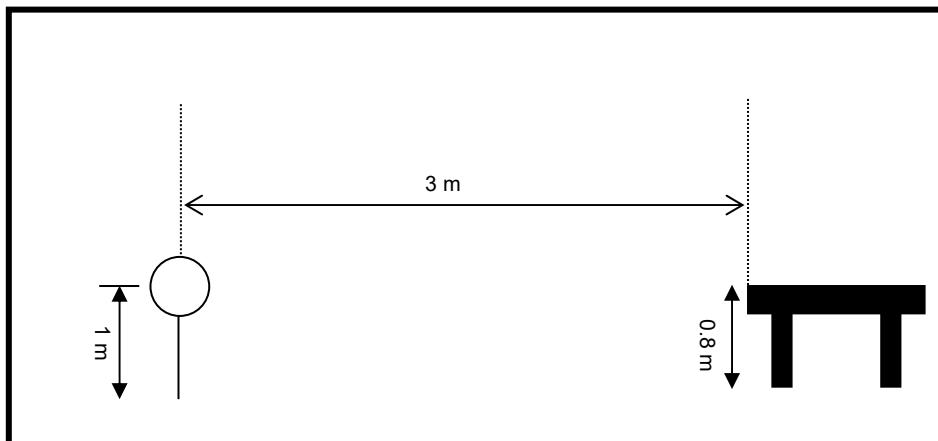

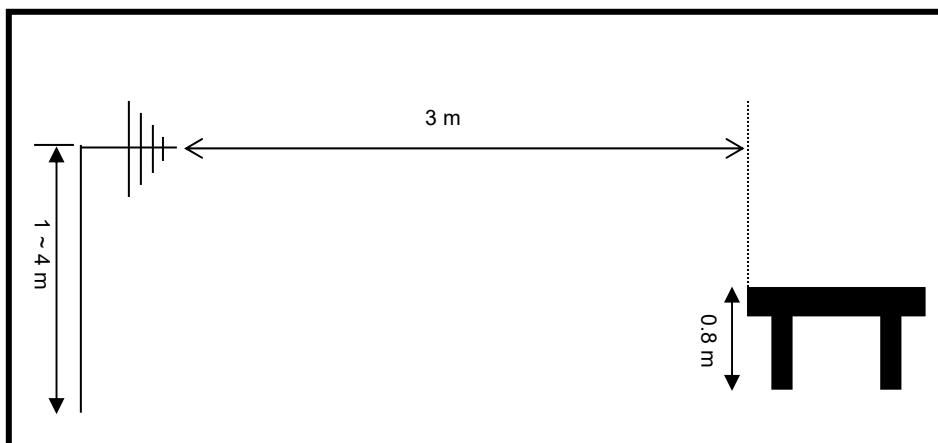

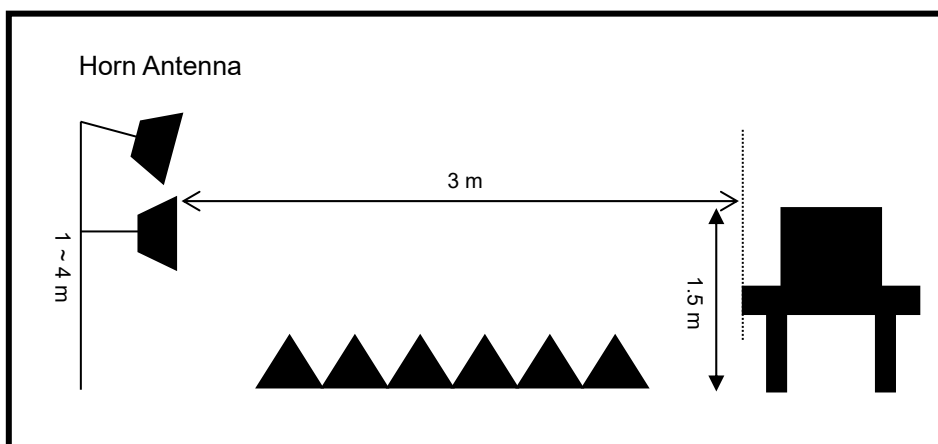
Radiated emission setup, below 30 MHz

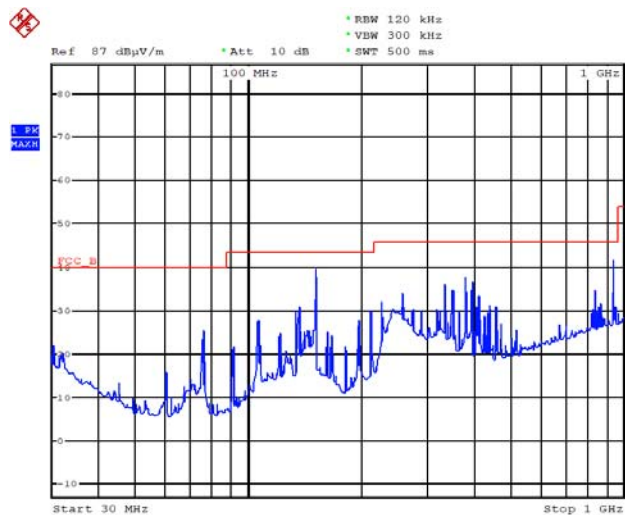

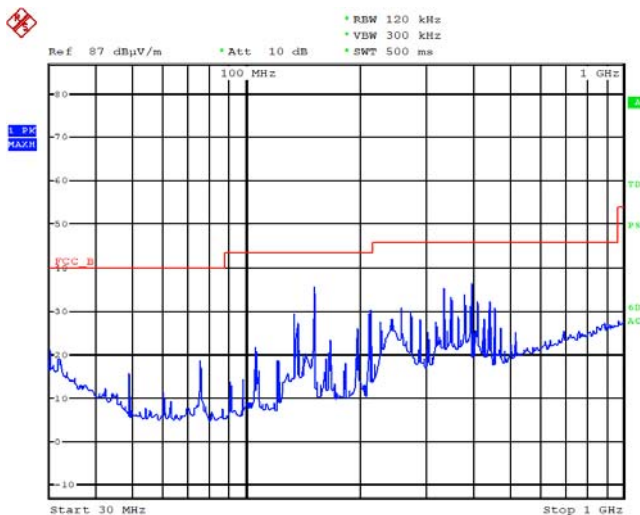

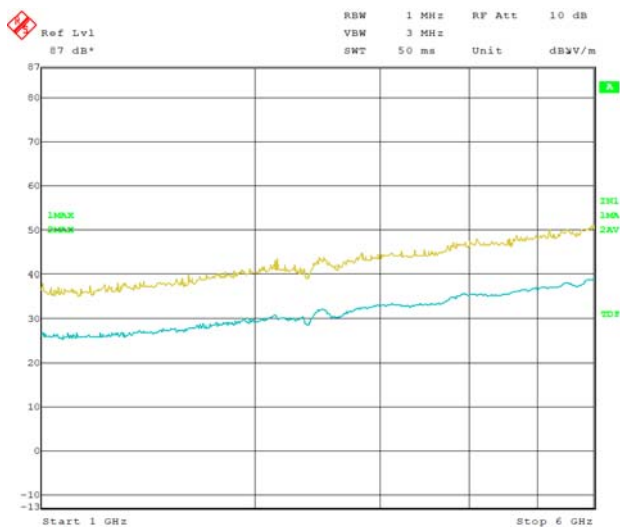
Horizontal

## 5.8 Antenna requirement

### 5.8.1 Standard applicable [FCC §15.203]

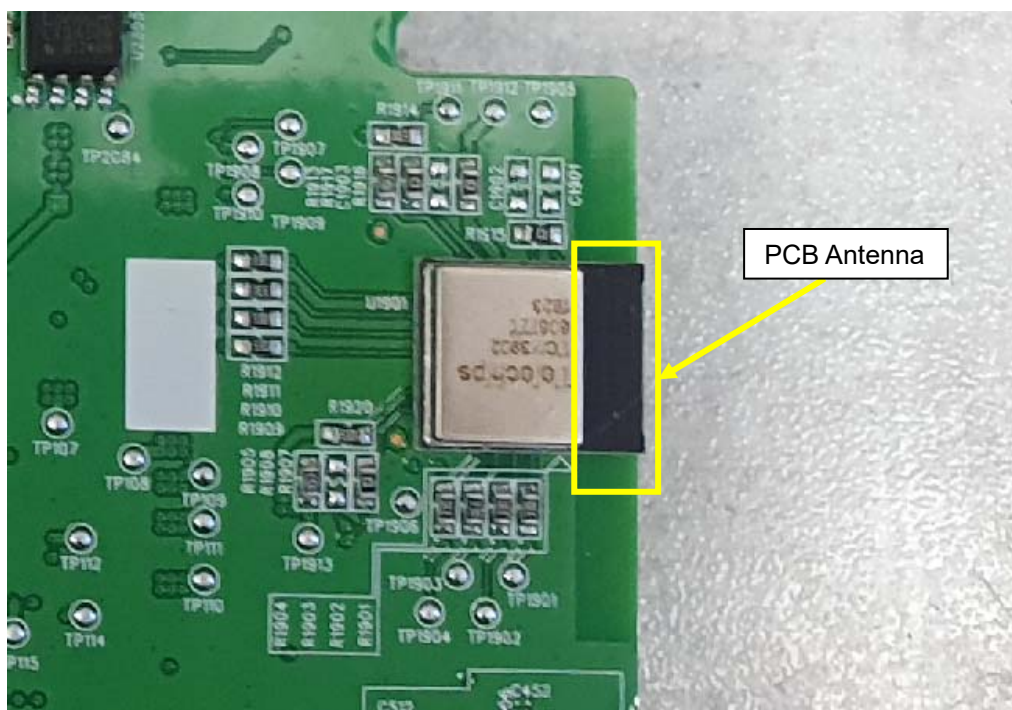
For intentional device, according to §15.203, an intentional radiator shall be designed to ensure that no antenna other than furnished by responsible party shall be used with the device.

The use of a permanently attached antenna or of an antenna that user a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

The manufacturer may design the unit so that broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

## 5.9 AC Power Conducted emissions

### 5.9.1 Standard Applicable [FCC §15.207(a)]

For intentional radiator that is designed to be connected to the public utility(AC)power line, the radio frequency. Voltage that is conducted back onto the AC power line on any frequencies hopping mode within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50  $\mu$ H/50 ohms line Impedance stabilization network(LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal.
