Note:

1. The maximum output power is 12.80dBm (19.05mW) at 2438MHz (with -2.0dBi numeric antenna gain.)
2. For mobile or fixed location transmitters, no SAR consideration applied. The minimum separation generally be used is at least 20 cm, even if the calculations indicate that the MPE distance would be lesser.

Calculation

Given $S = \frac{P \times G}{4\pi d^2}$ *Equation 1*

Where $d = \text{distance in cm}$

$P = \text{Power in mW}$

$G = \text{Numeric antenna gain}$

$S = \text{Power Density in mW/cm}^2$

Maximum Permissible Exposure

EUT Output Power=19.05mW

Numeric antenna gain=0.63

Substituting the MPE safe distance using $d=20$ cm into *Equation 1* :

The power density $S = 19.05 \times 0.63 / (4\pi \times 400) \text{ cm}^2 = 2.39 \times 10^{-3} \text{ mW/cm}^2$

(For mobile or fixed location transmitters, the maximum power density is 1.0 mW/cm^2 even if the calculation indicates that the power density would be larger.)
