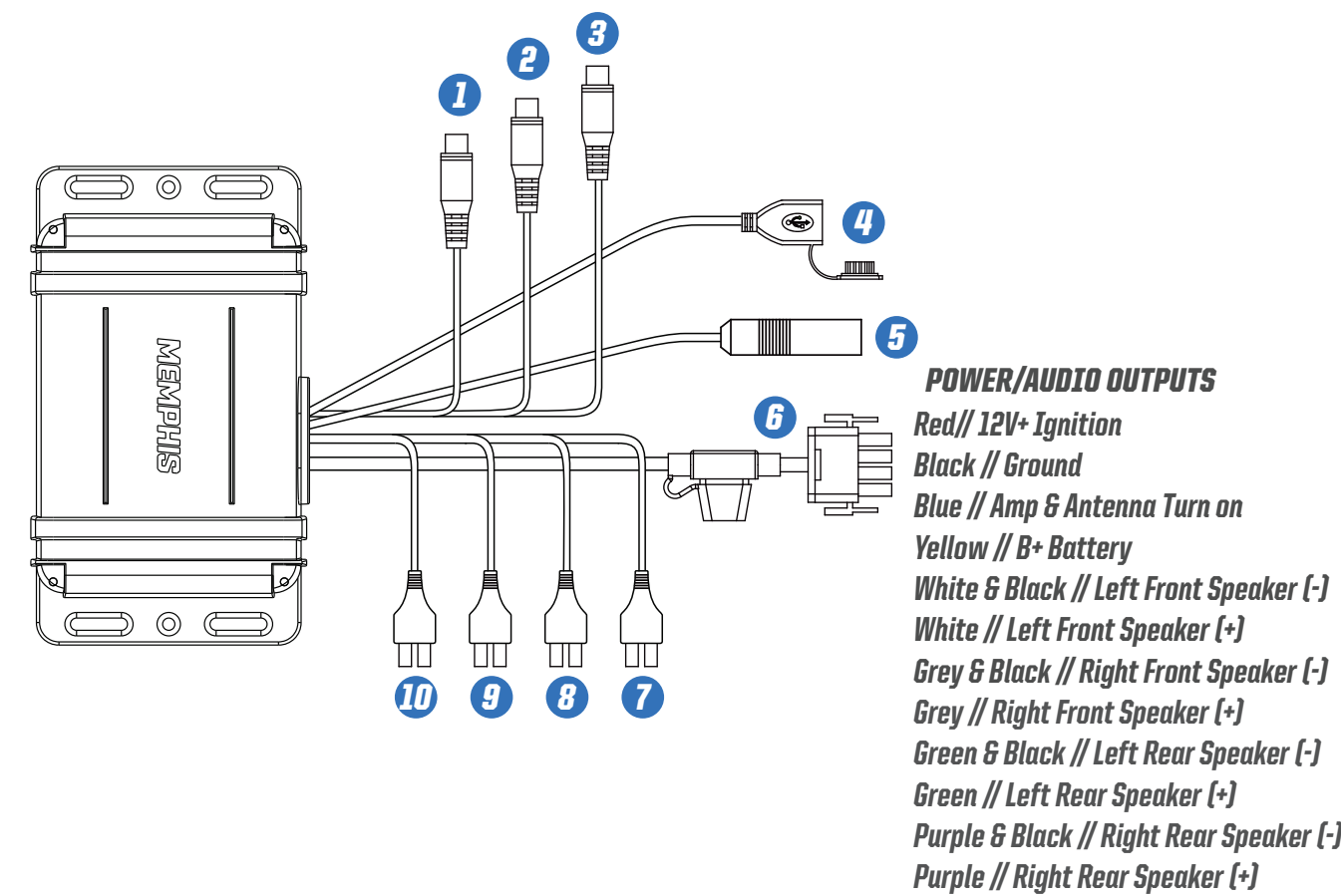


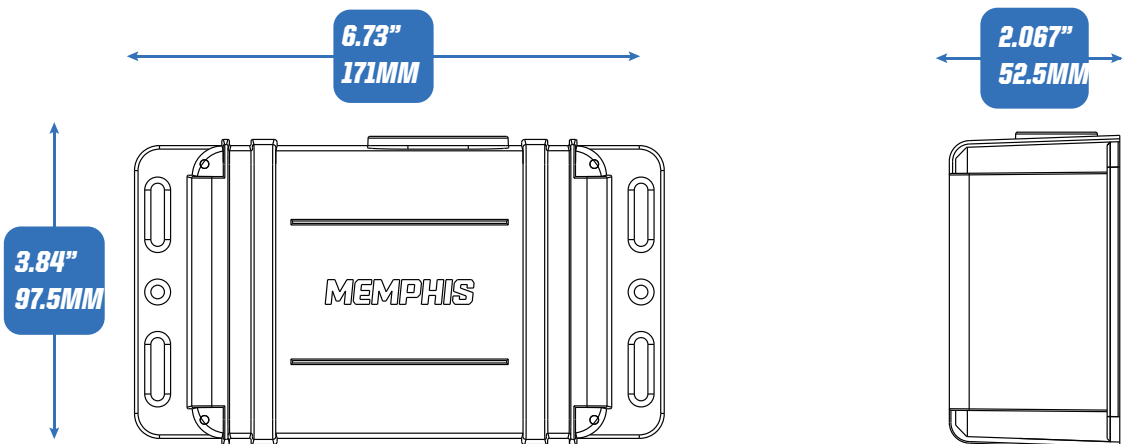

INSTALLATION OVERVIEW



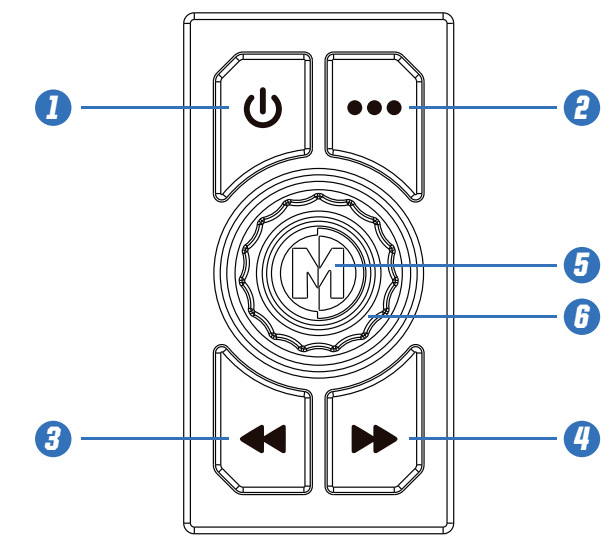
CONNECTIONS

- 1. Trigger
- 2. RGB Led
- 3. Wired Remote
- 4. USB
- 5. Radio Antenna
- 6. Power
- 7. Black RCA / AUX IN
- 8. White RCA / Front
- 9. Red RCA / Rear
- 10. Green RCA / SUB



*Note: Mounting depth is 90mm but room is required for wires and connections. Check available depth prior to mounting. Measure before cutting and be certain you will not be drilling into any items that will damage your vehicle.

BUTTON FUNCTIONS



CONTROLS

- 1. POWER/SOURCE KEY
- 2. SOFT KEY
- 3. FORWARD ARROW
- 4. BACK ARROW
- 5. ENCODER CENTER
- 6. VOLUME UP/DOWN

POWER/SOURCE KEY

POWER ON: SHORT PRESS to power unit ON. LONG PRESS for 2 seconds to power unit OFF.

SOURCE SELECTION: When unit is ON, short press to cycle through sources: Bluetooth, FM, AM, AUX, WB, USB, corresponding colors are blue, red, pink, green, yellow, cyan.

SOFT KEY

SHORT PRESS to turn on/off the RGB light. LONG PRESS to turn on/off Trigger 1

BACK/FORWARD ARROWS

RADIO MODE:

Short press back arrow to Preset+, long press to Seek+.
Short press forward arrow to Preset-, long press to Seek-.

USB MODE:

Short press back arrow to next song, long press to fast-forward.
Short press forward arrow to previous song, long press to fast-rewind.

BT MODE:

Short press back arrow to next song.
Short press forward arrow to previous song.

TRIGGER MODE:

Short press back arrow to cycle through T1, T2, T3, T4, OFF.
Short press forward arrow to cycle through T4, T3, T2, T1, OFF.

ENCODER KEY

RADIO MODE:

Short press to mute.

USB MODE:

Short press to pause/play.

BT MODE:

Short press to pause/play.

VOLUME UP/DOWN

VOLUME ADJUSTMENT: Turn Knob to adjust volume up or down.

WARRANTY
