Subject – Attestation of software used in Part 15E UNII-2A and UNII-2C submission for FCC ID: QWP-50450I.

Cambium Networks confirm that: -

During certification test the PMP 450I / PTP 450I uses internal development software which is identified as Bxxx-PXP455-PRODTEST, where xxx is a unique reference number, this development software is the building block for the final released software as any new developments such as support for additional frequency bands or changes which are seen to be beneficial are carried forward into the next software version. On completion of certification test and internal System Integration Test the collated internal development software is released to customers with a customer facing traceable identification reference “Canopy W.X.Y.Z”, where W is the Major version number, X is the Minor version number, Y is a Point release and Z is a bug fix to a point release.

CANOPY 14.0 is the first release and a major software version, CANOPY 14.1 would be a minor modification to the major software release, Canopy 14.1.1 would be a Point Release to the minor release and Canopy 14.1.1.1 would be a Dot bug fix to the point release.

Note: the decision to increment the “major” version is determined by marketing considerations, and does not indicate the need for a permissive Class change.

We state that software version B176 is a progression from version B135 and B144 and does not affect the performance of the product as previously tested and that CANOPY 14.0 reflects the software used to demonstrate DFS compliance. The customer release software to support Part 15E UNII-2A and UNII-2C will be CANOPY 14.2. There are no changes in the Point software release CANOPY 14.2 that may affect any of the certification test cases.
