



## 6 Measurement and Calculation

### 6.1 Maximum transmit power

**EUT Operation:** Test in fixing frequency operating mode at lowest, middle and highest frequency.

### 6.2 MPE Calculation

According to the formula  $S = \frac{PG}{4R^2\pi}$ , we can calculate S which is MPE.

Note:

- 1)  $P$  (Watts) = Power Input to antenna =  $10^{\frac{dBm}{10}} / 1000$
- 2)  $G$  (Antenna gain in numeric) =  $10^{\wedge}$  (Antenna gain in dBi / 10)
- 3)  $R$  = distance to the center of radiation of antenna (in meter) = 20cm
- 4) MPE limit = 1mW/cm<sup>2</sup>

The Max Conducted Peak Output Power is 0.10mW in lowest channel;

The best case gain of the antenna is 0dBi. 3dB logarithmic terms convert to numeric result is nearly 0

$$\text{So, } S = \frac{PG}{4R^2\pi} = \frac{0.10 \times 0}{4 \times 400 \times 3.14} = 0 \text{ mW/cm}^2 < 1 \text{ mW/cm}^2$$

So the device is exclusion from SAR test.
