2. Identifying Components



No.	Description
1	On/Off Button: Wi-Fi wake-up supported
2	Microphone
3	Power Status LED
4	Camera Status LED
5	Mode Switch (Normal/Covert)
6	HD Camera Lens
7	Wheel Switch (C1/C2/C3/C4)
8	Main Button (Start/Stop/Mark/Confirm)
9	Speaker
10	Dock Connector: Connects to the charging dock.
11	Interlocking Grooves: Fit the tongues of the chest/molle mount.
12	RFID Tag

3. Attaching to the Mount

To attach the camera to the mount:

- Aligning the tongues and grooves, slide the mount downwards to the camera until the two fit and click into place.



- Slide the latch inwards to secure the camera to the mount.

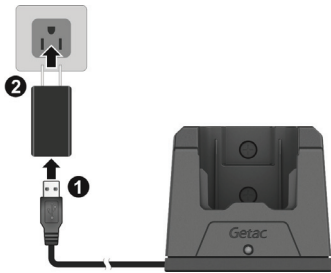


To detach:

- Slide the latch outwards to the unlocked position.
- Slide the camera off the mount.

4. Docking

- Connect the power cable to the adapter plug (1).
- Connect the adapter plug to an electrical outlet (2).



- Put BWC BC-02 in the charging dock.

The LED on the dock lights up to indicate power is connected.

5. Notices

FCC Regulations
