

**Remark:**

1. Evaluated all the transmitter signal and reporting worst-case configuration among all modulation types.
2. The device is investigated from 30MHz to 10 times of fundamental signal for radiated spurious emission test under different RB size/offset and modulations in exploratory test. Subsequently, only the worst-case emissions are reported.
3. RSE tests were performed with Adapter 1, Battery 1 and SKU A.
4. For 5G NR test combination is EN-DC 5A\_n77A.



## **3.2 Conducted Output Power and EIRP**

### **3.2.1 Description of the Conducted Output Power Measurement and EIRP Measurement**

A system simulator was used to establish communication with the EUT. Its parameters were set to force the EUT transmitting at maximum output power. The measured power in the radio frequency on the transmitter output terminals shall be reported.

The EIRP of transmitters must not exceed 1 Watts for 5G NR n77

According to KDB 412172 D01 Power Approach,

$EIRP = P_T + G_T - L_C$ ,  $ERP = EIRP - 2.15$ , where

$P_T$  = transmitter output power in dBm

$G_T$  = gain of the transmitting antenna in dBi

$L_C$  = signal attenuation in the connecting cable between the transmitter and antenna in dB

### **3.2.2 Test Procedures**

1. The transmitter output port was connected to the system simulator.
2. Set EUT at maximum power through the system simulator.
3. Select lowest, middle, and highest channels for each band and different modulation.
4. Measure and record the power level from the system simulator.






For radiated test below 30MHz




For radiated test from 30MHz to 1GHz

##### Note:

The low frequency, which started from 9 kHz to 30MHz, was pre-scanned and the result which was 20dB lower than the limit line was not reported.

There is adequate comparison measurement of both open-field test site and alternative test site - semi-Anechoic chamber according to 414788 D01 Radiated Test Site v01r01, and the result came out very similar.



## **4.2 Radiated Spurious Emission Measurement**

### **4.2.1 Description of Radiated Spurious Emission Measurement**

The radiated spurious emission was measured by substitution method according to ANSI / TIA-603-E. For base station operations in the 3700–3980 MHz band, the conducted power of any emission outside the licensee's authorized bandwidth shall not exceed –13 dBm/MHz.

The spectrum is scanned from 30 MHz up to a frequency including its 10th harmonic.

### **4.2.2 Test Procedures**

The testing follows FCC KDB 971168 D01 v03r01 Section 7 and ANSI C63.26-2015 section 5.5.4 Radiated measurement using the field strength method.

1. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
2. The EUT was set 3 meters from the receiving antenna, which was mounted on the antenna tower.
3. The table was rotated 360 degrees to determine the position of the highest spurious emission.
4. The height of the receiving antenna is varied between one meter and four meters to search the maximum spurious emission for both horizontal and vertical polarizations.
5. Make the measurement with the spectrum analyzer's RBW = 1MHz, VBW = 3MHz, taking the record of maximum spurious emission.
6. To convert spectrum reading E(dBuV/m) to EIRP(dBm)  
$$\text{EIRP(dBm)} = \text{Level (dBuV/m)} + 20\log(d) - 104.77$$
, where d is the distance at which field strength limit is specified in the rules
7. 
$$\text{Field Strength Level (dBm)} = \text{Spectrum Reading (dBm)} + \text{Antenna Factor} + \text{Cable Loss} + \text{Read Level} - \text{Preamp Factor}.$$
8. 
$$\text{ERP (dBm)} = \text{EIRP (dBm)} - 2.15$$
9. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.
10. The limit line is derived from  $43 + 10\log(P)\text{dB}$  below the transmitter power P(Watts)




