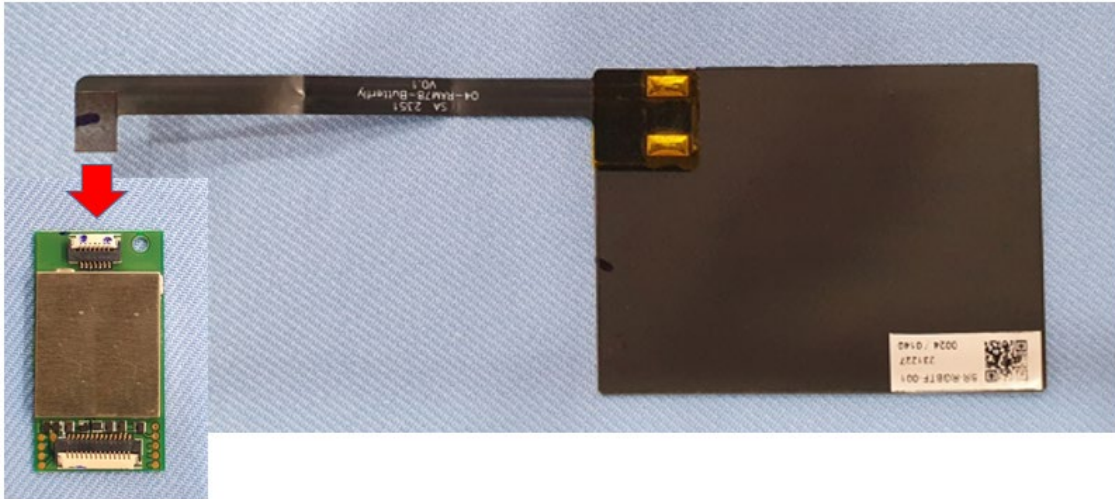


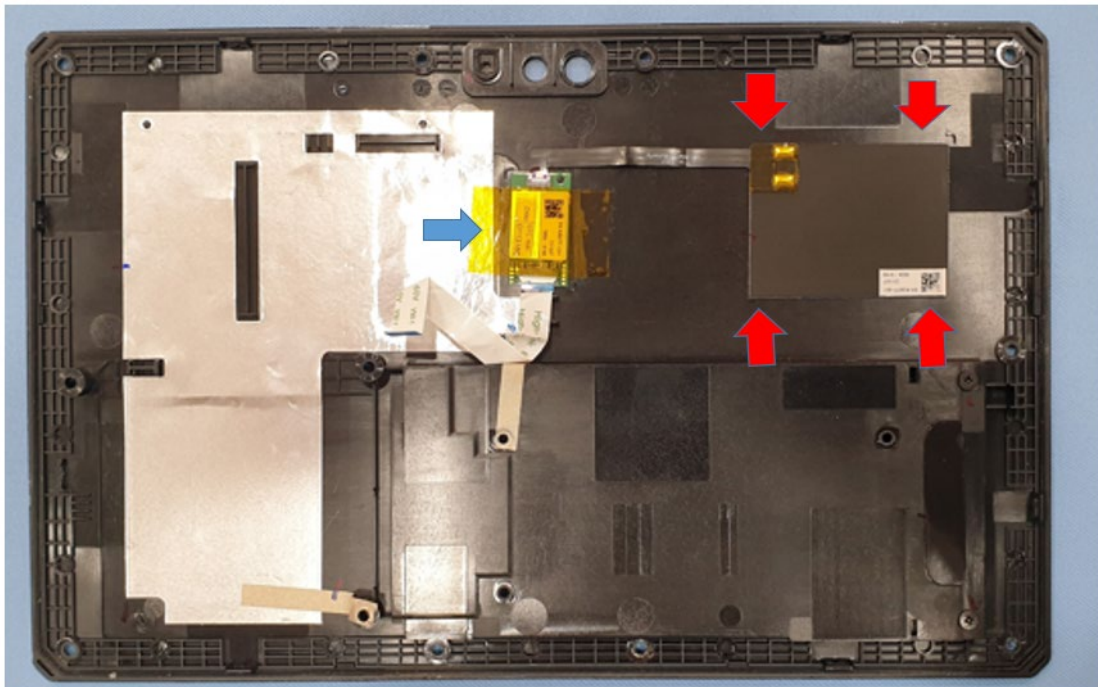
RFID installation manual

The detailed installation process is as follows :

1. Insert the gold finger ends of FPC at the connector



2. Fix the module + antenna on the back side of rear case with glue & yellow tape. Make sure the antenna is not bend and well attached



Federal Communication Commission Interference Statement

According to FCC Part 15 Subpart C Section 15.212, the radio elements of the modular transmitter must have their own shielding. However, due to there is no shielding for this module, this module is granted as a Limited Modular Approval. When this Module is installed into the end product, a Class II Permissive Change or a New FCC ID submission is required to ensure the full compliance of FCC relevant requirements.

This device is intended only for OEM integrators under the following conditions:

- 1) The transmitter module may not be co-located with any other transmitter or antenna. The co-transmitting with other radio will need a separate evaluation.
- 2) Module approval valid only when this module is installed in the tested host **ZX10, ZX10-Ex, ZX10G2, ZX10-210 , ZX10-220**".

As long as 2 conditions above are met, further transmitter test will not be required. However, the OEM integrator is still responsible for testing their end-product for any additional compliance requirements required with this module installed
