1. What is the FDA's role concerning the safety of wireless phones?

Under the law, the FDA does not review the safety of radiation-emitting consumer products such as wireless phones before they can be sold, as it does with new drugs or

er exists, ough the existing scientific data does not justify FDA regulatory actions, the FDA has urged the wireless phone industry to take a number of steps, including the following:

Support current and future research regarding possible biological effects of the type

of RF emitted by wireless phones;

2. Design wireless phones in a way that minimizes any RF exposure to the user that is not necessary for device function; and

3. Cooperate in providing users of wireless phones with complete and accurate information regarding possible effects of wireless phone use on human health and safety. The FDA belongs to an interagency working group of the federal agencies that have responsibility for different aspects of RF safety to ensure coordinated efforts at the federal level. The following agencies belong to this working group.

1. National institute for Occupational Safety and Health

2. Environmental Enritation Agency.

4. National Telecommunications and Information Administration
The National Institutes of Health participates in some interagency working group
activities as well. The FDA shares regulatory responsibilities for wireless phones with the Federal Communications Commission (FCC). All phones that are sold in the United States must comply with FCC safety guidelines that act to limit RF exposure. The FCC relies on the FDA and other health agencies for safety questions about wireless phones.
The FCC also regulates the base statons that the wireless phone networks rely upon.
While these base stations operate at higher power than do the wireless phones than the safety of the people get from these base stations are typically themselves. If the Federal well has been calculated and the safety questions are thus not the subject of the safety questions discussed in this document.

2. Do wireless phones pose a health hazard?

2. Do wireless phones pose a health hazard? Current scientific evidence does not show that any health problems are associated with using wireless phones. There is no proof, however, that wireless phones are absolutely safe, Wireless phones emit low levels of Radio Frequency (RF) energy while operating microvave ranges (which also emit very low levels of RF when they are in standby mode). While high levels of RF can produce health effects (by heating tissue), exposure to low-level RF that does not produce heating effects results in no known adverse health effects. Many studies of low-level RF exposures have not uncovered any biological effects. Although some studies have suggested that some biological effects may occur, such findings have not been confirmed by additional research. In some cases, other resear have had difficulty in reproducing those studies, and/or determining the reasons for

inconsistent results.

3. What are the results of the research done already?

The research conducted thus far has produced conflicting results, and many studies have suffered from flaws in their research methods. Animal experiments investigating the effects of Radio Frequency (RF) energy exposures characteristic of wireless phones have yielded conflicting results that often cannot be repeated in other laboratories. A few animal studies, however, have suggested that low levels of RF could accelerate the development of cancer in laboratory animals, However, many of the studies that showed increased tumor development used animals that had been genetically engineered or treated with cancer-causing chemicals so as to be pre-disposed to develop cancer in the absence of RF exposure. Other studies exposed the animals to RF for up to 22 hours per day. These conditions are not similar to the conditions under which people use wireless phones, so it is largely unknown what the results of such studies mean for human health and safety. Three large epidemiology studies have been published since December 2000. These studies investigated possible associations between the use of wireless phones and primary brain cancer (glioma, meningioma, acoustic neuroma, other brain tumors, and

salivary gland tumors), leukemia, or other types of cancer. None of the studies demonstrated the existence of any harmful health effects from wireless phone RF exposures. However, none of the studies can provide absolute findings about long-term exposures since the average period of phone use in these studies was approximately

Here the term "wireless phone" refers to handheld wireless phones with built-in antennas often called "Cell" or "mobile" phones. These types of wireless phones can expose the user to measurable Radio Frequency (RF) energy because of the short distance between the phone and the user's head. These RF exposures are limited by FCC safety guidelines that were developed with the advice of the FDA and other federal health and safety agencies. When the phone is located at greater distances from the user, the exposure to RF is drastically reduced due to a person's RF exposure rapidly decreasing with

5. What is the FDA doing to find out more about the possible health effects of wireless phone RF? The FDA is working with the U.S. National Toxicology Program and with groups of

The FDA is working with the U.S. National Toxicology Program and with groups of investigators around the world to ensure that high-priority animal studies are conducted to address concerns about the effects of exposure to Radio Frequency (RF) energy. The FDA has been a leading participant in the World Health Organization International Electro Magnetic Fields (EMF) Project since its inception in 1996, An influential result of this work has been the development of a detailed agenda of research needs that has implemented new research programs around the world. The project has also resulted in series of public information documents on EMF issues. The FDA and the Cellular Telecommunications & Internet Association (CTIA) have a formal Cooperative Research and Development Agreement (CRADA) to conduct research on wireless phone safety. Telecommunications & Internet Association (CTIA) have a formal Cooperative Research and Development Agreement (CRADA) to conduct research on wireless phone safety. The FDA provides the scientific oversight, obtaining input from experts in government, industry, and academic organizations. CTIA-funded research is conducted through contracts with independent investigators. The initial research will include both laboratory studies and studies of wireless phone users. The CRADA will also include a broad assessment of additional research needs in the context of the latest research

6. What research is needed to decide whether RF exposure from wireless phones poses a health risk?

a health risk?
A combination of laboratory studies and epidemiological studies of people actually using wireless phones would provide some of the vital data. Lifetime animal exposure studies could be completed in a few years. However, very large numbers of animals would be needed to provide reliable proof of a cancer-promoting effect, if one exists.
Epidemiological studies can provide data that is directly applicable to human Epidemiological studies can provide data that is directly applicable to human populations, but ten or more years of follow-up-research may be needed to provide answers about certain health effects, such as cancer. This is due to the interval between exposure time to a cancer-causing agent and the rate for which tumors develop—if they on. This could take several years into the future. The interpretation of epidemiological studies is hampered by difficulties in measuring actual RF exposure during day-to-day use of wireless phones, Many factors affect this measurement, such as the angle at which the plane is held, or which model of phone is held.

7. What has the FDA done to measure the Radio Frequency energy coming from

wireless phones?
The Institute of Electrical and Electronic Engineers (IEEE) is developing a technical The Institute of Electrical and Electronic Engineers (IEEE) is developing a technical standard for measuring the Radio Frequency (RF) energy exposure from wireless phones and other wireless handsets with the participation and leadership of FDA scientists and engineers. The standard, "Recommended Practice for Determining the Spatial-Peak Specific Absorption Rate (SAR) in the Human Body Due to Wireless Communications Devices: Experimental Techniques", sets forth the first consistent test methodology for measuring the rate at which RF is deposited in the heads of wireless phone users. The test method uses a tissue-simulating model of the human head. Standardized SAR test methodology is expected to greatly improve the consistency of measurements maddifferent laboratories on the same phone, SAR is the measurement of the amount of

energy absorbed in tissue, either by the whole body or a small part of the body. It is measured in watts/kg (or mill-watts/g) of matter. This measurement is used to determine whether a wireless phone complies with safety guidelines. 8. How can I find out how much Radio Frequency energy exposure I can get by using

8. How can I find out how much Radio Frequency energy exposure I can get by using my wireless phone?

All phones sold in the United States must comply with Federal Communications Commission (FCC) guidelines that limit Radio Frequency (RF) energy exposures. The FC established these guidelines in consultation with the FDA and the other federal health and safety agencies. The FCC limit for RF exposure from wireless phones is set at a Specific Absorption Rate (SAR) of 1.6 watts per kilogram (1,6W/kg), The FCC limit is consistent with the safety standards developed by the Institute of Electrical and Electronic Engineering (IEEE) and the National Council on Radiation Protection and Measurement. The exposure limit takes into consideration the body's ability to remove heat from the tissues that absorb energy from the wireless phone and is set well below levels known to have effects. Manufacturers of wireless phones must report the RF exposure level for each model of phone to the FCC.

The FCC website (http://www.rcc.gov/cgb/cglular.html) gives directions for locating the FCC identification number on your phone, so you can find your phone's RF exposure level in the online listing.

9. What about children using wireless phones?

Some groups sponsored by other national governments have advised that children be discouraged from using wireless phones at all. For example, the government in the United Kingdom distributed leaflest containing such a recommendation in December 2000. They noted that no evidence exists that using a wireless phone causes brain tumors or other ill effects. Their recommendation to limit wireless phone use by children was strictly precautionary, it was not based on scientific evidence that any health hazard exists.

10. What steps can I take to reduce my exposure to Radio Frequency energy from my

If there is a risk from these products- and at this point we do not know that there is - it is probably very small. But if you are concerned about avoiding even potential risks, you can take a few simple steps to minimize your exposure to Radio Frequency (RF) energy. Since time is a key factor in how much exposure a person receives, reducing the amount of time spent using a wireless phone will reduce RF exposure. 11. What about wireless phone interference with medical equipment

Electro Magnetic Interference (EMI) of implanted cardiac pacemakers and defibrillators from wireless telephones. The FDA has tested hearing aids for interference from handheld wireless phones and helped develop a voluntary standard sponsored by the Institute of Electrical and Electronic Engineers (IEEE). This standard specifies test methods and performance requirements for hearing aids and wireless phones so that no interference occurs when a person uses a compatible phone and a compatible hearing aid simultaneously.
