Hi Y.K. :

Please address the following issues:

Question #1: Based upon the technical specification as described in the user manual, this handheld terminal is equipped with WLAN radio and CDMA radio. As indicated in the proposed ID label format, the FCC ID number for CDMA radio is P4M-DTEVDUAL. By checking this CDMA FCC ID number on FCC web site, CDMA radio was not approved as module and require 20cm separation distance to the body of user and the max. antenna gain allowed is 1 dBi. There is no approval information for WLAN radio so condition of WLAN approval can not be verified. Please confirm the following:

1. While doing FCC Part 15B tests, the CDMA module was installed but not activated.

[YG] Yes, you are correct.

2. The EUT tested does not contain WLAN radio.

[YG] Yes, that's correct.

3. This approval under above subject FCC ID number is limited to PC peripheral technical requirements.

[YG] Yes, you are correct.

4. You have been advised CDMA radio approval condition and aware this approval does not cover CDMA or WLAN portion of approval.

[YG] Yes, you are correct.

Question #2: Please provide AC line conducted test data. This device is shipped with AC adapter.

Question #3: Please provide revised user manual to include section 15.21, 15.19(a) (3) and 15.105(b) statement.
