



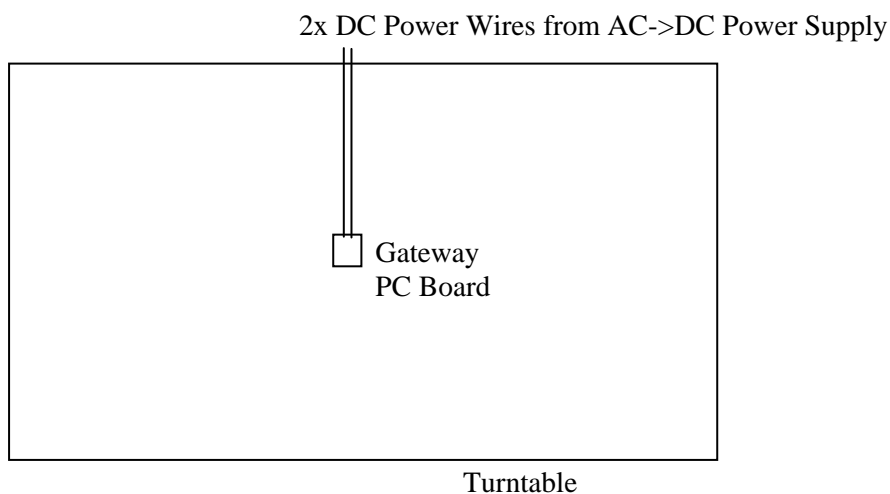

3.0 Sample Calculations

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any) from the measured reading. The basic equation with a sample calculation is as follows:

$$FS = RA + AF + CF - AG$$

Where

- FS = Field Strength in dB μ V/m
- RA = Receiver Amplitude (including preamplifier) in dB μ V
- CF = Cable Attenuation Factor in dB
- AF = Antenna Factor in dB
- AG = Amplifier Gain in dB

In the following table(s), the reading shown on the data table reflects the preamplifier gain. An example for the calculations in the following table is as follows.

Assume a receiver reading of 52.0 dB μ V is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB is added. The amplifier gain of 29 dB is subtracted, giving a field strength of 32 dB μ V/m. This value in dB μ V/m was converted to its corresponding level in μ V/m.

$$\begin{aligned} RA &= 52.0 \text{ dB}\mu\text{V} \\ AF &= 7.4 \text{ dB/m} \\ CF &= 1.6 \text{ dB} \\ AG &= 29.0 \text{ dB} \\ FS &= 32 \text{ dB}\mu\text{V/m} \end{aligned}$$

$$\text{Level in } \mu\text{V/m} = [10(32 \text{ dB}\mu\text{V/m})/20] = 39.8 \mu\text{V/m}$$

The following is how net line-conducted readings were determined:

$$NF = RF + LF + CF + AF$$

Where

- NF = Net Reading in dB μ V
- RF = Reading from receiver in dB μ V
- LF = LISN Correction Factor in dB
- CF = Cable Correction Factor in dB
- AF = Attenuator Loss Factor in dB

To convert from dB μ V to μ V or mV the following was used:

$$UF = 10^{(NF/20)} \text{ where } UF = \text{Net Reading in } \mu\text{V}$$

3.1 Measurement Uncertainty

Compliance of the product is based on the measured value. However, the measurement uncertainty is included for informational purposes.

3.2 Site Description

Test Site(s): 2

Our OATS are 3m and 10m sheltered emissions measurement ranges located in a light commercial environment in Boxborough, Massachusetts. They meet the technical requirements of ANSI C63.4-2003 and CISPR 22:1993/EN 55022:1994 for radiated and conducted emission measurements. The shelter structure is entirely fiberglass and plastic, with outside dimensions of 33 ft x 57 ft. The structure resembles a quonset hut with a center ceiling height of 16.5 ft.

The testing floor is covered by a galvanized sheet metal groundplane that is earth-grounded via copper rods around the perimeter of the site. The joints between individual metal sheets are bridged with a 2 inch wide metal strips to provide low RF impedance contact throughout. The sheets are screwed in place with stainless steel, round-head screws every three inches. Site illumination and HVAC are provided from beneath the ground reference plane through flush entry ports, the port covers are electrically bonded to the ground plane.

A flush metal turntable with 12 ft. diameter and 5000 lb. load capacity (12,000 lb. in Site 3) is provided for floor-standing equipment. A wooden table 80 cm high is used for table-top equipment. The turntable is electrically connected to the ground plane with three copper straps. The straps are connected to the turntable at the center of it with ground braid. The copper strap is directly connected to the groundplane at the edges of the turntable. The turntable is located on the south end of the structure and the antennas are mounted 3 and 10 meters away to the north. The antenna mast is a non-conductive with remote control of antenna height and polarization. The antenna height is adjustable from 1 to 4 meters.

All final radiated emission measurements are performed with the testing personnel and measurement equipment located below the ground reference plane. The site has a full basement underneath the turntable where support equipment may be remotely located. Operation of the antenna, turntable and equipment under test is controlled by remote controls that manipulate the antenna height and polarization and with a turntable control. Test personnel are located below the ellipse when measurements are performed, however the site maintains the ability of having personnel manipulate cables while monitoring test equipment. Ambient radiated emissions are 6 dB or more below the relevant FCC emission limits.

AC mains power is brought to the equipment under test through a power line filter, to remove ambient conducted noise. 50 Hz (240 VAC single phase), 60 Hz power (120 VAC single phase, 208 VAC three phase), and 60 Hz (480 VAC three phase) are available. Conducted emission measurements are performed with a Line Impedance Stabilization Network (LISN) or Artificial Mains Network (AMN) bonded to the ground reference plane. A removable vertical groundplane (2 meter X 2 meter area) is used for line-conducted measurements for table top equipment. The vertical groundplane is electrically connected to the reference groundplane.

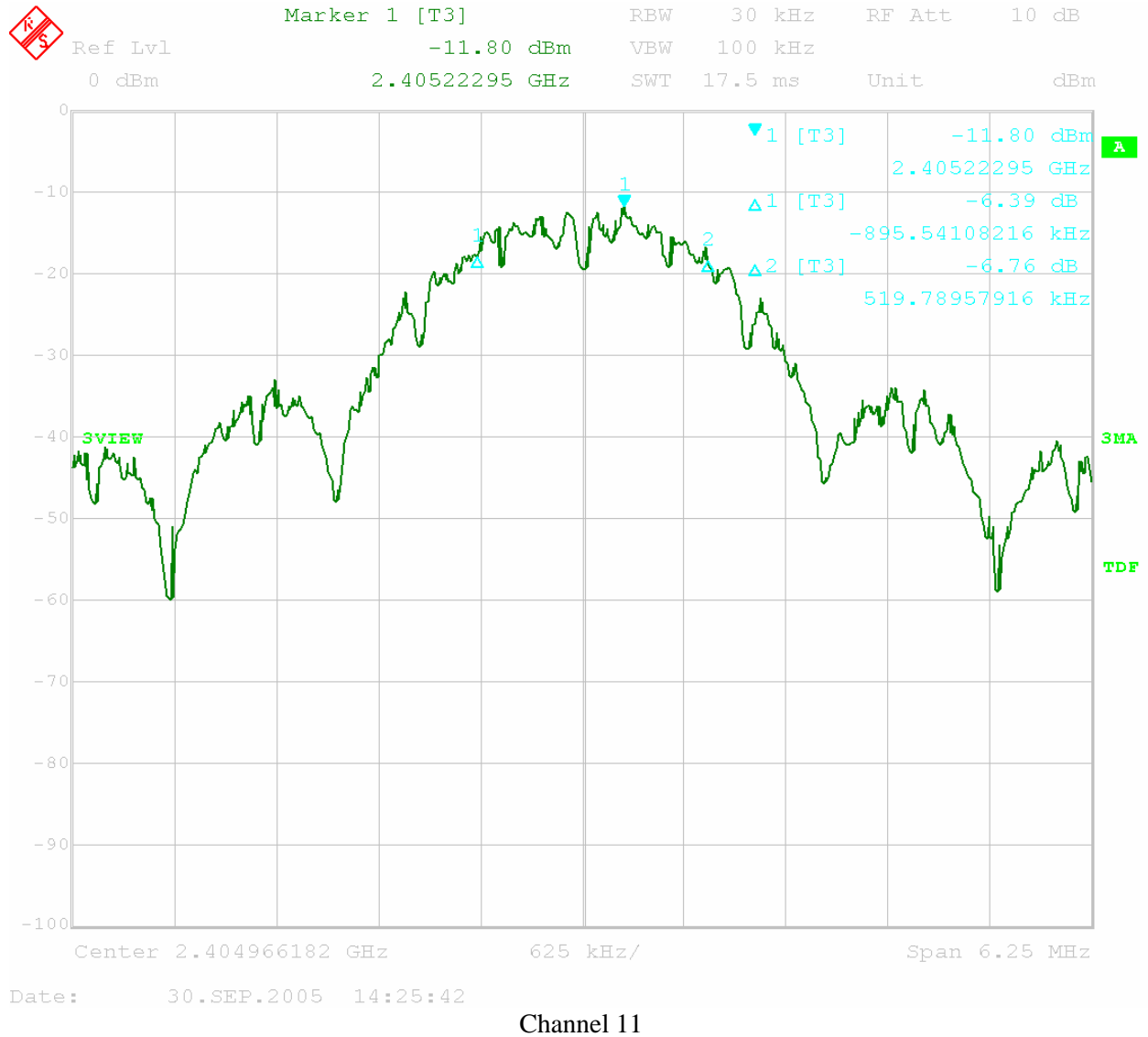
The EMC Lab has two Semi-anechoic Chambers and one Shielded Chamber. AC Mains Power is available at 120, 230, and 277 Single Phase; 208, 400, and 480 3-Phase. Large reference groundplanes are installed in the general lab area to facilitate EMC work not requiring a shielded environment.

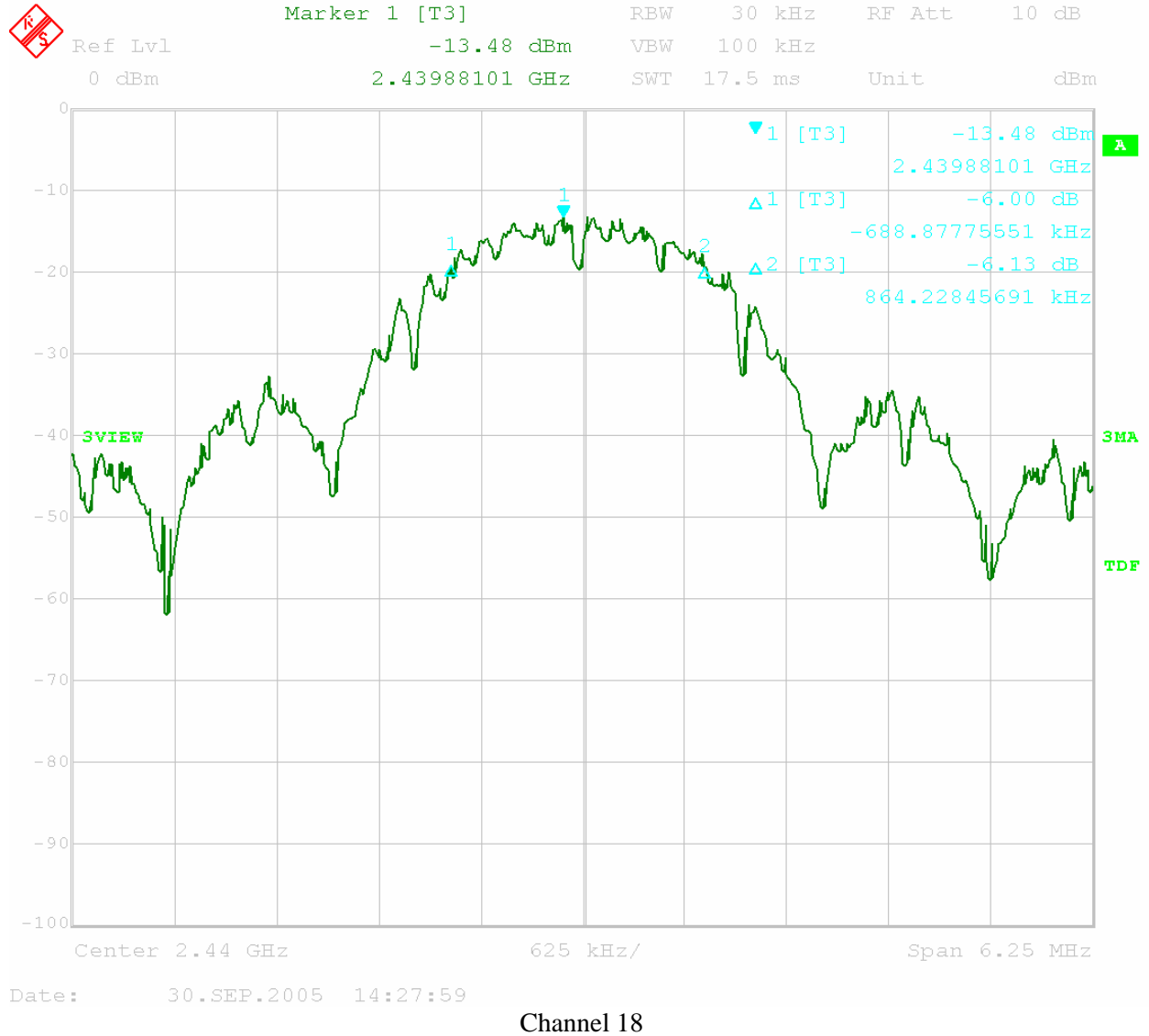

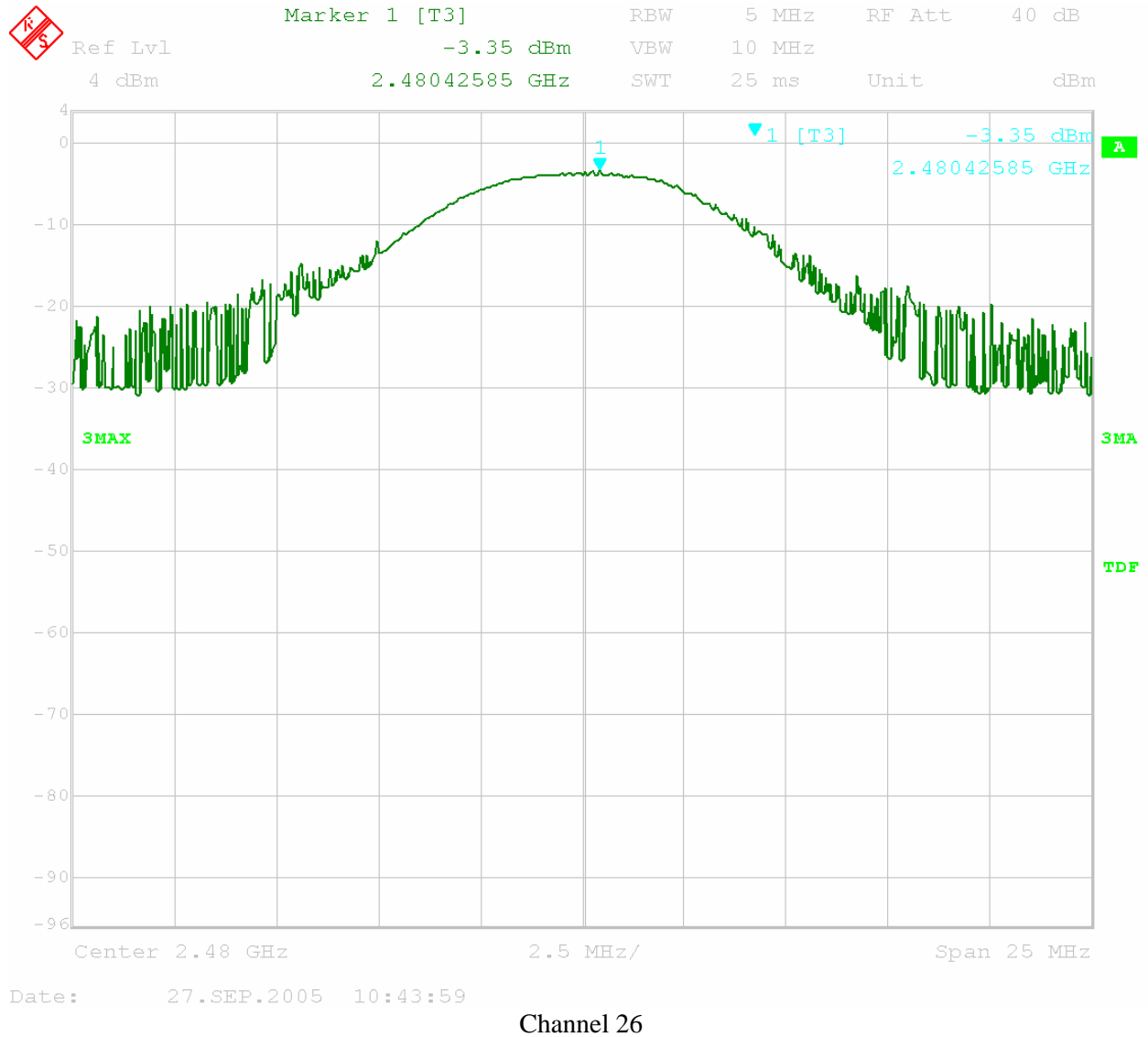
The human RF exposure limit is 1 mW/cm². The power density S generated by some value of EIRP at a given distance d is related by the equation:

$$S = \text{EIRP} / (4\pi d^2)$$

The distance, given a maximum EIRP of 2.65 dBm (1.85 mW) at which the radiated power density of the EUT is equal to the human RF exposure limit is 0.38 cm from the antenna.
