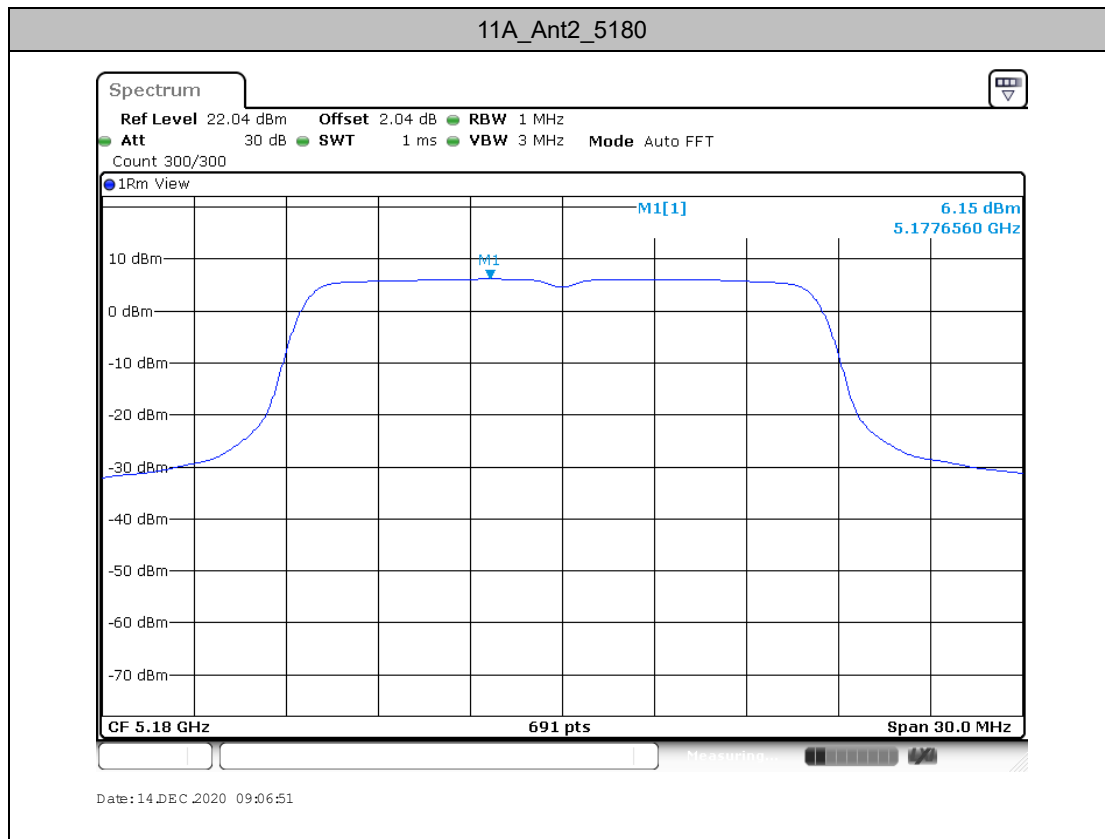




Maximum power spectral density
