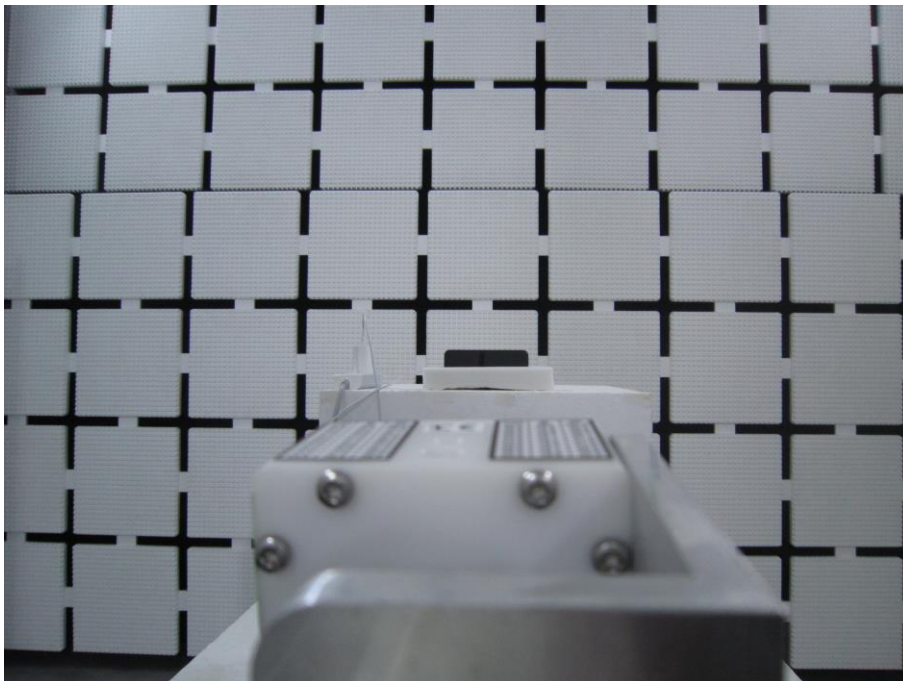

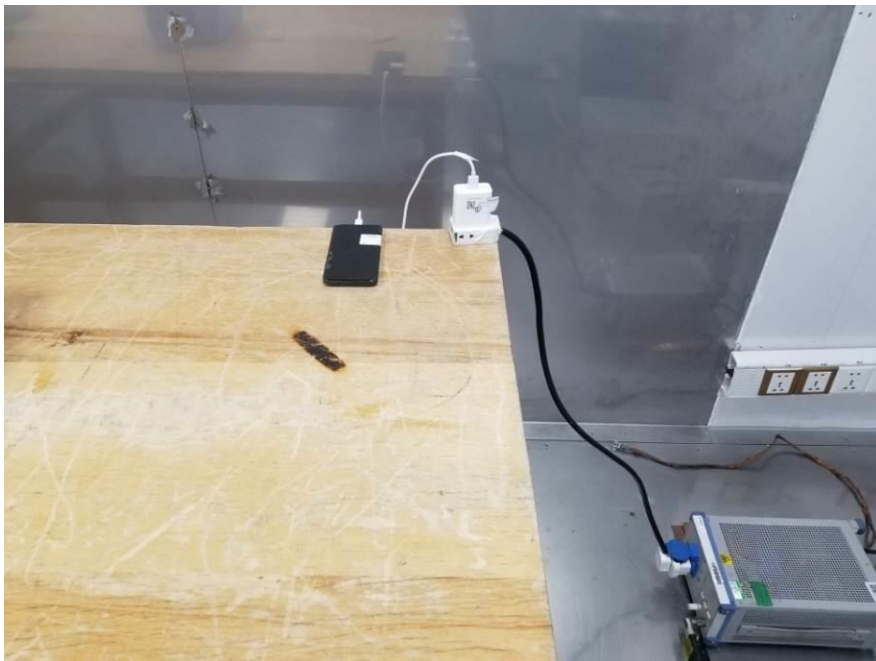
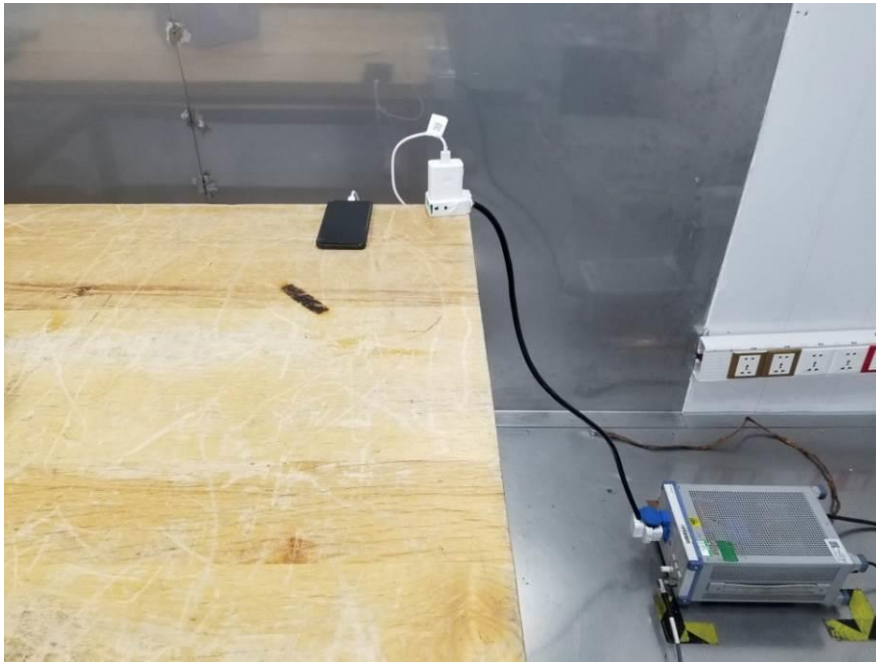

#### Conducted Emissions at Mains Terminals (150kHz-30MHz)

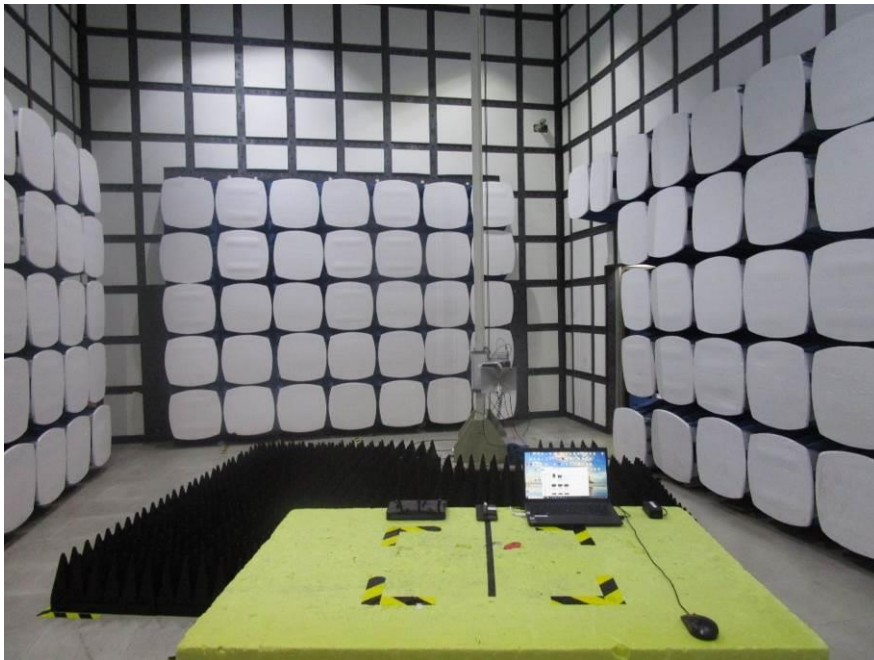
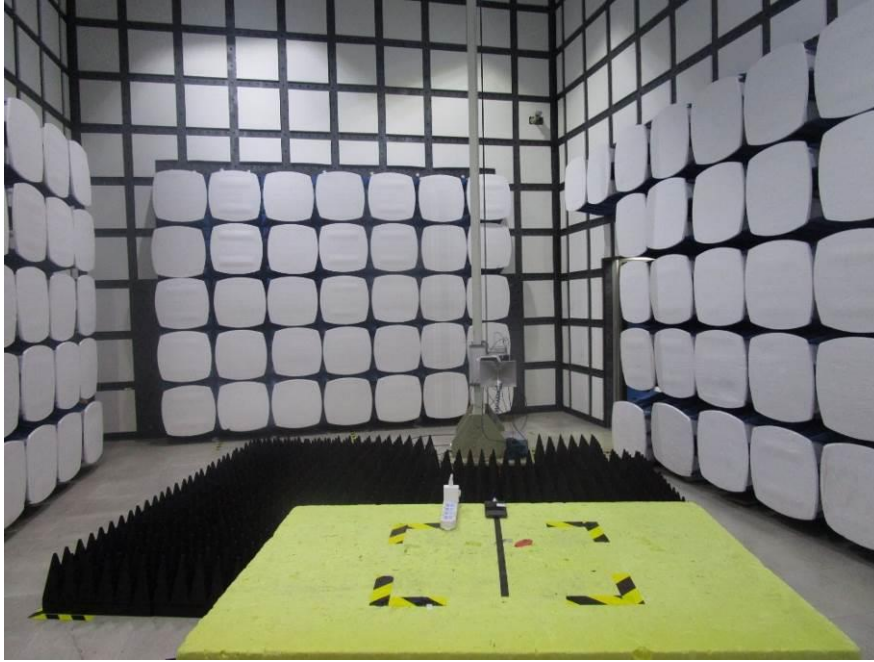




### Radiated Emissions (30MHz-1GHz)

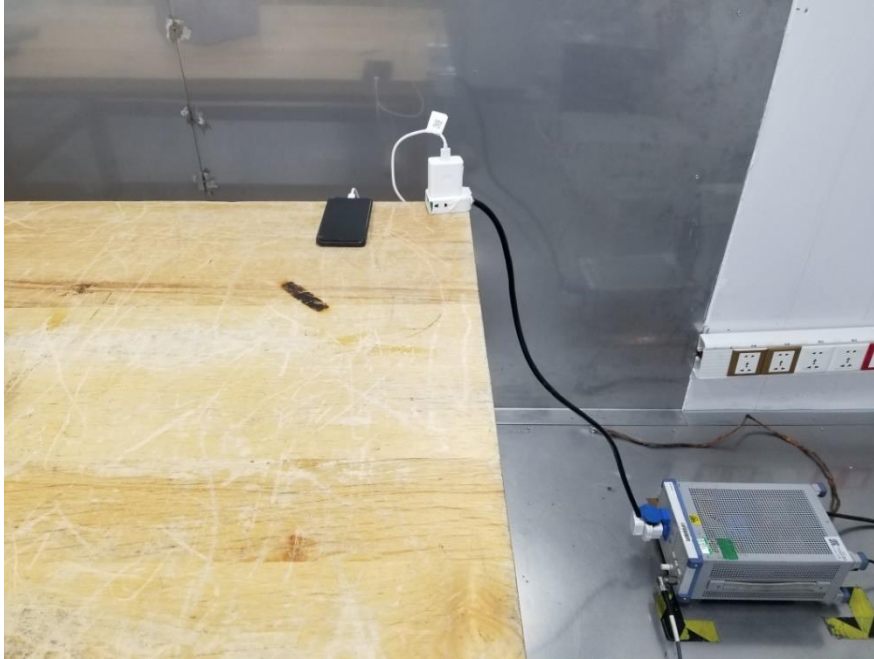


### Radiated Emissions (Above 1GHz)

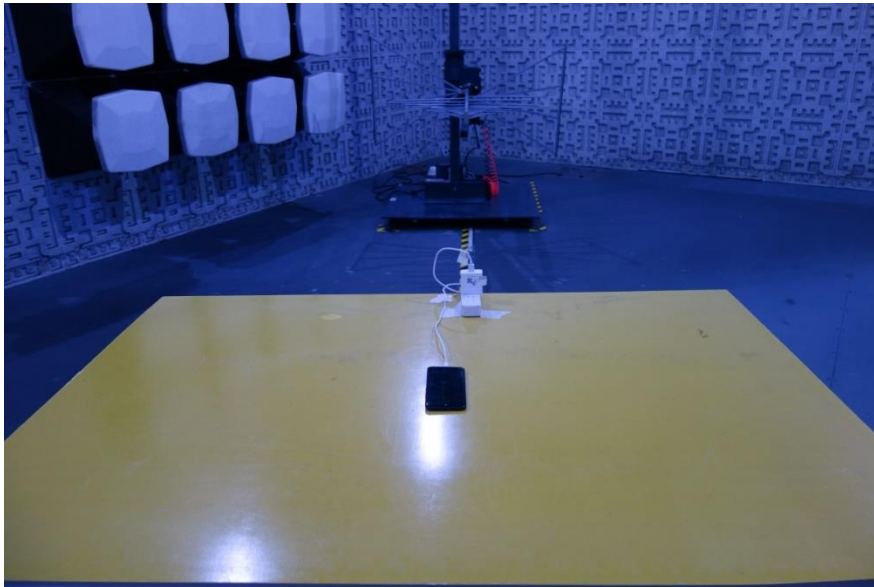

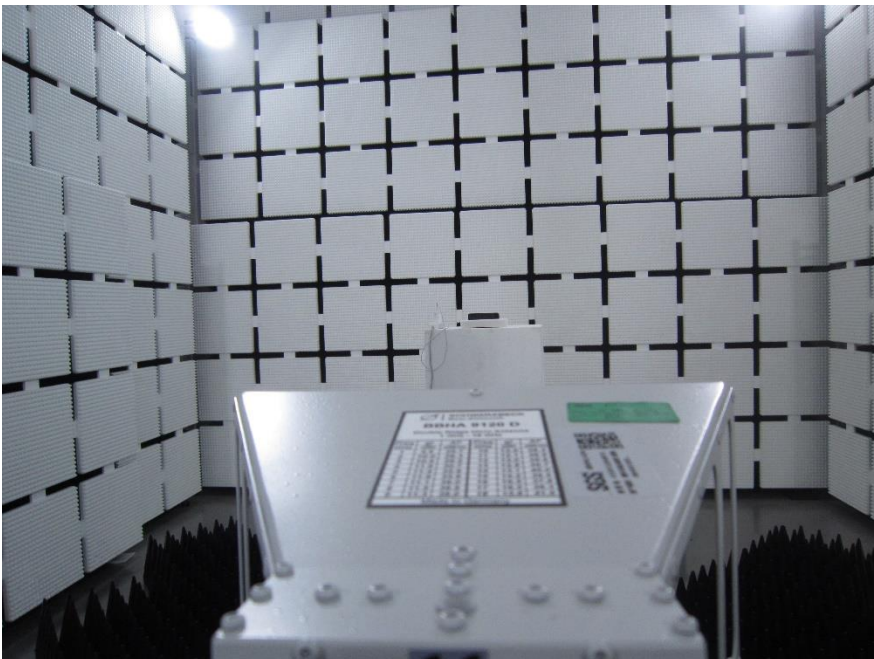

### Radiated Emissions which fall in the restricted bands



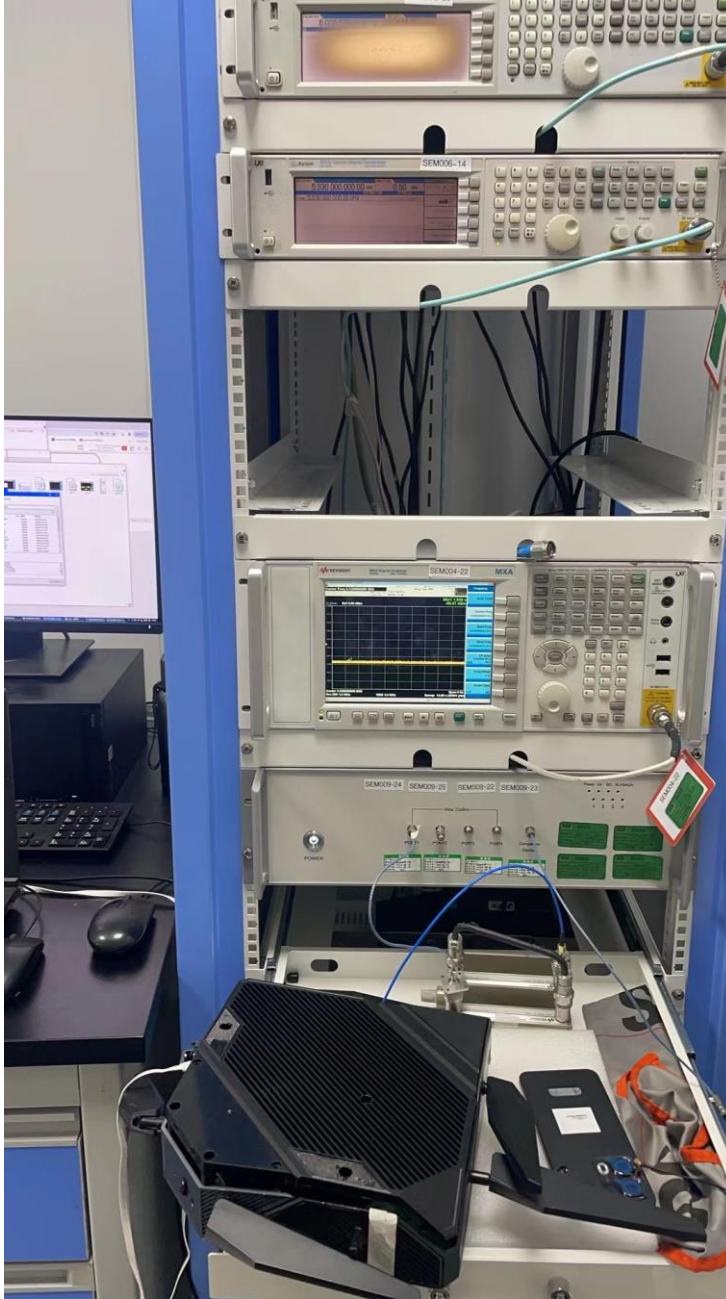

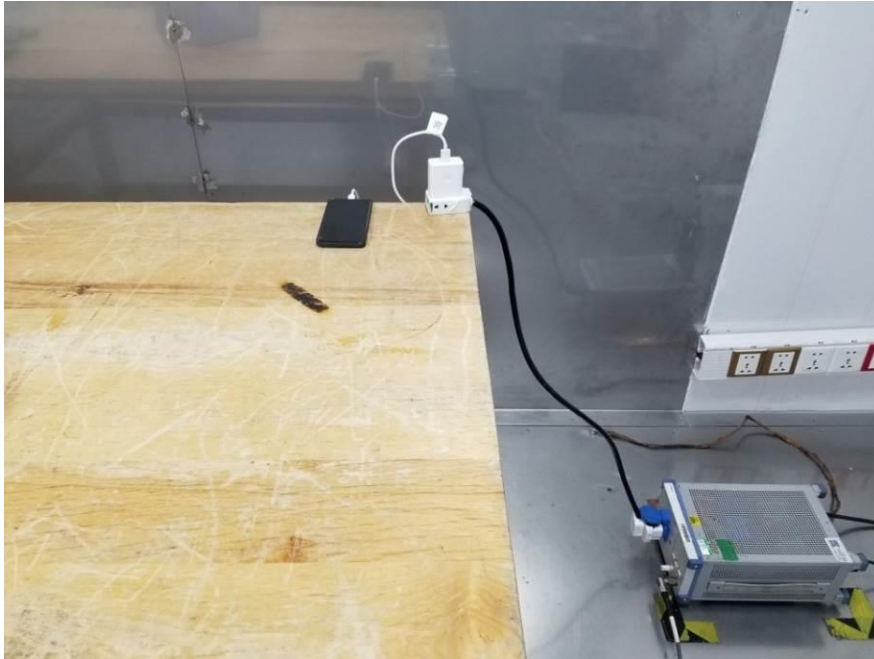

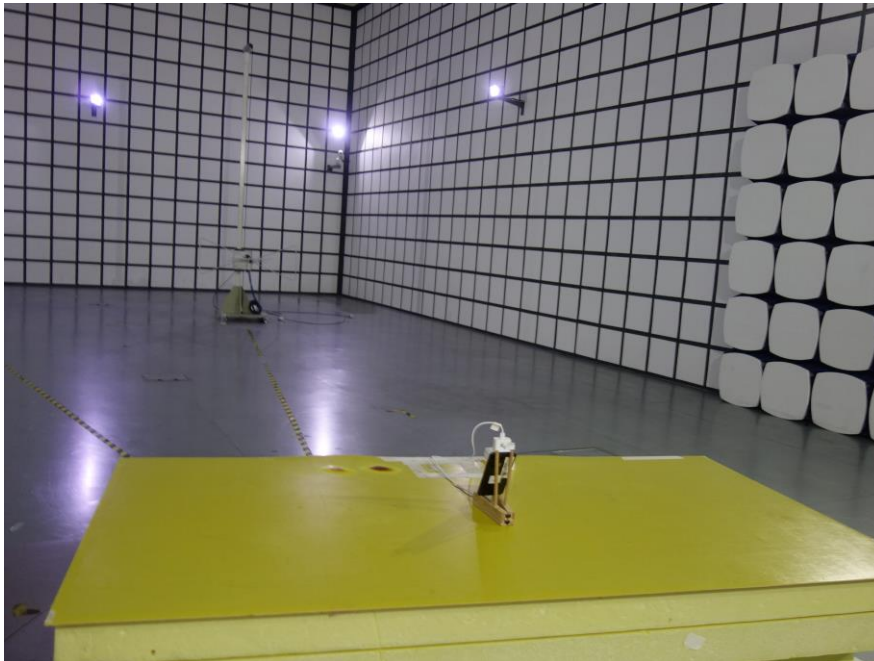
