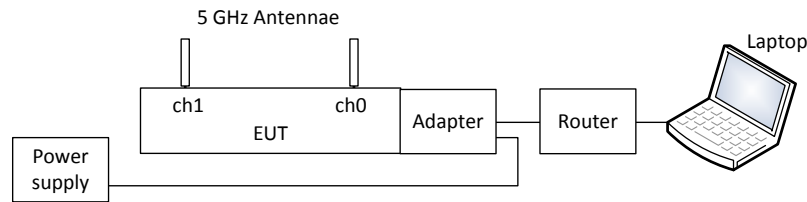


Figure 3.6-1: Setup diagram

## Section 8. Testing data

### 8.1 FCC 15.207(a) and RSS-Gen 7.2.4 AC power line conducted emissions limits

#### 8.1.1 Definitions and limits

**FCC:**

Except as shown in paragraphs (b) and (c) of this section, for an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30 MHz, shall not exceed the limits in the following table, as measured using a 50  $\mu$ H/50  $\Omega$  line impedance stabilization network (LISN). Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower limit applies at the boundary between the frequency ranges.

**IC:**

The purpose of this test is to measure unwanted radio frequency currents induced in any AC conductor external to the equipment which could conduct interference to other equipment via the AC electrical network.

Except when the requirements applicable to a given device state otherwise, for any licence-exempt radiocommunication device equipped to operate from the public utility AC power supply, either directly or indirectly, the radio frequency voltage that is conducted back onto the AC power lines in the frequency range of 0.15 MHz to 30 MHz shall not exceed the limits shown in Table 2. The tighter limit applies at the frequency range boundaries.

The conducted emissions shall be measured with a 50  $\Omega$ /50  $\mu$ H line impedance stabilization network (LISN).

### 8.1.3 Observations, settings and special notes

---

The EUT was set up as tabletop configuration.

The spectral scan has been corrected with transducer factors (i.e. cable loss, LISN factors, and attenuators) for determination of compliance.

A preview measurement was generated with the receiver in continuous scan mode. Emissions detected within 6 dB or above limit were re-measured with the appropriate detector against the correlating limit and recorded as the final measurement.

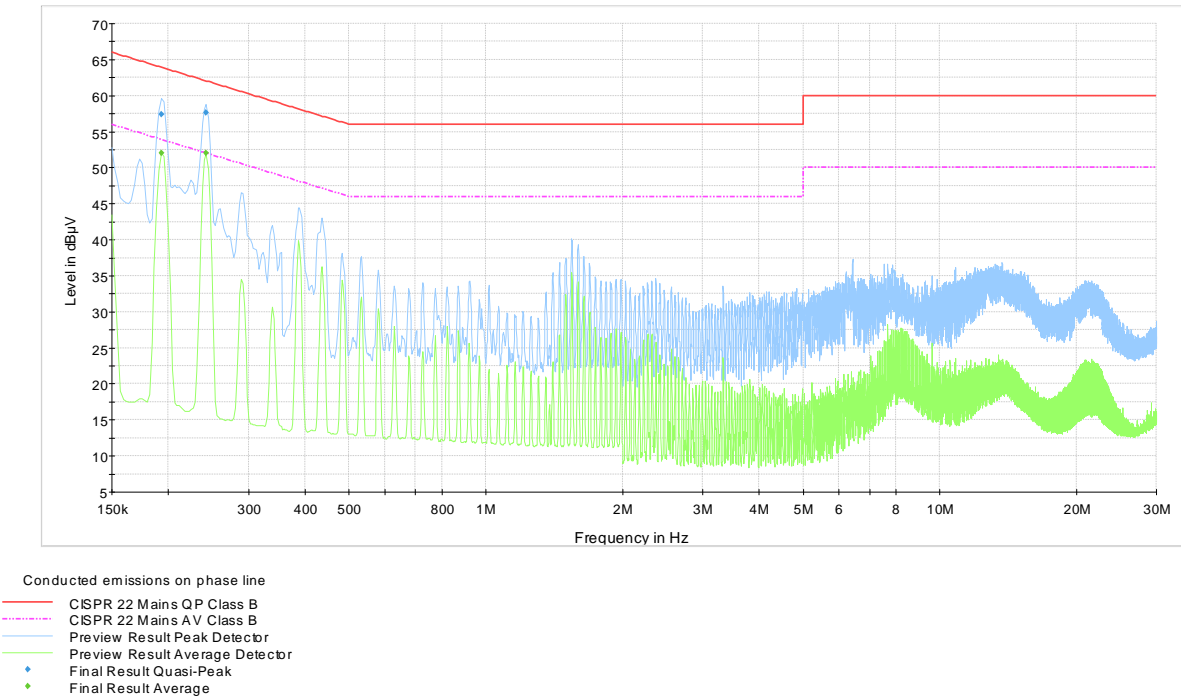

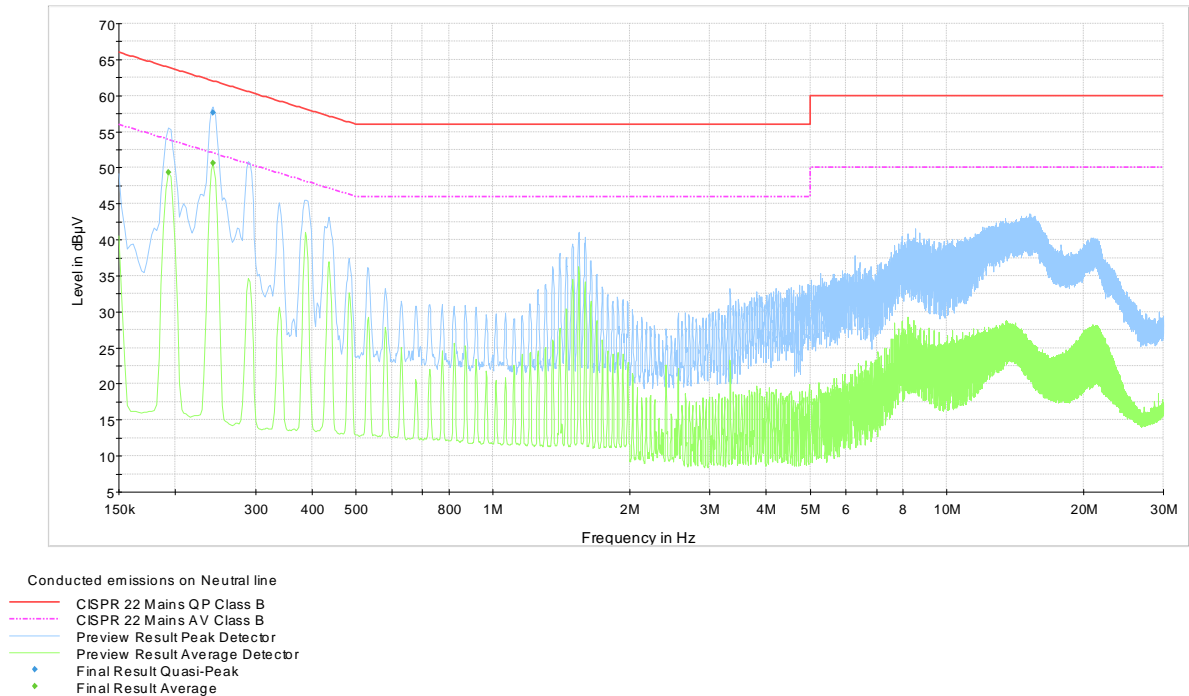

## 8.2 FCC 15.403(i) Emission bandwidth

### 8.2.1 Definitions and limits

For purposes of this subpart the emission bandwidth shall be determined by measuring the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, that are 26 dB down relative to the maximum level of the modulated carrier. Determination of the emissions bandwidth is based on the use of measurement instrumentation employing a peak detector function with an instrument resolution bandwidth approximately equal to 1.0 percent of the emission bandwidth of the device under measurement.

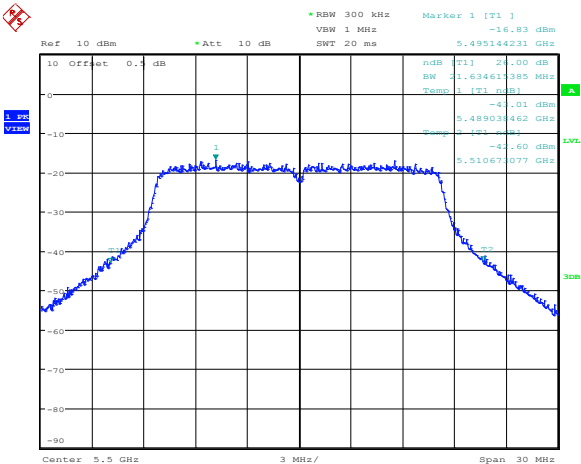

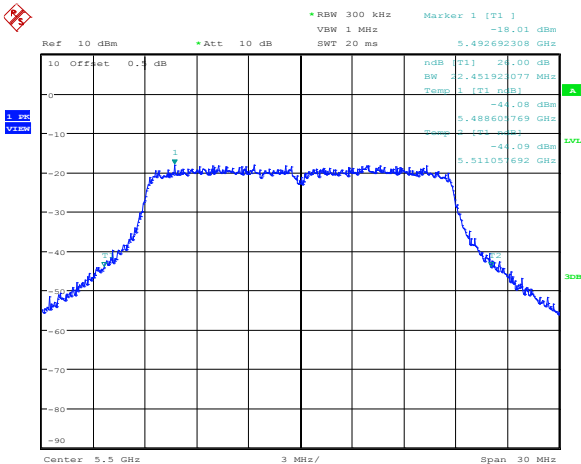

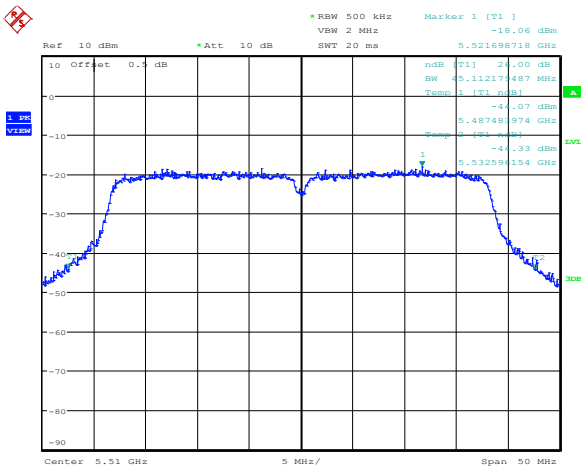

### 8.3 RSS-Gen 4.6.1 Occupied bandwidth

#### 8.3.1 Definitions and limits

When an occupied bandwidth value is not specified in the applicable RSS, the transmitted signal bandwidth to be reported is to be its 99 percent emission bandwidth, as calculated or measured.

The transmitter shall be operated at its maximum carrier power measured under normal test conditions.

The span of the analyzer shall be set to capture all products of the modulation process, including the emission skirts. The resolution bandwidth shall be set to as close to 1 percent of the selected span as is possible without being below 1 percent. The video bandwidth shall be set to 3 times the resolution bandwidth. Video averaging is not permitted. Where practical, a sampling detector shall be used since a peak or, peak hold, may produce a wider bandwidth than actual.

The trace data points are recovered and are directly summed in linear terms. The recovered amplitude data points, beginning at the lowest frequency, are placed in a running sum until 0.5 percent of the total is reached and that frequency recorded. The process is repeated for the highest frequency data points. This frequency is recorded.

The span between the two recorded frequencies is the occupied bandwidth.

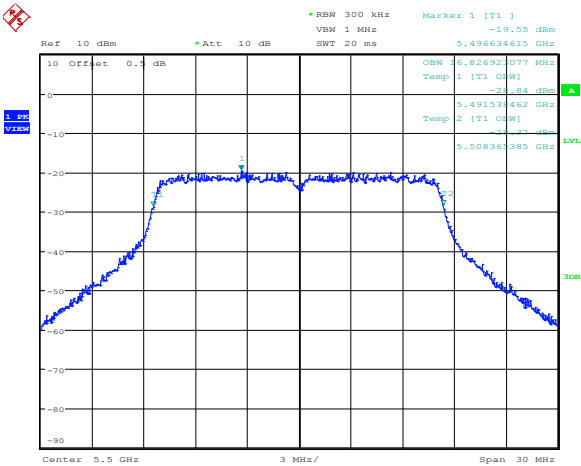

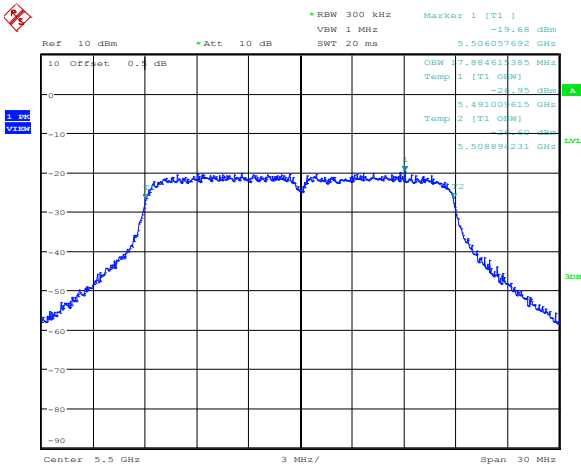

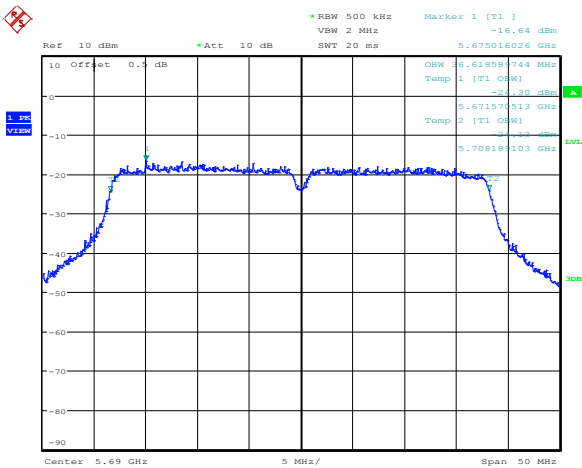

## 8.4 FCC 15.407(a)(2) and RSS-210 A9.2(3) 5.47–5.725 GHz band output power, EIRP and spectral density limits

### 8.4.1 Definitions and limits

#### FCC:

For the 5.25–5.35 GHz and 5.47–5.725 GHz bands, the maximum conducted output power over the frequency bands of operation shall not exceed the lesser of 250 mW (24 dBm) or  $11 \text{ dBm} + 10 \log_{10}(B)$ , where B is the 26 dB emission bandwidth in megahertz. In addition, the peak power spectral density shall not exceed 11 dBm in any 1 MHz band. If transmitting antennas of directional gain greater than 6 dBi are used, both the maximum conducted output power and the peak power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

The maximum conducted output power must be measured over any interval of continuous transmission using instrumentation calibrated in terms of an rms-equivalent voltage. The measurement results shall be properly adjusted for any instrument limitations, such as detector response times, limited resolution bandwidth capability when compared to the emission bandwidth, sensitivity, etc., so as to obtain a true peak measurement conforming to the above definitions for the emission in question.

The peak power spectral density is measured as a conducted emission by direct connection of a calibrated test instrument to the equipment under test. If the device cannot be connected directly, alternative techniques acceptable to the Commission may be used. Measurements are made over a bandwidth of 1 MHz or the 26 dB emission bandwidth of the device, whichever is less. A resolution bandwidth less than the measurement bandwidth can be used, provided that the measured power is integrated to show total power over the measurement bandwidth. If the resolution bandwidth is approximately equal to the measurement bandwidth, and much less than the emission bandwidth of the equipment under test, the measured results shall be corrected to account for any difference between the resolution bandwidth of the test instrument and its actual noise bandwidth.

(h)(1) Transmit power control (TPC). U-NII devices operating in the 5.25–5.35 GHz band and the 5.47–5.725 GHz band shall employ a TPC mechanism. The U-NII device is required to have the capability to operate at least 6 dB below the mean EIRP value of 30 dBm. A TPC mechanism is not required for systems with an e.i.r.p. of less than 500 mW (27 dBm).

#### IC:

The maximum conducted output power shall not exceed 250 mW (24 dBm) or  $11 + 10 \times \log_{10}(B)$ , dBm, whichever power is less. The power spectral density shall not exceed 11 dBm in any 1 MHz band. The maximum e.i.r.p. shall not exceed 1 W (30 dBm) or  $17 + 10 \times \log_{10}(B)$ , dBm, whichever power is less. B is the 99% emission bandwidth in MHz. Note that devices with a maximum e.i.r.p. greater than 500 mW (27 dBm) shall implement TPC in order to have the capability to operate at least 6 dB below the maximum permitted e.i.r.p. of 1 W (30 dBm).

**Note:** For the band 5600–5650 MHz, no operation is permitted. Until further notice, devices subject to this annex shall not be capable of transmitting in the band 5600–5650 MHz. This restriction is for the protection of Environment Canada weather radars operating in this band.

Directional gain for cross-polarized MIMO 2 × 2 is 7.2 dBi. No summation of gain is needed for cross-polarized antennas as per manufacturer's definition of the cross-polarized MIMO type.

FCC PPSD limit was calculated as follows:  $11 - (7.2 - 6) = 9.8 \text{ dBm/MHz}$

The 99 % measured occupied bandwidth for 802.11a was 16.83 MHz, for 802.11n HT20 was 17.89 MHz and for 802.11n HT40 was 36.62 MHz.

IC output power limit for 802.11a was calculated as follows:  $11 + 10 \times \log_{10} (16.83) = 23.26 \text{ dBm} < 24 \text{ dBm}$

IC output power limit for 802.11n HT20 was calculated as follows:  $11 + 10 \times \log_{10} (17.89) = 23.53 \text{ dBm} < 24 \text{ dBm}$

IC output power limit for 802.11n HT40 was calculated as follows:  $11 + 10 \times \log_{10} (36.62) = 26.63 \text{ dBm} > 24 \text{ dBm}$

## 8.5 FCC 15.407(b) and RSS-210 A9.2(3) Spurious (out-of-band) emissions

### 8.5.1 Definitions and limits

#### FCC:

- (3) For transmitters operating in the 5.47–5.725 GHz band: all emissions outside of the 5.47–5.725 GHz band shall not exceed an EIRP of –27 dBm/MHz.
- (5) The emission measurements shall be performed using a minimum resolution bandwidth of 1 MHz. A lower resolution bandwidth may be employed near the band edge, when necessary, provided the measured energy is integrated to show the total power over 1 MHz.
- (6) Unwanted emissions below 1 GHz must comply with the general field strength limits set forth in § 15.209.
- (7) The provisions of § 15.205 apply to intentional radiators operating under this section.
- (8) When measuring the emission limits, the nominal carrier frequency shall be adjusted as close to the upper and lower frequency block edges as the design of the equipment permits.

#### IC:

Emissions outside the band 5470–5725 MHz shall not exceed –27 dBm/MHz e.i.r.p.

#### RSS-Gen 7.2.2 Emissions falling within restricted frequency bands

Restricted bands, identified in below, are designated primarily for safety-of-life services (distress calling and certain aeronautical bands), certain satellite downlinks, radio astronomy and some government uses. Except where otherwise indicated, the following restrictions apply:

- (a) fundamental components of modulation of licence-exempt radio apparatus shall not fall within the restricted bands of below;
- (b) unwanted emissions falling into restricted bands of below shall comply with the limits specified in RSS-Gen;
- (c) unwanted emissions not falling within restricted frequency bands shall either comply with the limits specified in the applicable RSS, or with those specified in RSS-Gen.

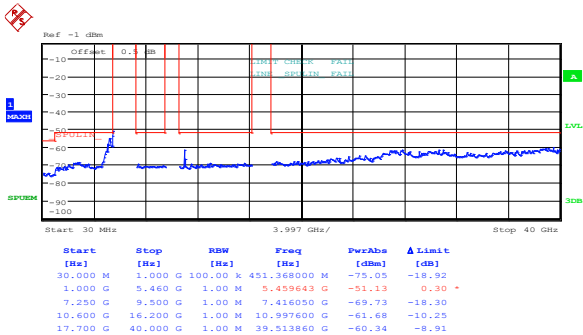


Figure 8.5-1: Peak spurious emissions within restricted bands at FCC low channel, 802.11a, cho

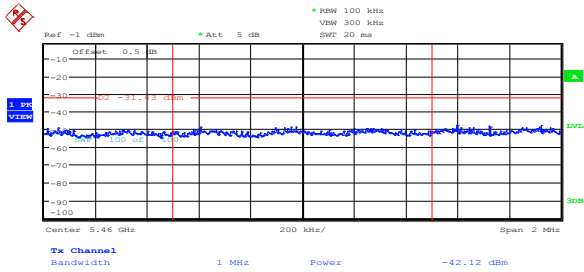


Figure 8.5-2: Peak spurious emission at 5.46 GHz on FCC high channel, 802.11a, cho

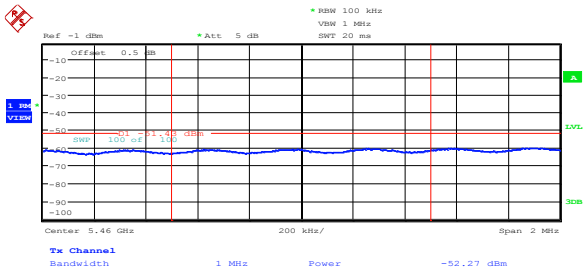


Figure 8.5-3: Average spurious emission at 5.46 GHz on FCC high channel, 802.11a, cho

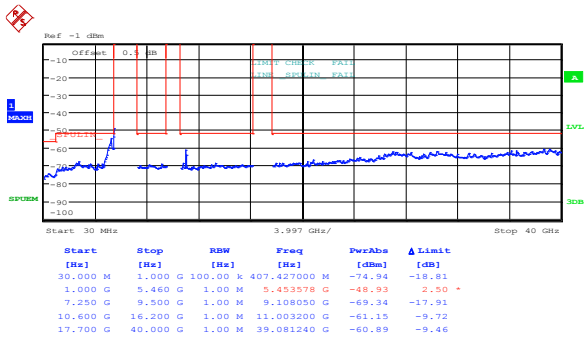


Figure 8.5-4: Peak spurious emissions within restricted bands at FCC low channel, 802.11n HT20, cho

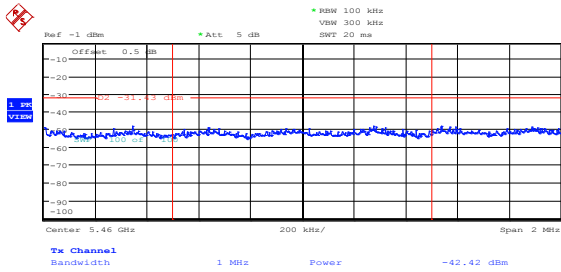


Figure 8.5-5: Peak spurious emission at 5.46 GHz on FCC high channel, 802.11n HT20, cho

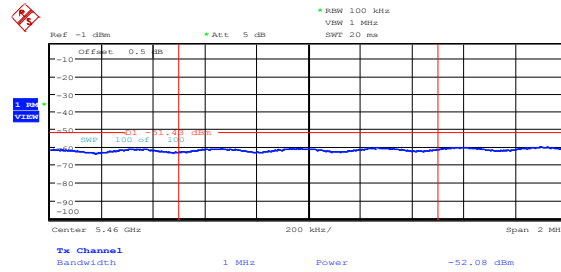


Figure 8.5-6: Average spurious emission at 5.46 GHz on FCC high channel, 802.11n HT20, cho

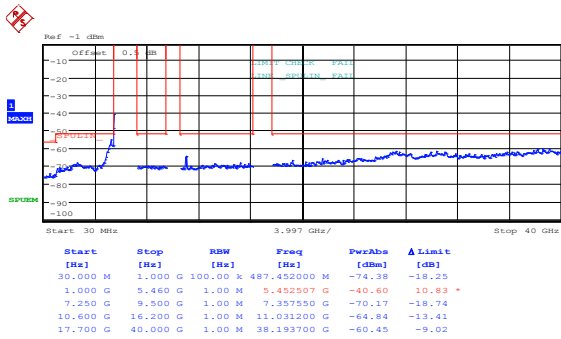


Figure 8.5-7: Peak spurious emissions within restricted bands at FCC low channel, 802.11n HT40, cho

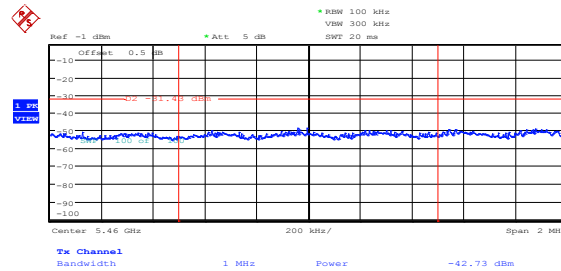


Figure 8.5-8: Peak spurious emission at 5.46 GHz on FCC low channel, 802.11n HT40, cho

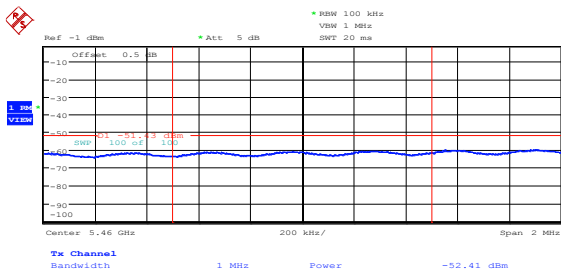


Figure 8.5-9: Average spurious emission at 5.46 GHz on FCC low channel, 802.11n HT40, cho

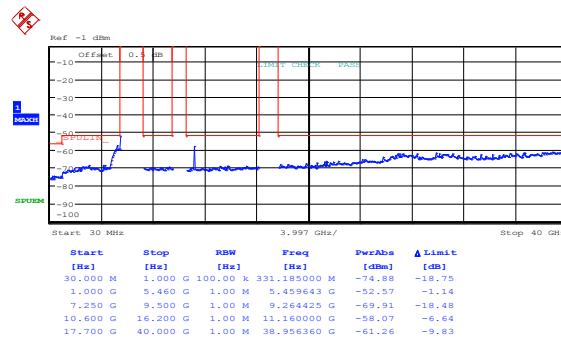


Figure 8.5-10: Peak spurious emissions within restricted bands at FCC mid channel, 802.11a, cho

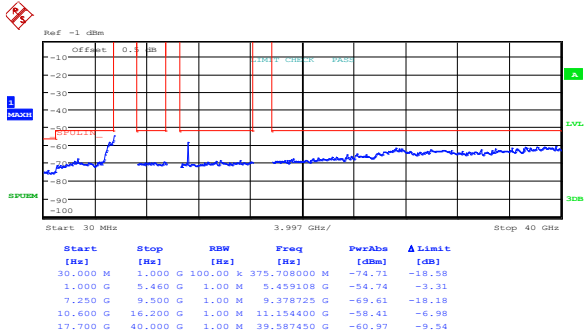


Figure 8.5-11: Peak spurious emissions within restricted bands at FCC mid channel, 802.11n HT20, cho

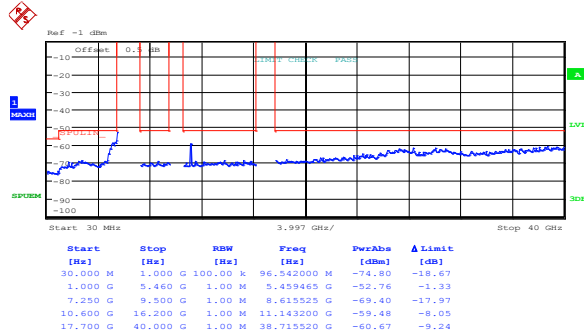


Figure 8.5-12: Peak spurious emissions within restricted bands at FCC mid channel, 802.11n HT40, cho

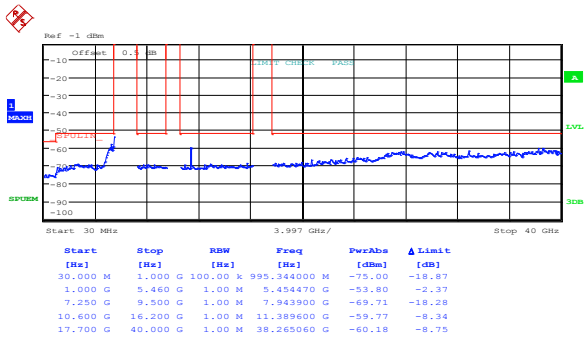


Figure 8.5-13: Peak spurious emissions within restricted bands at FCC high channel, 802.11a, cho

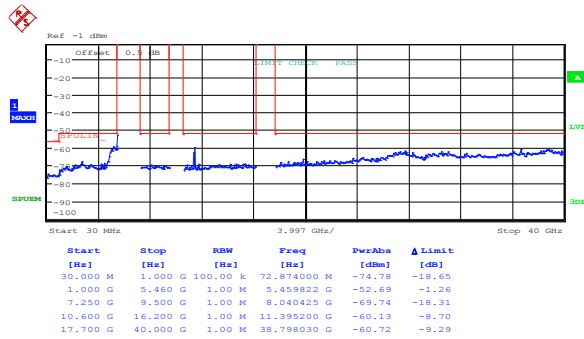


Figure 8.5-14: Peak spurious emissions within restricted bands at FCC high channel, 802.11n HT20, cho

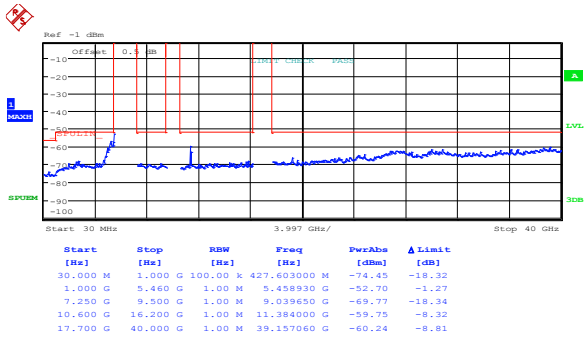


Figure 8.5-15: Peak spurious emissions within restricted bands at FCC high channel, 802.11n HT40, cho

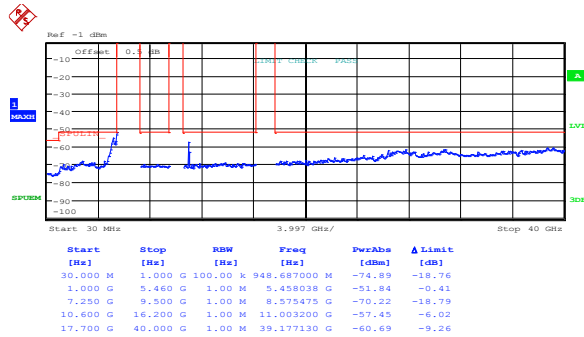


Figure 8.5-16: Peak spurious emissions within restricted bands at FCC low channel, 802.11a, ch1

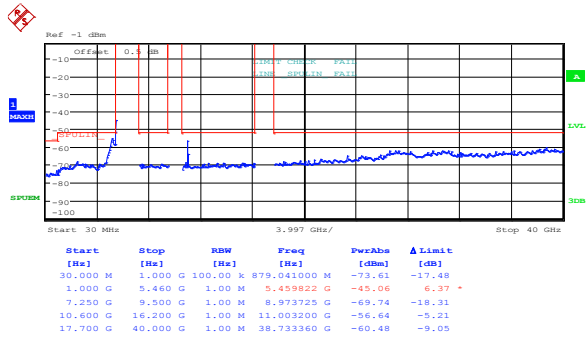


Figure 8.5-17: Peak spurious emissions within restricted bands at FCC low channel, 802.11n HT20, ch1

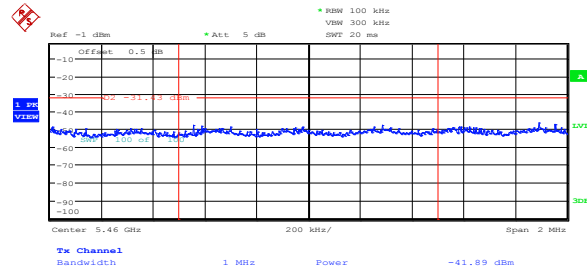


Figure 8.5-18: Peak spurious emission at 5.46 GHz on FCC low channel, 802.11n HT20, ch1

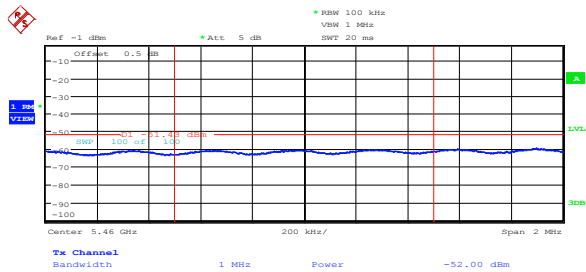


Figure 8.5-19: Average spurious emission at 5.46 GHz on FCC low channel, 802.11n HT20, ch1

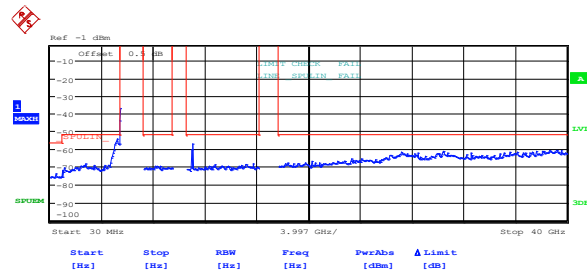


Figure 8.5-20: Peak spurious emissions within restricted bands at FCC low channel, 802.11n HT40, ch1

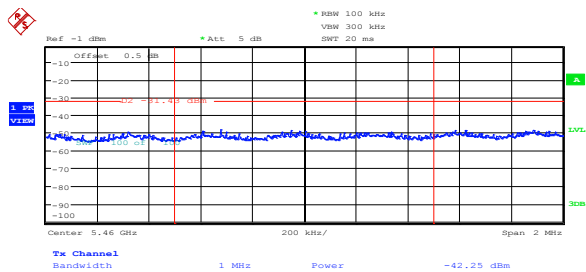


Figure 8.5-21: Peak spurious emission at 5.46 GHz on FCC low channel, 802.11n HT20, ch1

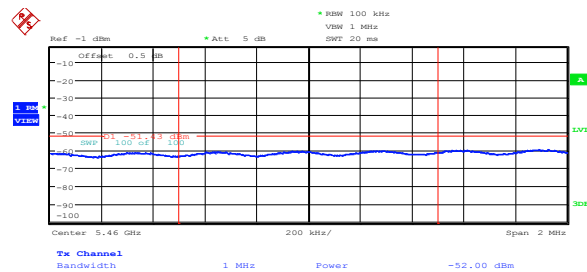


Figure 8.5-22: Average spurious emission at 5.46 GHz on FCC low channel, 802.11n HT20, ch1

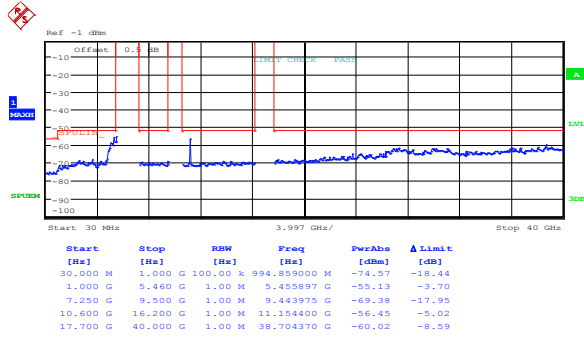


Figure 8.5-23: Peak spurious emissions within restricted bands at FCC mid channel, 802.11a, ch1

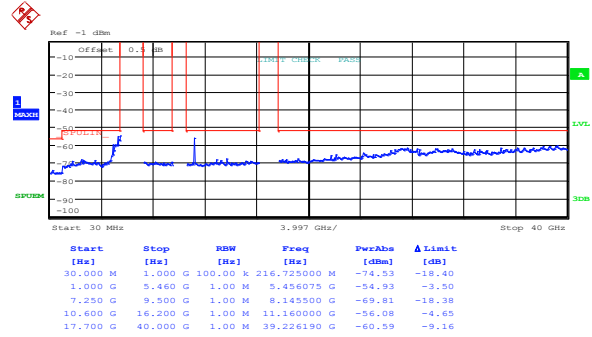


Figure 8.5-24: Peak spurious emissions within restricted bands at FCC mid channel, 802.11n HT20, ch1

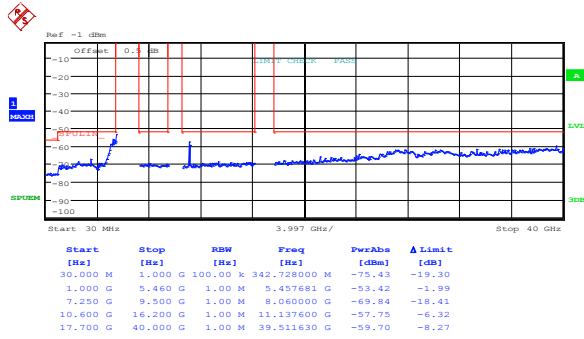


Figure 8.5-25: Peak spurious emissions within restricted bands at FCC mid channel, 802.11n HT40, ch1

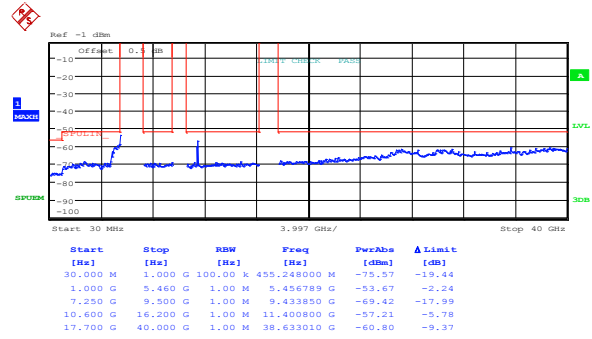


Figure 8.5-26: Peak spurious emissions within restricted bands at FCC high channel, 802.11a, ch1

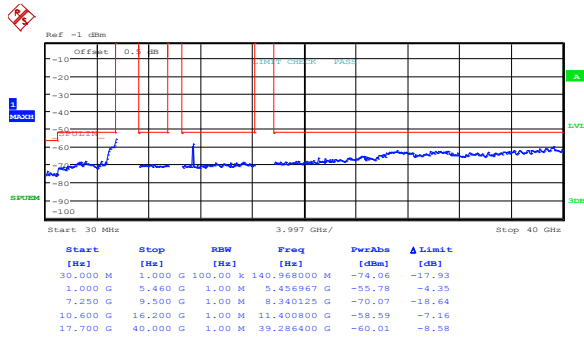


Figure 8.5-27: Peak spurious emissions within restricted bands at FCC high channel, 802.11n HT20, ch1

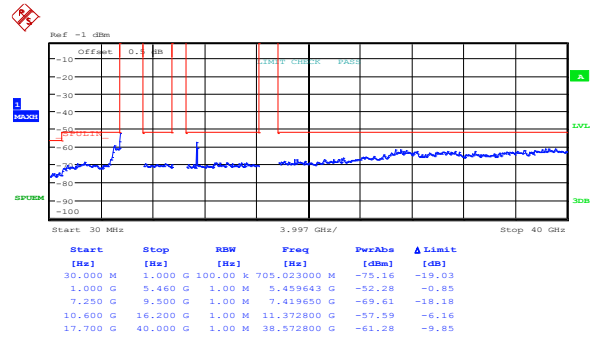


Figure 8.5-28: Peak spurious emissions within restricted bands at FCC high channel, 802.11n HT40, ch1

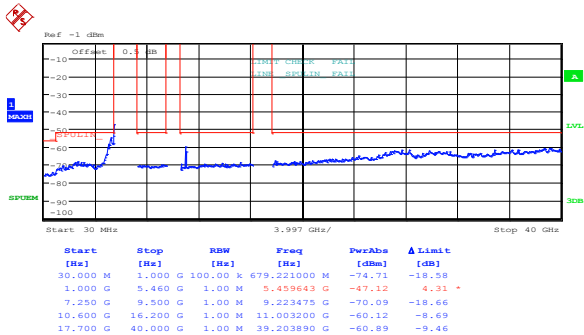


Figure 8.5-29: Peak spurious emissions within restricted bands at IC low channel, 802.11a, cho

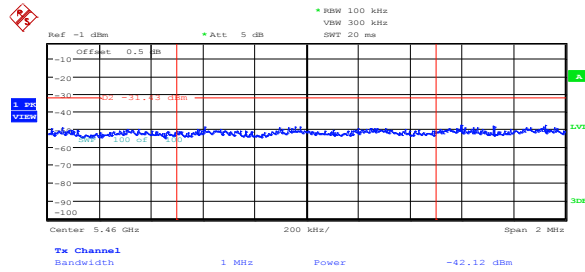


Figure 8.5-30: Peak spurious emission at 5.46 GHz on IC low channel, 802.11a, cho

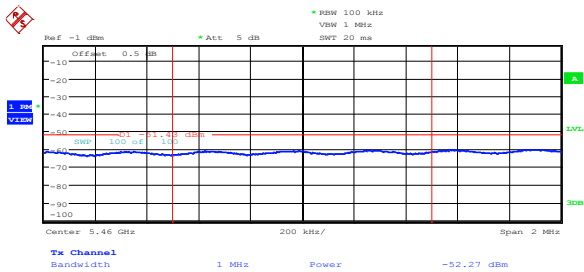


Figure 8.5-31: Average spurious emission at 5.46 GHz on IC low channel, 802.11a, cho

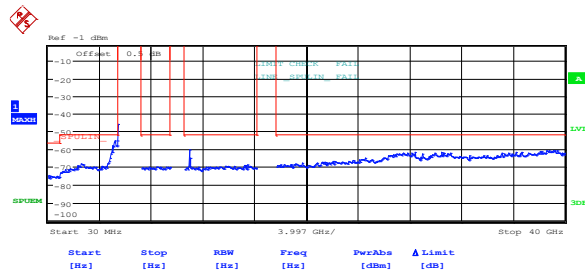


Figure 8.5-32: Peak spurious emissions within restricted bands at IC low channel, 802.11n HT20, cho

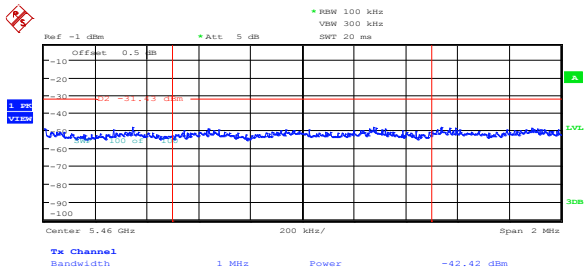


Figure 8.5-33: Peak spurious emission at 5.46 GHz on IC low channel, 802.11n HT20, cho

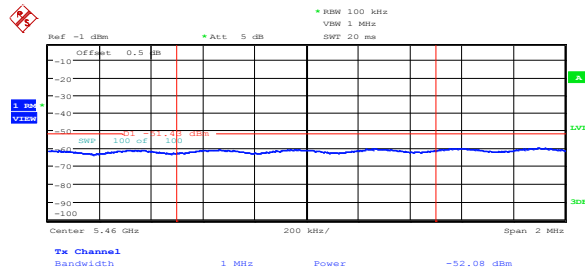


Figure 8.5-34: Average spurious emission at 5.46 GHz on IC low channel, 802.11n HT20, cho

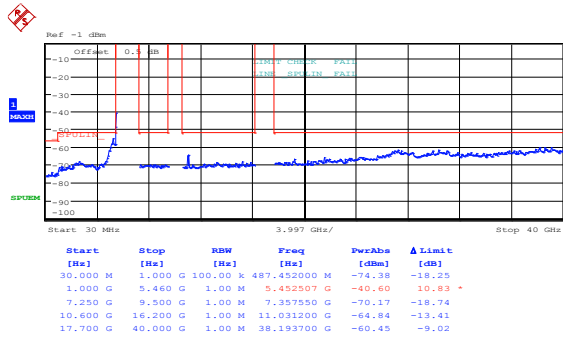


Figure 8.5-35: Peak spurious emissions within restricted bands at IC low channel, 802.11n HT40, cho

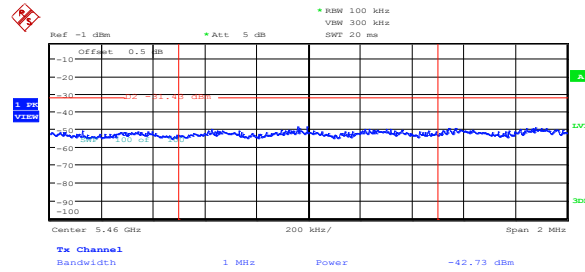


Figure 8.5-36: Peak spurious emission at 5.46 GHz on IC low channel, 802.11n HT40, cho

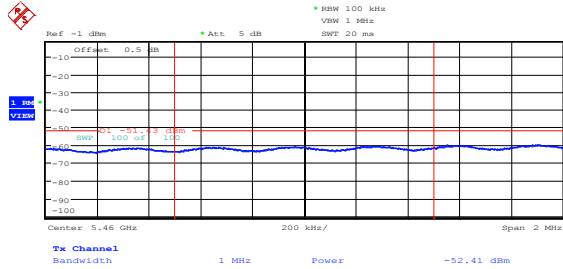


Figure 8.5-37: Average spurious emission at 5.46 GHz on IC low channel, 802.11n HT40, cho

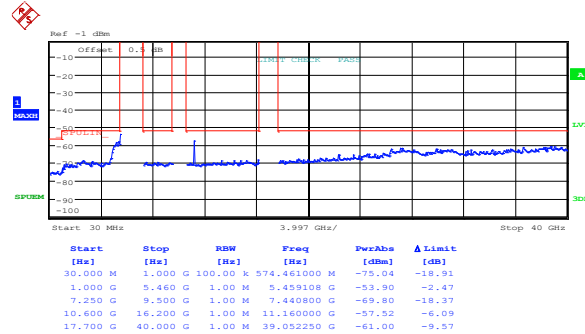


Figure 8.5-38: Peak spurious emissions within restricted bands at IC mid channel, 802.11a, cho

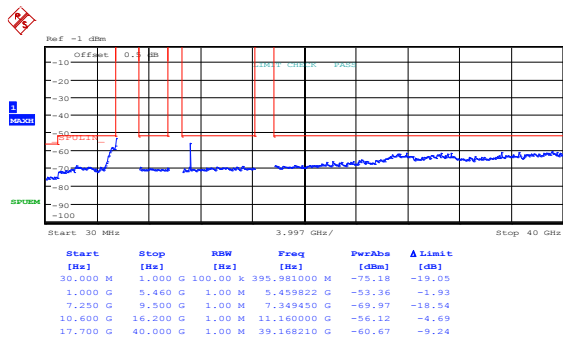


Figure 8.5-39: Peak spurious emissions within restricted bands at IC mid channel, 802.11n HT20, cho

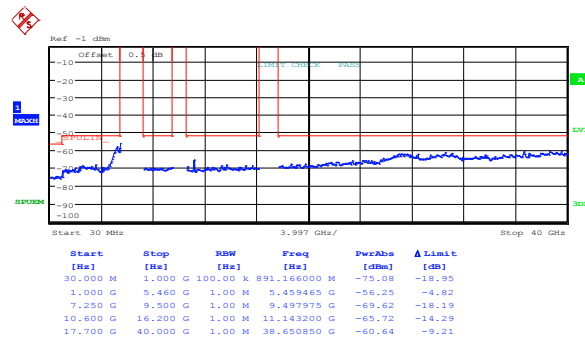


Figure 8.5-40: Peak spurious emissions within restricted bands at IC mid channel, 802.11n HT40, cho

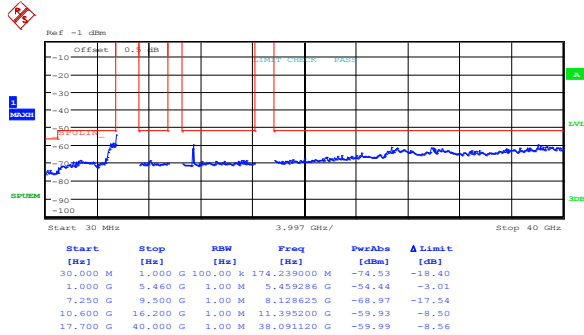


Figure 8.5-41: Peak spurious emissions within restricted bands at IC high channel, 802.11a, cho

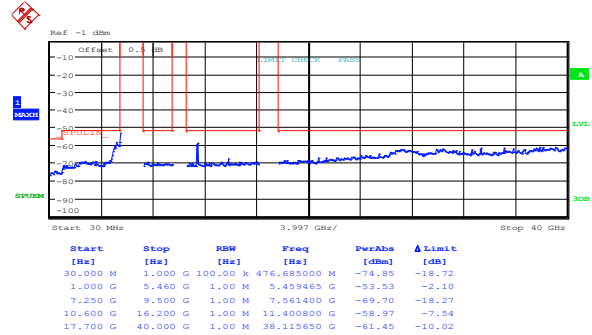


Figure 8.5-42: Peak spurious emissions within restricted bands at IC high channel, 802.11n HT20, cho

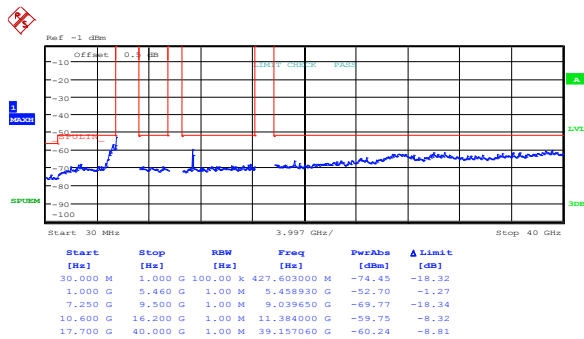


Figure 8.5-43: Peak spurious emissions within restricted bands at IC high channel, 802.11n HT40, cho

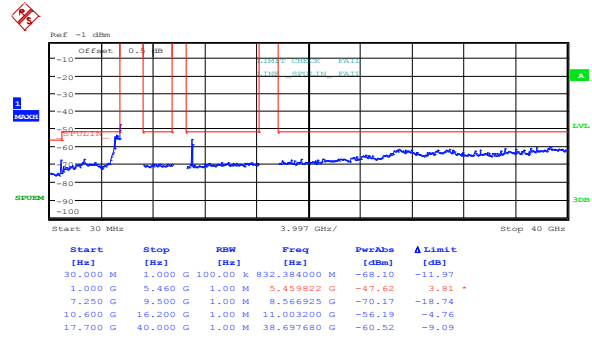


Figure 8.5-44: Peak spurious emissions within restricted bands at IC low channel, 802.11a, ch1

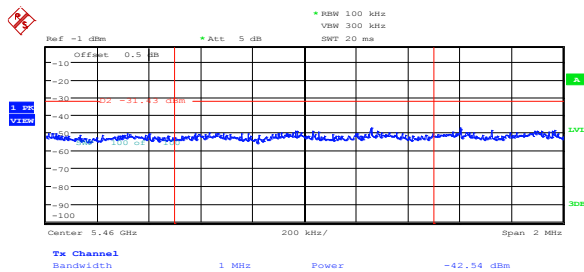


Figure 8.5-45: Peak spurious emission at 5.46 GHz on IC low channel, 802.11a, ch1

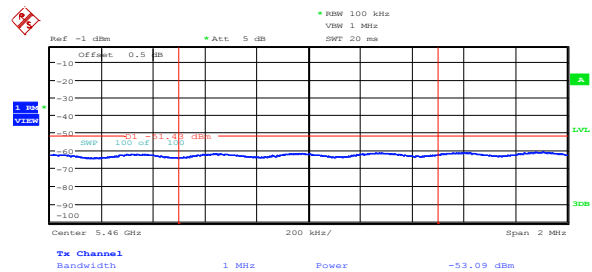


Figure 8.5-46: Average spurious emission at 5.46 GHz on IC low channel, 802.11a, ch1

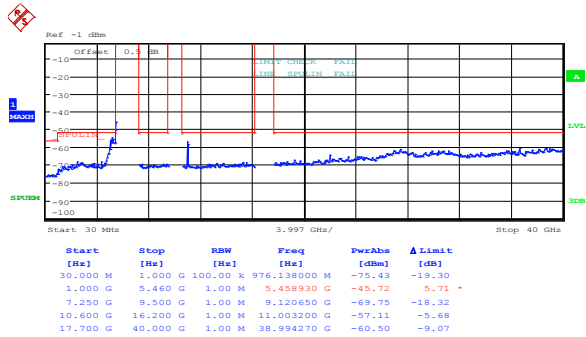


Figure 8.5-47: Peak spurious emissions within restricted bands at IC low channel, 802.11n HT20, ch1

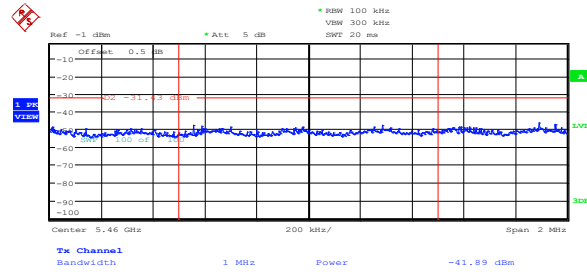


Figure 8.5-48: Peak spurious emission at 5.46 GHz on IC low channel, 802.11n HT20, ch1

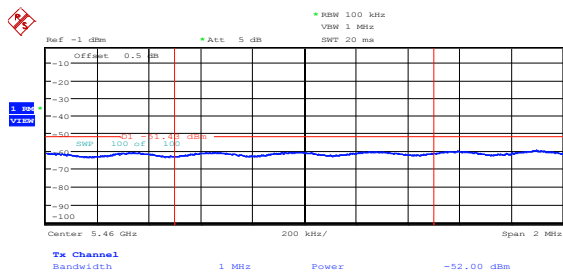


Figure 8.5-49: Average spurious emission at 5.46 GHz on IC low channel, 802.11n HT20, ch1

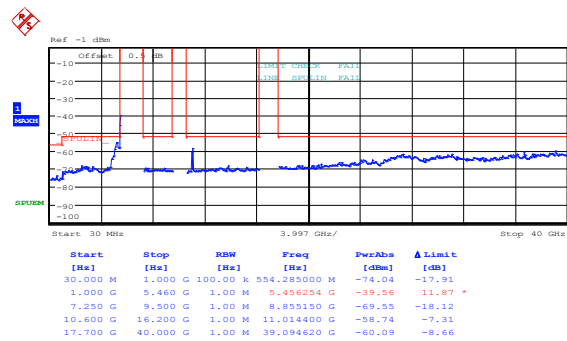


Figure 8.5-50: Peak spurious emissions within restricted bands at IC low channel, 802.11n HT40, ch1

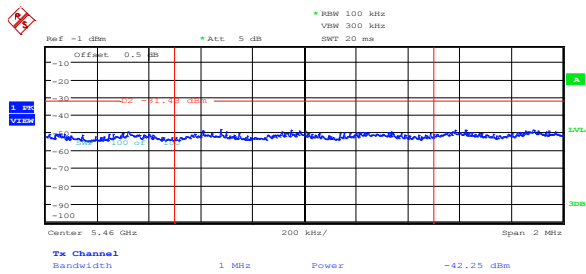


Figure 8.5-51: Peak spurious emission at 5.46 GHz on IC low channel, 802.11n HT40, ch1

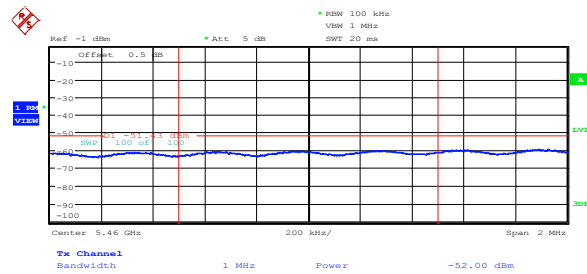


Figure 8.5-52: Average spurious emission at 5.46 GHz on IC low channel, 802.11n HT40, ch1

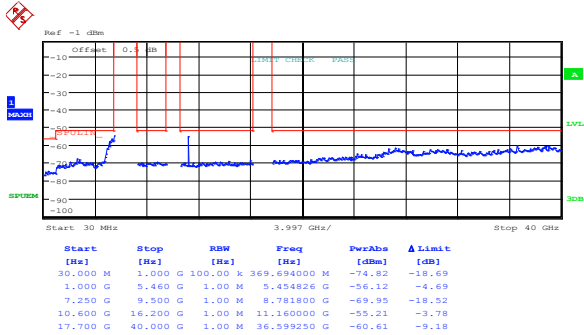


Figure 8.5-53: Peak spurious emissions within restricted bands at IC mid channel, 802.11a, ch1

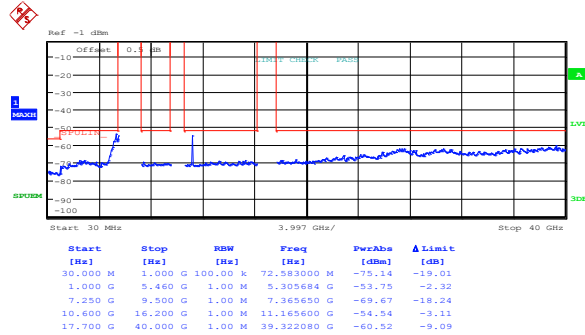


Figure 8.5-54: Peak spurious emissions within restricted bands at IC mid channel, 802.11n HT20, ch1

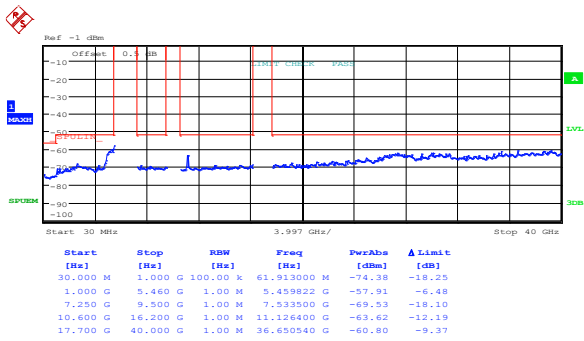


Figure 8.5-55: Peak spurious emissions within restricted bands at IC mid channel, 802.11n HT40, ch1

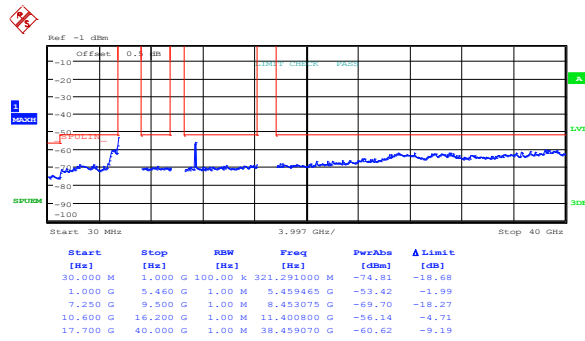


Figure 8.5-56: Peak spurious emissions within restricted bands at IC high channel, 802.11a, ch1

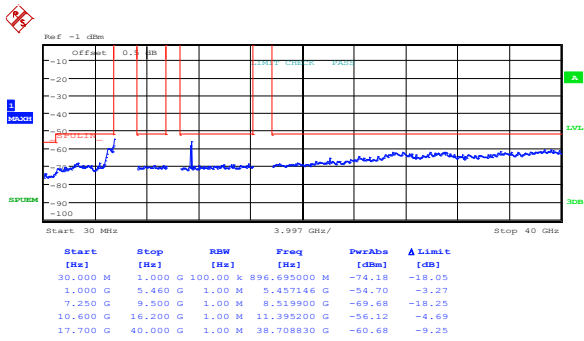


Figure 8.5-57: Peak spurious emissions within restricted bands at IC high channel, 802.11n HT20, ch1

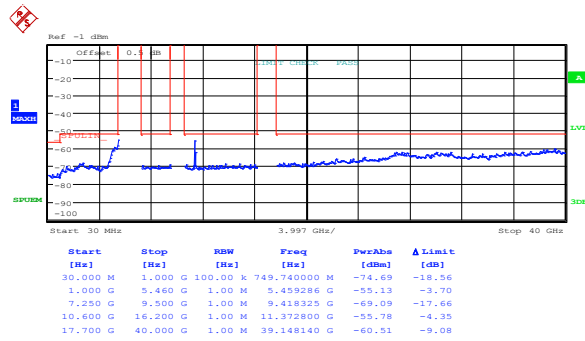


Figure 8.5-58: Peak spurious emissions within restricted bands at IC high channel, 802.11n HT40, ch1

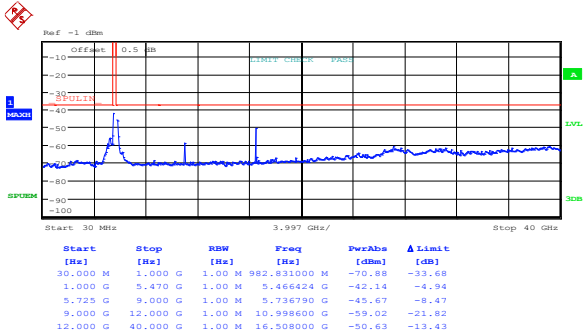


Figure 8.5-59: Spurious out-of-band emissions outside restricted bands at low channel, 802.11a, cho

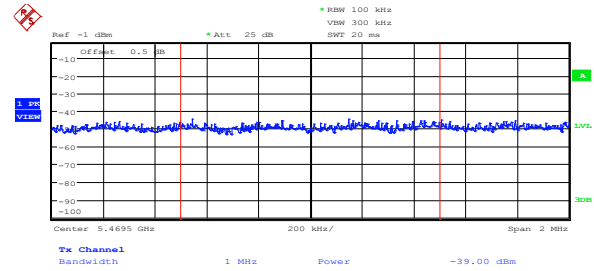


Figure 8.5-60: Lower band edge emission at 5.47 GHz on low channel, 802.11a, cho (limit = -37.2 dBm/MHz)

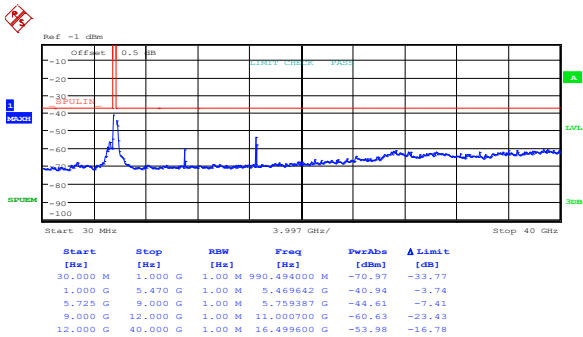


Figure 8.5-61: Spurious out-of-band emissions outside restricted bands at low channel, 802.11n HT20, cho

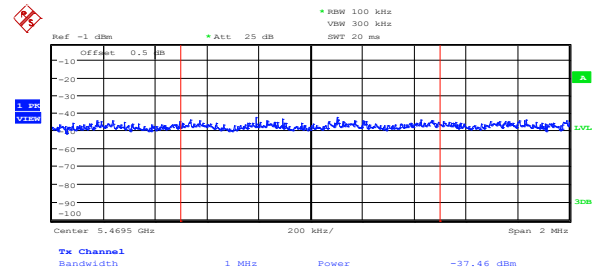


Figure 8.5-62: Lower band edge emission at 5.47 GHz on low channel, 802.11n HT20, cho (limit = -37.2 dBm/MHz)

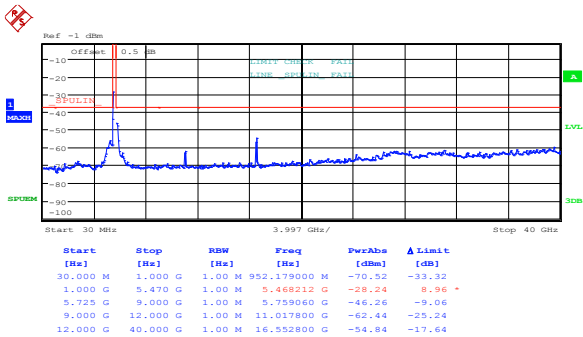


Figure 8.5-63: Spurious out-of-band emissions outside restricted bands at low channel, 802.11n HT40, cho

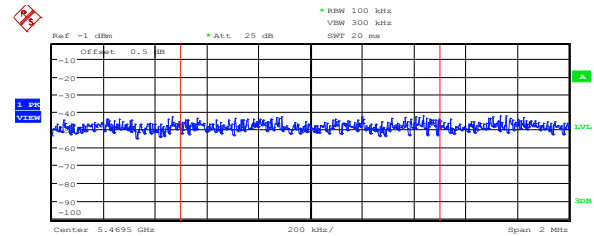


Figure 8.5-64: Lower band edge emission at 5.47 GHz on low channel, 802.11n HT40, cho (limit = -37.2 dBm/MHz)

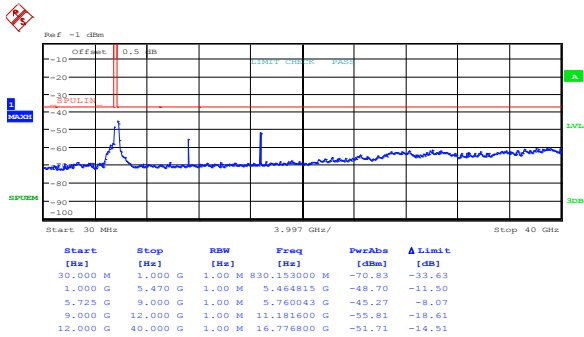


Figure 8.5-65: Spurious out-of-band emissions outside restricted bands at mid channel, 802.11a, cho

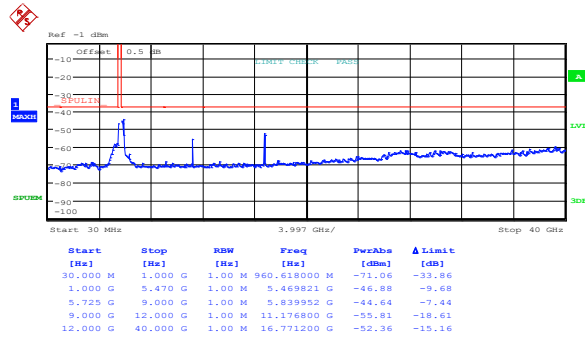


Figure 8.5-66: Spurious out-of-band emissions outside restricted bands at mid channel, 802.11n HT20, cho

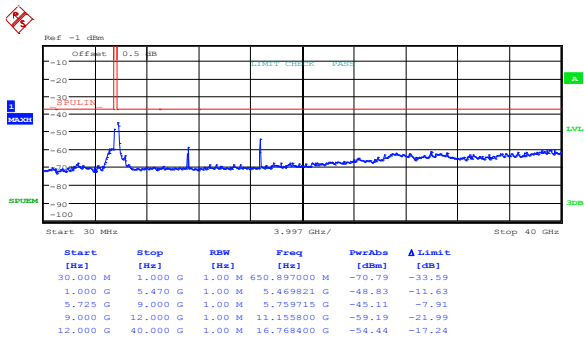


Figure 8.5-67: Spurious out-of-band emissions outside restricted bands at mid channel, 802.11n HT40, cho

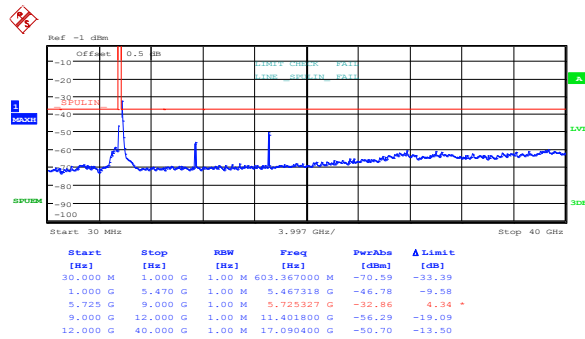


Figure 8.5-68: Spurious out-of-band emissions outside restricted bands at high channel, 802.11a, cho

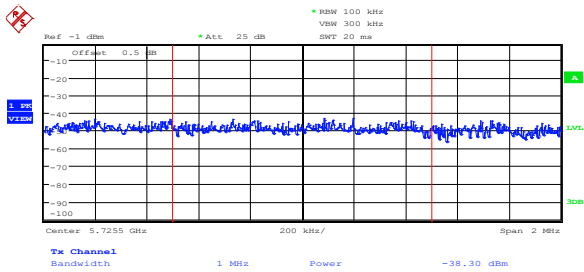


Figure 8.5-69: Upper band edge emission at 5.725 GHz on high channel, 802.11a, cho (limit = -37.2 dBm/MHz)

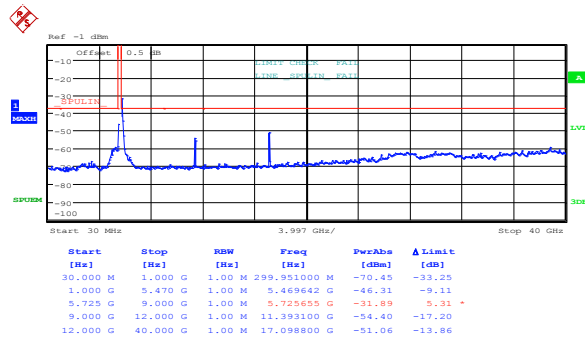


Figure 8.5-70: Spurious out-of-band emissions outside restricted bands at high channel, 802.11n HT20, cho

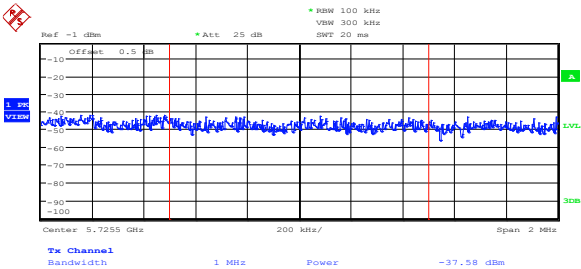


Figure 8.5-71: Upper band edge emission at 5.725 GHz on high channel, 802.11n HT20, cho (limit = -37.2 dBm/MHz)

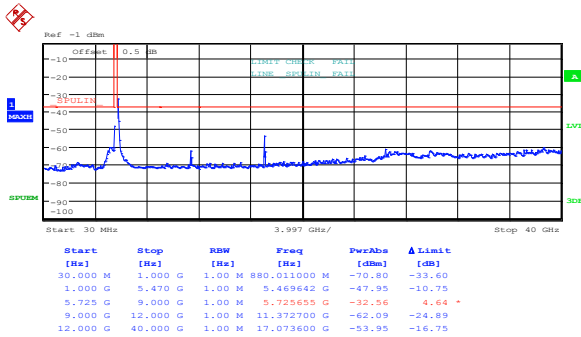


Figure 8.5-72: Spurious out-of-band emissions outside restricted bands at high channel, 802.11n HT40, cho

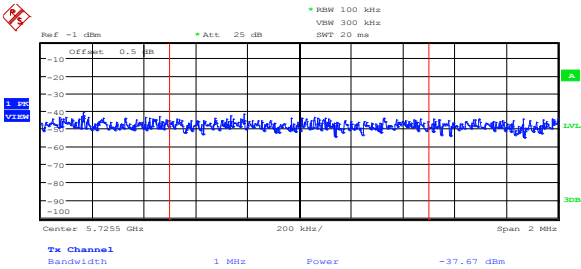


Figure 8.5-73: Upper band edge emission at 5.725 GHz on high channel, 802.11n HT40, cho (limit = -37.2 dBm/MHz)

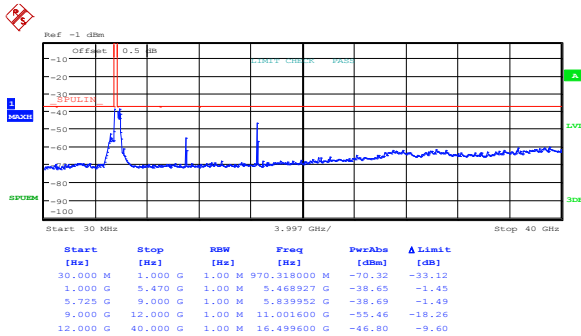


Figure 8.5-74: Spurious out-of-band emissions outside restricted bands at low channel, 802.11a, ch1

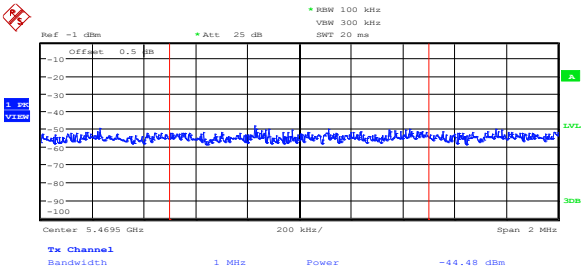


Figure 8.5-75: Lower band edge emission at 5.47 GHz on low channel, 802.11a, ch1 (limit = -37.2 dBm/MHz)

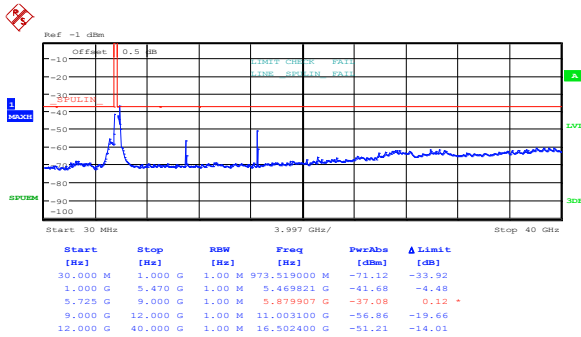


Figure 8.5-76: Spurious out-of-band emissions outside restricted bands at low channel, 802.11n HT20, ch1

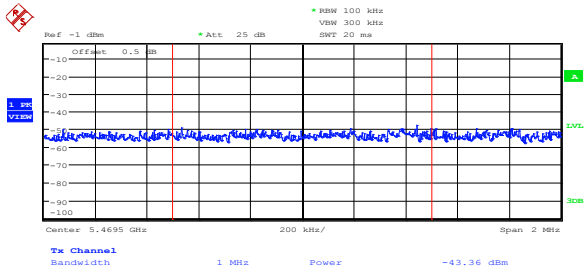


Figure 8.5-77: Lower band edge emission at 5.47 GHz on low channel, 802.11n HT20, ch1 (limit = -37.2 dBm/MHz)

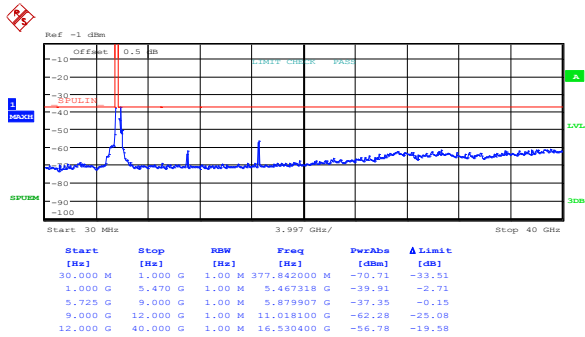


Figure 8.5-78: Spurious out-of-band emissions outside restricted bands at low channel, 802.11n HT40, ch1

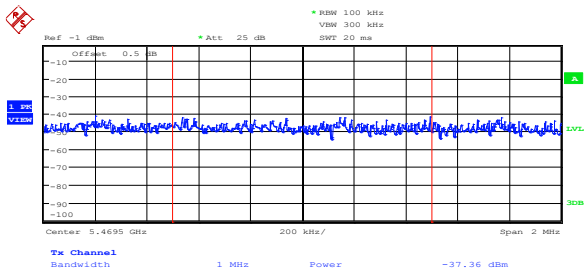


Figure 8.5-79: Lower band edge emission at 5.47 GHz on low channel, 802.11n HT40, ch1 (limit = -37.2 dBm/MHz)

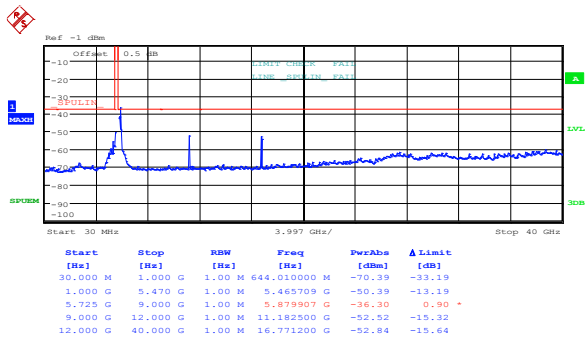


Figure 8.5-80: Spurious out-of-band emissions outside restricted bands at mid channel, 802.11a, ch1

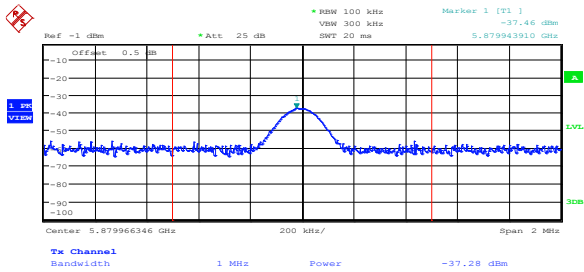


Figure 8.5-81: Spurious out-of-band emissions at 5.88 GHz on mid channel, 802.11a, ch1 (limit = -37.2 dBm/MHz)

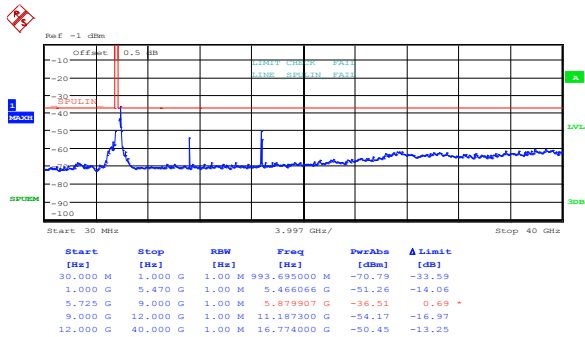


Figure 8.5-82: Spurious out-of-band emissions outside restricted bands at mid channel, 802.11n HT20, ch1

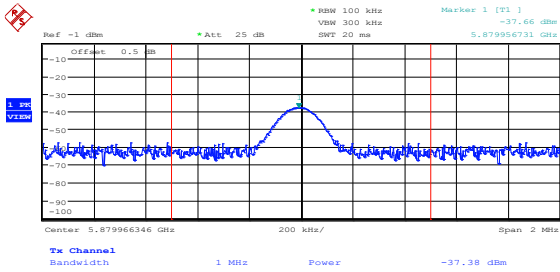


Figure 8.5-83: Spurious out-of-band emissions at 5.88 GHz on mid channel, 802.11n HT20, ch1 (limit = -37.2 dBm/MHz)

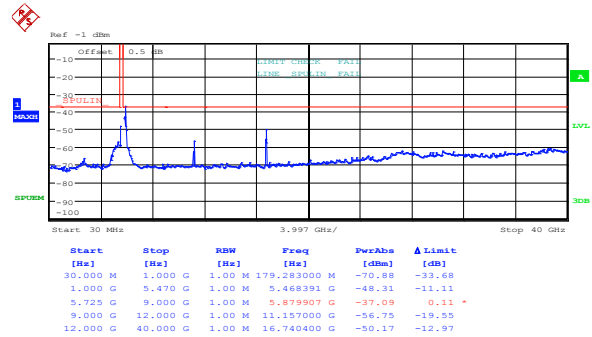


Figure 8.5-84: Spurious out-of-band emissions outside restricted bands at mid channel, 802.11n HT40, ch1

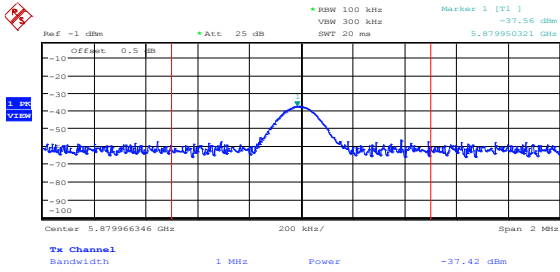


Figure 8.5-85: Spurious out-of-band emissions at 5.88 GHz on mid channel, 802.11n HT40, ch1 (limit = -37.2 dBm/MHz)

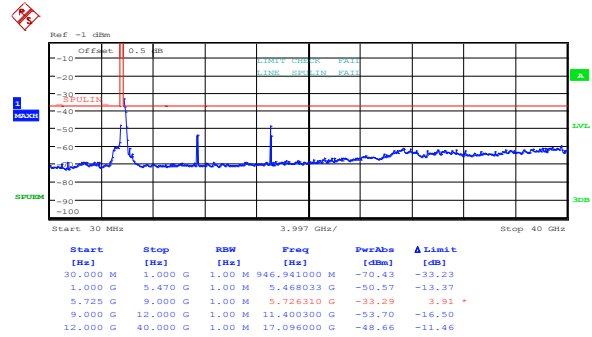


Figure 8.5-86: Spurious out-of-band emissions outside restricted bands at high channel, 802.11a, ch1

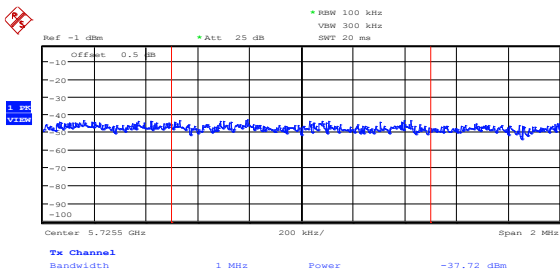


Figure 8.5-87: Upper band edge emission at 5.725 GHz on high channel, 802.11a, ch1 (limit = -37.2 dBm/MHz)

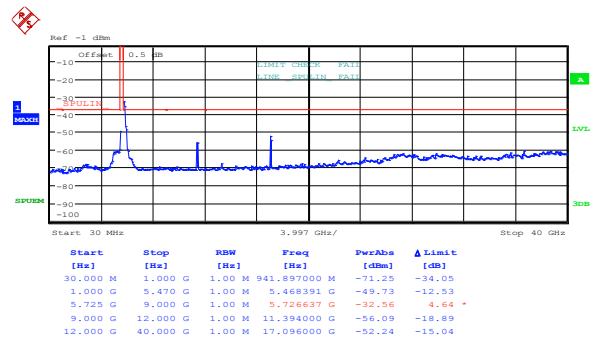


Figure 8.5-88: Spurious out-of-band emissions outside restricted bands at high channel, 802.11n HT20, ch1

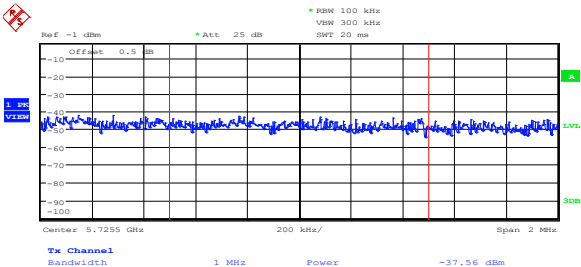


Figure 8.5-89: Upper band edge emission at 5.725 GHz on high channel, 802.11n HT20, ch1 (limit = -37.2 dBm/MHz)

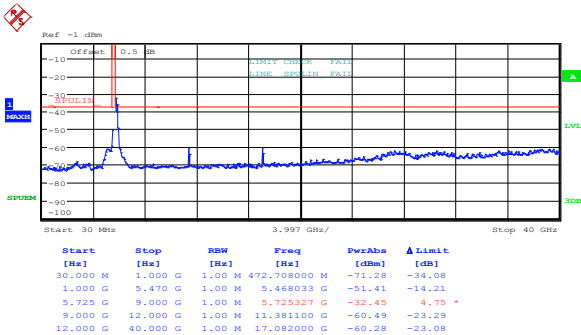


Figure 8.5-90: Spurious out-of-band emissions outside restricted bands at high channel, 802.11n HT40, ch1

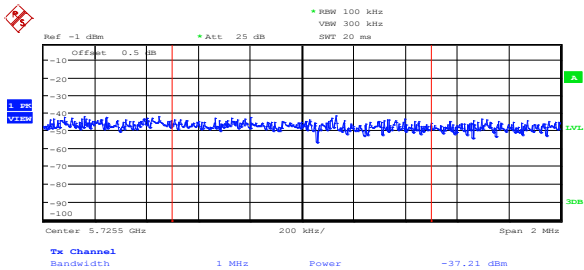


Figure 8.5-91: Upper band edge emission at 5.725 GHz on high channel, 802.11n HT40, ch1 (limit = -37.2 dBm/MHz)

## 8.7 FCC 15.407(a)(6) and RSS-210 A9.4(2) Peak excursion and PSD-to-average ratio

### 8.7.1 Definitions and limits

(6) The ratio of the peak excursion of the modulation envelope (measured using a peak hold function) to the maximum conducted output power (measured as specified above) shall not exceed 13 dB across any 1 MHz bandwidth or the emission bandwidth whichever is less.

**IC:**  
Within the emission bandwidth, when the peak spectral density per MHz over any continuous transmission exceeds the average ( $10 \log_{10} (B)$ ) value by more than 3 dB, the permissible power spectral density shall be reduced by the excess amount.

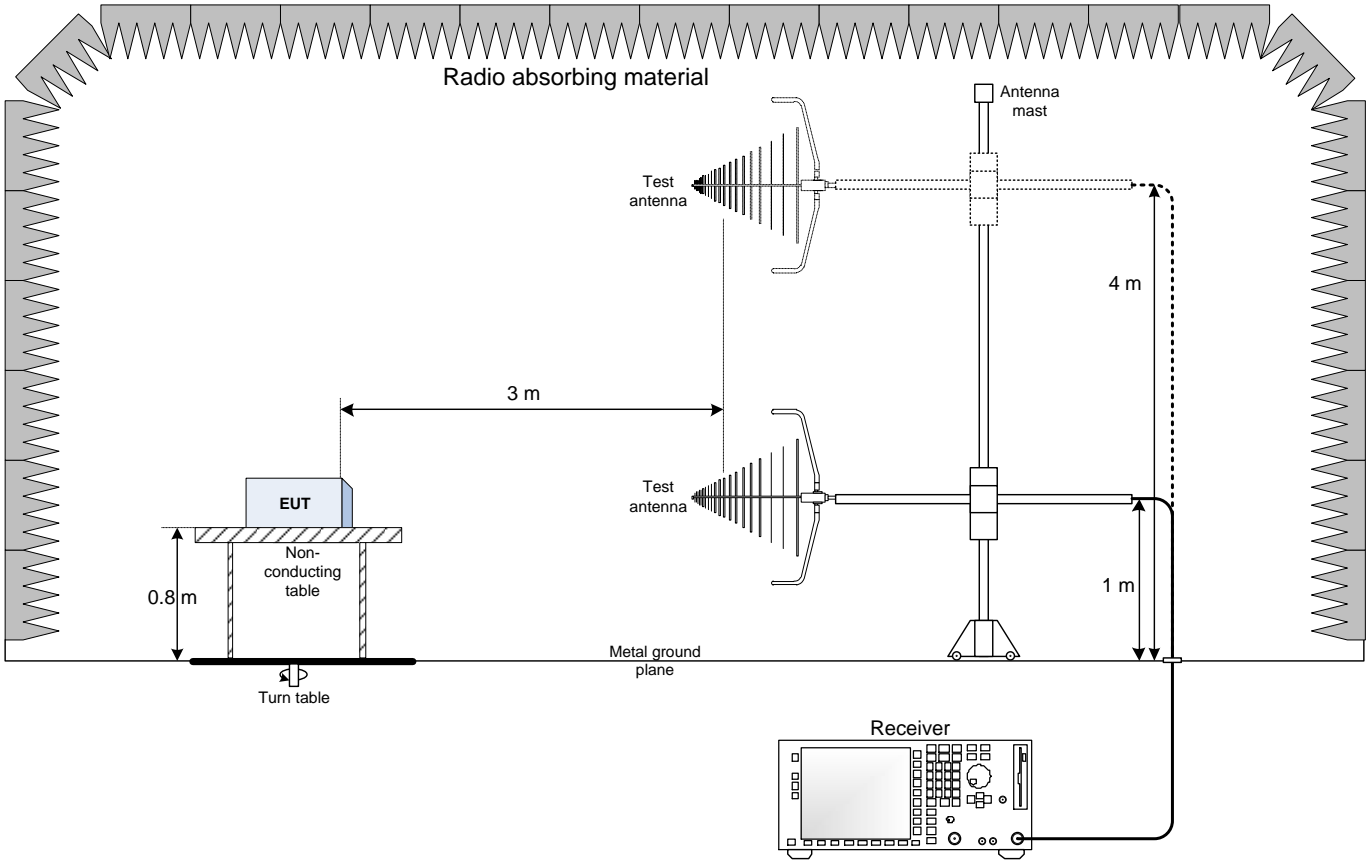
