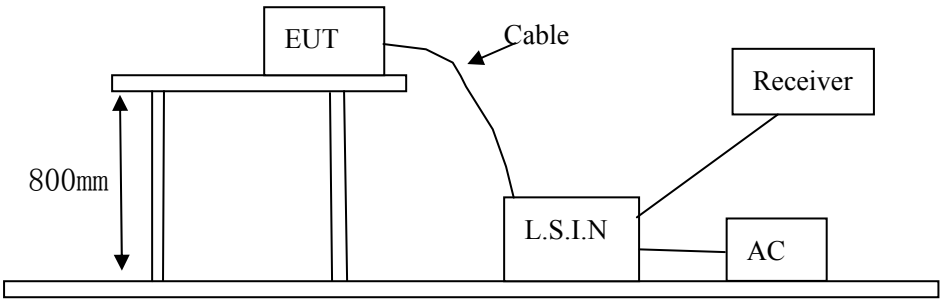

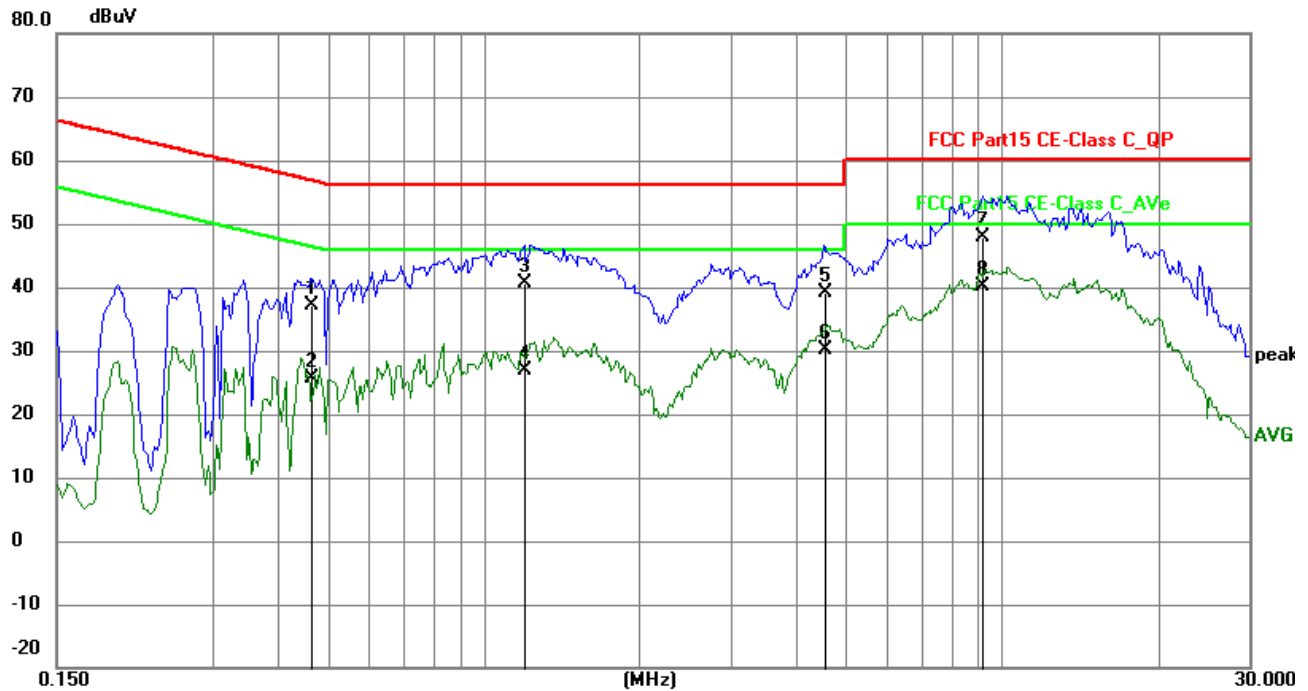

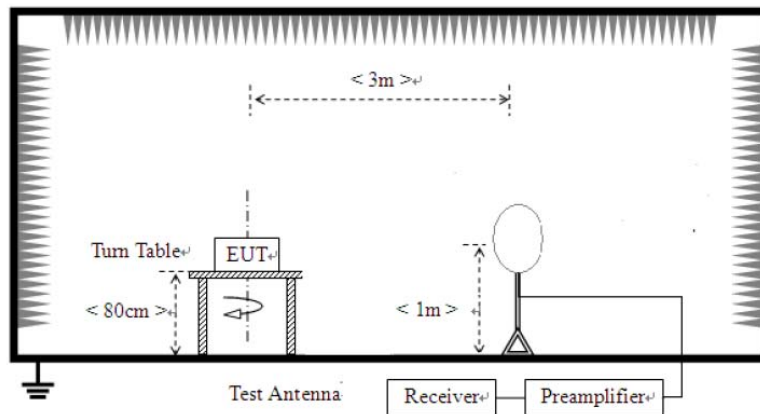
6 Undesirable Emission and Restrict band

6.1 Test Method and test Procedure:

- (1) The EUT was tested according to ANSI C63.10-2013. The radiated test was performed at Timeway Laboratory. This site is on file with the FCC laboratory division, Registration No.744189
- (2) The EUT, peripherals were put on the turntable which table size is 1m x 1.5 m, table high 0.8 m. All set up is according to ANSI C63.10-2013.
- (3) The frequency spectrum from 30 MHz to 40 GHz was investigated. All readings from 30 MHz to 1 GHz are Quasi-peak values with a resolution bandwidth of 120 kHz. For measurement above 1GHz, peak values with RBW=1MHz, VBW=3MHz and PK detector. Measurements were made at 3 meters.
- (4) The antenna high is varied from 1 m to 4 m high to find the maximum emission for each frequency.
- (5) Maximizing procedure was performed on the six (6) highest emissions to ensure EUT compliance is with all installation combinations. All data was recorded in the peak detection mode. For radiated emissions from 9kHz to 30MHz



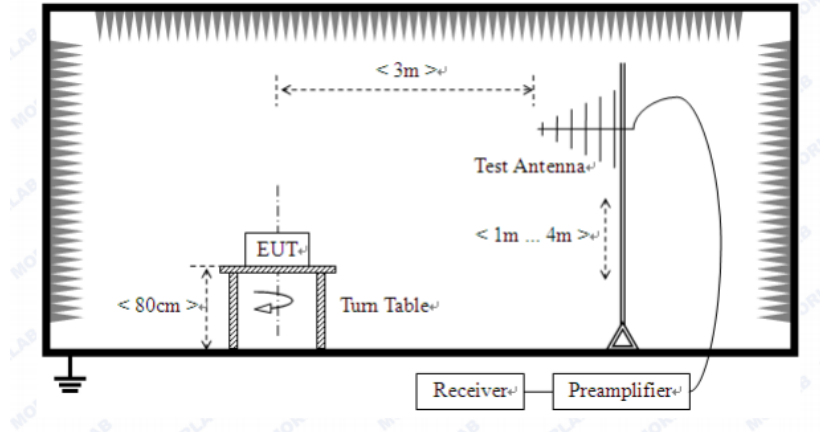

CH36 for 11a at 6Mbps: Vertical



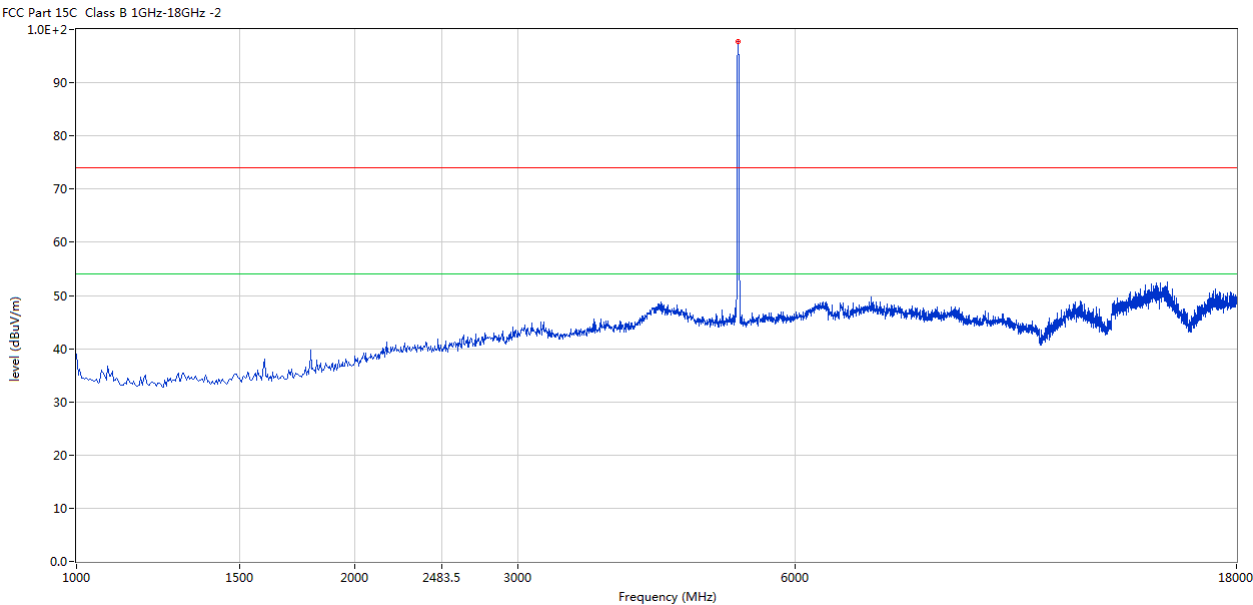

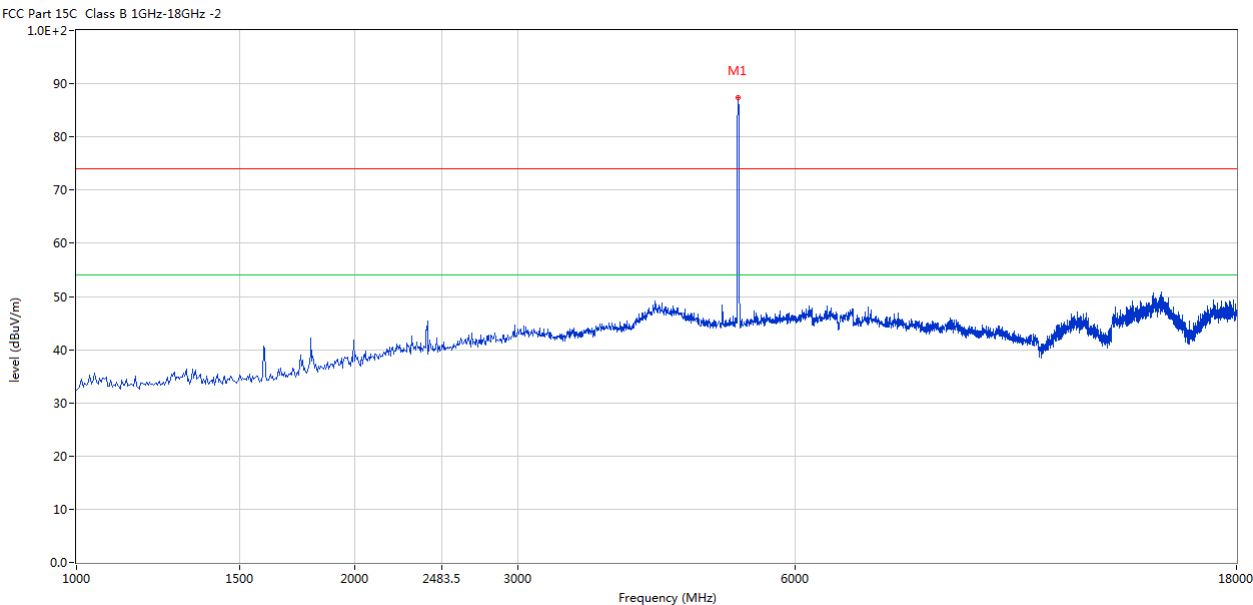

CH40 for 11a at 6Mbps: Horizontal



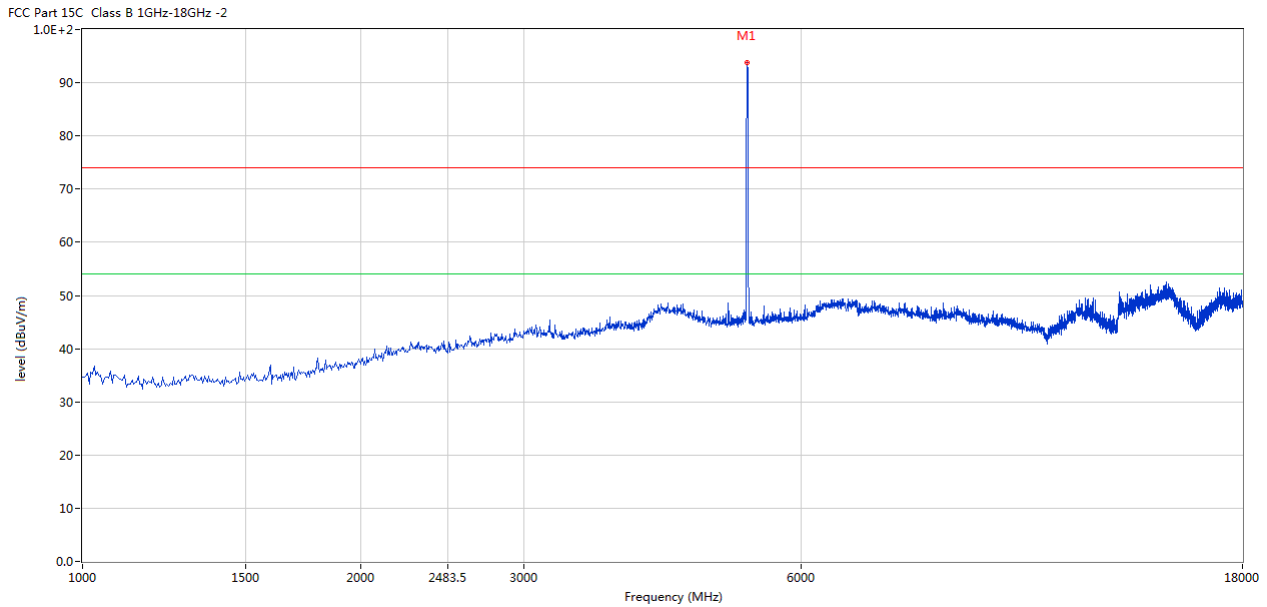

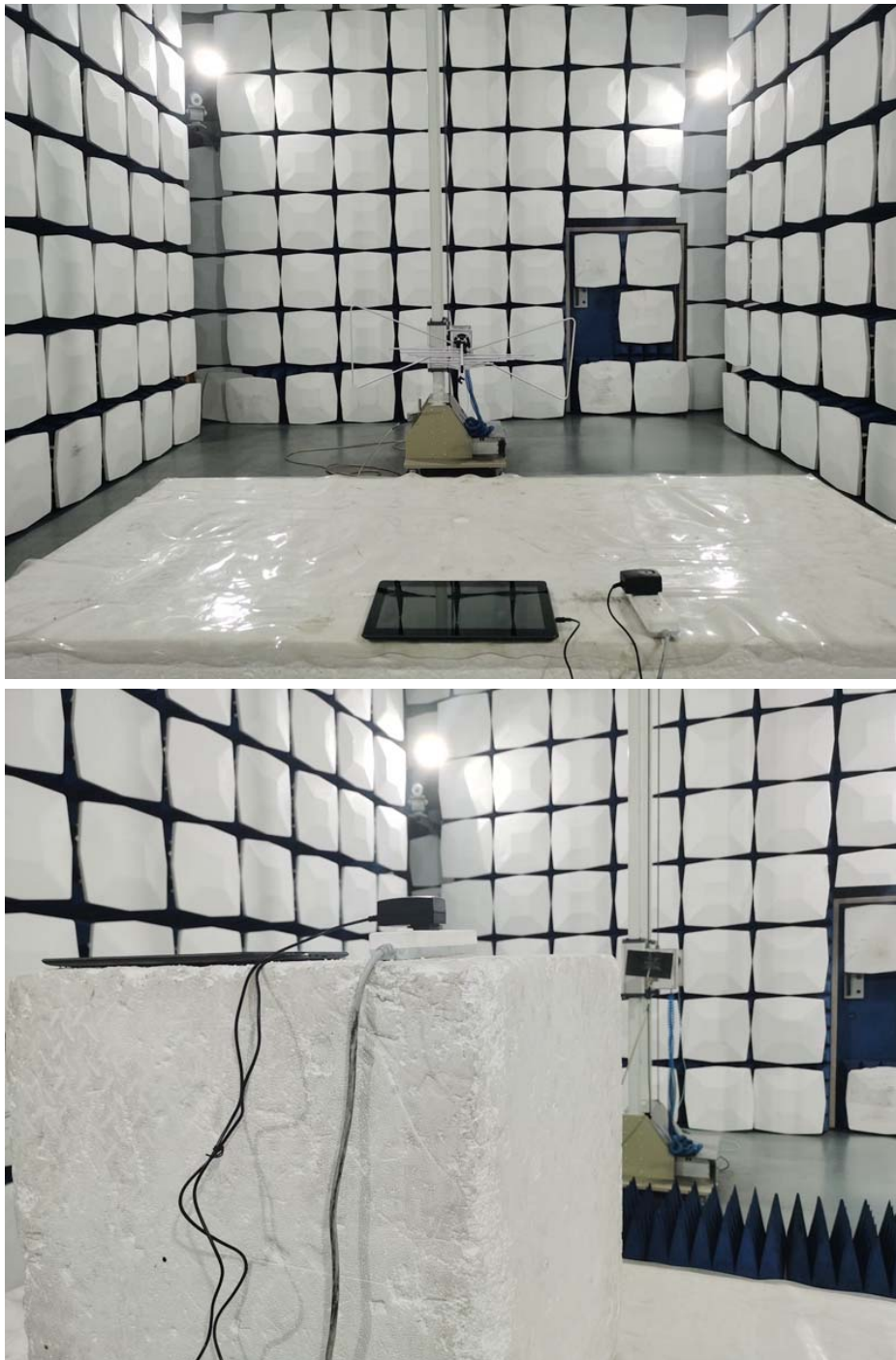
