





Setup & File Transfer: Use the Pocket mobile app to pair and transfer files via Bluetooth® or Wi-Fi. At first power-on, Bluetooth advertising is enabled to support pairing. Wireless settings can be managed in the app. Features and defaults may change with firmware/app updates.

Definitions. "Product" means the Pocket device, its included battery and in-box cable. "App" means Pocket software. "Services" means cloud features linked to your account.

At OVE's option, the exclusive remedy is repair, replacement, or refund. Proof of purchase is required.
