> provide full schematics that include the Cavium RF board and Main
> Board.

> The FCC has adopted new rules for UNII devices operating in the
> 5.25-5.35GHz band. In ET Docket 03-122, the FCC is requiring these
> devices to contain
> Dynamic Frequency Selection. There is an interim test procedure in the
> appendix of the Rules. The Rules can be found at:
