IMPORTANT INFORMATION ABOUT YOUR UNLEASH HEADSET

INITIAL CHARGING

1. Insert 4 "AA" batteries in the charging case
2. Remove headset and base from case
3. Reinsert headset and base
4. Give unit full charge (typically 4 hours)
5. Follow directions on instruction label

INSERTING UNLEASH INTO THE CASE

For easier insertion of both the base and headset insert the contact ends in first and then rotate them down into the case.

POWER OPTIMIZATION

If you notice your headset remains "active" for extended periods of time when no call is active then your phone model does not support voltage modulation of headsets. This condition can result in shorter standby times than expected. To improve the battery life of your unit, use the Manual Standby Function (see instruction label for directions) to manually place your Unleash headset into standby mode.
