BATTERY & ASSEMBLY INSTRUCTIONS

Step 1: Insert Batteries:


batteries.

Display: Requires 3 "AAA" size batteries (not included) Do not mix old and new batteries. Do not mix alkaline, standard (carbon-zinc), or rechargeable (nickel-cadmium)

Sensor: Requires 3 "LR44" size batteries (included)

Do not dispose of batteries in fire, batteries may explode or leak.

Step 2: Attach the Foot Pad to the Display

Step 3: Slide the Display in the grooved slots of the Pitcher's Mound. The Foot Pad should extend outwards in front of the Mound.

Step 4: Attach the Sensor to a glove or backstop. (not included) (See Figure 1)

TRACK YOUR SPEED:

Step 1: Turn on the glove sensor

Step 2: Press the "on" button located on the pitch plate. Then select the distance: 24ft, 36ft, 46ft, 54ft or 60.6ft (7.3m, 11m, 14m x 16.5m or 18.5m).

NOTE: For accuracy, measure and match the selected distance to the distance from the pitch plate to the catcher's glove w/sensor.

Step 3: Place one foot on the Foot Pad. The display should flash "HHH". Pitch the ball. Note: Lift foot off the foot pad upon the release of ball. When the ball triggers the sensor in the glove it will transmit the actual MPH to the LED screen.
