Charge, Install SIM Card

1. Use charger or charging by USB with DC 5V
2. Insert the SIM card by notch-in, metal touching-down then start to use.

Switch On, Switch Off

1. Under switch off, hold down power key in 3 seconds, the equipment will be inside the on- processing with vibration;
2. Under switch on, hold down power key in 3 seconds, the equipment will be inside the off- processing with vibration;

Indicator light

Hold down power key in 3 seconds to switch on, LED light will appear red, yellow and green colors alternating twinkle, it means it's in searching the signal. If SIM card is normal, the LED light will twinkle one time by six seconds, now the machine can be used; If the SIM card is useless or not be inserted, LED light will twinkle one time by one second, now the machine can not be used, then please check the SIM card.

LED Indicator Light Color Meaning

1. Green when the power in 66% - full;
2. Blue when the power in 33%-66%;
3. Red when the power under 33%;
4. Red twinkle urgently when the power under 10%.

Attention

Switch on the machine after inserted the SIM card. It will be recognized useless card to insert the SIM card under switching on and can not be read the card effetely, will need to switch off and restart it again then can be used in normally.

2. The bought date is according to the distributor's invoice or reception date.
3. Service Promise: If the machine in problem after sale in 7 days under the outside looking is not be damaged, users can choose return it back or change the goods, we will service in free repairing under the outside looking damaged; After sale in one year from bought date happened function problems or the user not satisfied with free changeable and free repairing, our company will do the paid service and just collect the parts costing.
4. Our company will do the paid service under guarantee (Include "Three pack" validity period) and in the same time not enjoy "Three pack" service;
 - ① Can not show the effective guarantee card, invoice ,reception

or the machine code damaged;

- ② The bought date or the distributor(effective stamp) etc. didn't wrote or altered the guarantee card;
- ③ Cause of force majeure(Fire,Thunder,Earthquake.abnormal electric pressure) caused problems or damaged;
- ④ Under transporting or the loading caused the problems or damaged;
- ⑤ Human causing damaged and include using under abnormal work surrounding, not follow the use instructions or attention matter, connect not properly, connect to not suitable power or not follow the user instructions mentioned of under the computer environment caused the problems or damaged;
- ⑥ No company's authorized then unload, repair and refit;
- ⑦ Under normal using damaged, old or other reason caused broken, rust or dip;
- ⑧ Not belong to our company's products(Fake goods);
- ⑨ Outside looking damaged, face scratched not belong to guarantee

5. Please take the guarantee card, invoice or reception to our company's directed repair station to repair. If the problems can not be solved properly, please call or send letter to our service department, we will solve it for you in the shortest

time.

6. Please use the origin or vibration protection packing to send to our repair station to repair, if damaged under the transporting cause of not using the protection packing will not in the guarantee range, the charges for the transportation will be paid by the user.
7. This guarantee promise paid range just limit under change, repair the damaged products, not include production problem caused the other indirect damage.
