### 2 Test Configuration of Equipment Under Test

### 2.1 Test Mode

Antenna port conducted and radiated test items were performed according to KDB 971168 D01 Power Meas. License Digital Systems v03r01 with maximum output power.

For radiated measurement, the measured emission level of the EUT was maximized by rotating the EUT on a turntable, adjusting the orientation of the EUT and EUT antenna in two degree (Degree 0 and Degree 90), and adjusting the measurement antenna orientation, following C63.26 exploratory test procedures and only the worst case emissions were reported in this report..

Radiated emissions were investigated as following frequency range:

- 1. 30 MHz to 9000 MHz for WCDMA Band V
- 2. 30 MHz to 18000 MHz for WCDMA Band IV
- 3. 30 MHz to 19100 MHz for WCDMA Band II





### 3.2 Conducted Output Power and ERP/EIRP

### 3.2.1 Description of the Conducted Output Power and ERP/EIRP

A system simulator was used to establish communication with the EUT. Its parameters were set to enforce EUT transmitting at the maximum power. The measured power in the radio frequency on the transmitter output terminals shall be reported.

The ERP of mobile transmitters must not exceed 7 Watts for WCDMA Band V

#### 3.2.2 Test Procedures

- 1. The transmitter output port is connected to the system simulator.
- 2. Set EUT at maximum power through system simulator.
- 3. Select the lowest, middle, and the highest channels for each band and different modulation.
- 4. Measure the maximum burst average power for GSM and maximum average power for other modulation signal.





#### For radiated test below 30MHz





#### For radiated test from 30MHz to 1GHz





There is adequate comparison measurement of both open-field test site and alternative test site - semi-Anechoic chamber according to 414788 D01 Radiated Test Site v01r01, and the result came out very similar.

### 4.4 Field Strength of Spurious Radiation Measurement

### 4.4.1 Description of Field Strength of Spurious Radiated Measurement

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitter power (P) by a factor of at least 43 + 10 log (P) dB. The spectrum is scanned from 30 MHz up to a frequency including its 10th harmonic.

#### 4.4.2 Test Procedures

The testing follows FCC KDB 971168 D01 v03r01 Section 7 and ANSI C63.26-2015 section 5.5.4 Radiated measurement using the field strength method.

- 1. The EUT is placed on a rotatable wooden table 0.8 meters for frequency below 1 GHz and 1.5 meter for frequency above 1 GHz above the ground.
- 2. The EUT is set 3 meters away from the receiving antenna, which is mounted on the antenna tower.
- 3. The table is rotated 360 degrees to determine the position of the highest spurious emission.
- 4. The height of the receiving antenna is varied between one meter and four meters to search for the maximum spurious emission for both horizontal and vertical polarizations.
- 5. Make the measurement with the spectrum analyzer's RBW = 1 MHz, VBW = 3 MHz, taking record of maximum spurious emission.
- To convert spectrum reading E(dBuV/m) to EIRP(dBm)
   EIRP(dBm) = Level (dBuV/m) + 20log(d) -104.77,
   where d is the distance at which filed strength limit is specified in the rules
- 7. Field Strength Level (dBm) = Spectrum Reading (dBm) + Antenna Factor + Cable Loss + Read Level Preamp Factor.
- 8. ERP (dBm) = EIRP (dBm) 2.15
- 9. The RF fundamental frequency shall be excluded against the limit line in the operating frequency band.
- 10. The limit line is derived from 43 + 10log(P) dB below the transmitter power P(Watts)
