This exterior label can use wording such as the following: "Contains Transmitter Module FCC ID:RI7LE910Q1SN or"Contains FCC ID:RI7LE910Q1SN. Any similar wording that expresses the same meaning may be used. The Grantee may either provide such a label, an example of which must be included in the application for equipment authorization, or, must provide adequate instructions along with the module which explain this requirement. In the latter case, a copy of these instructions must be included in the application for equipment authorization.	Y Please see exhibition label sample for the FCC ID of this module. And also in the exhibition Users manual, there are instructions give to the OEM on how to label the end product.
7. The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements. A copy of these instructions must be included in the application for equipment authorization.	Y The EUT is compliant with all applicable FCC rules.
