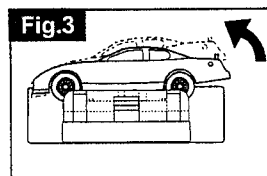
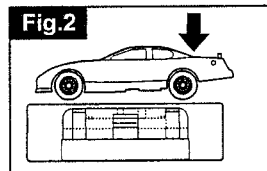
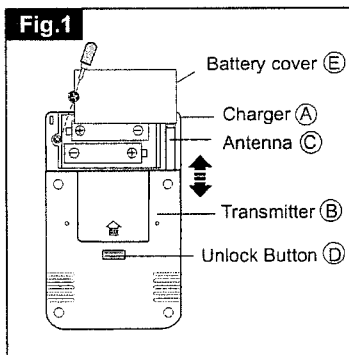


OWNER'S MANUAL

Please read carefully before operating your vehicle. Keep these instructions for future reference as they contain important information.

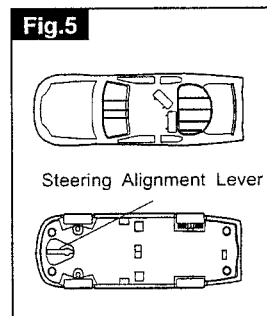
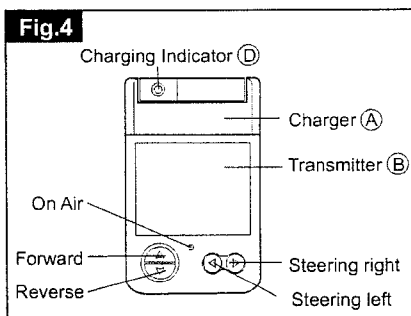
SET UP

Push the Unlock button ④, slide the Charger ①, then separate the Transmitter ② from Charger ①. (See diagram Fig. 1) Install 2 x AA batteries to the Battery compartment with correct polarity. To remove the battery cover ⑤, use screwdriver to turn the screw in anticlockwise. (See diagram Fig. 1)



Vehicle has rechargeable Ni-Cd battery. Quick boost charge the Vehicle for around 1 minute by placing the Vehicle on Charger platform correctly. (See diagram Fig. 2) Red LED light ④ indicates that Vehicle is charging. When LED light goes off, charging has been completed. Remove the vehicle from the charging platform as shown in Fig. 3.

Slide the Charger ① into Transmitter ②. (See diagram Fig. 1) Extend the antenna ③. Press any Transmitter button to run and control Vehicle. (See diagram Fig. 4)



RACE

Adjust the Steering alignment lever Left or Right when the steering is not properly aligned. (See diagram Fig. 5). Operate your Vehicle in a dry, open area, do not drive in the street. Keep away from sands and water. Do not operate your Vehicle too far away from the Transmitter, your signal strength will become weak and Vehicle will not function properly. The maximum range for the Vehicle should be between 20 to 30 feet (7 to 10 metres), when operating outdoor. For best results, hold Transmitter antenna up, not pointed down toward R/C Vehicle.

BATTERY PRECAUTIONS

- ★ Never mix alkaline/standard (carbon-zinc) and rechargeable (nickel cadmium) batteries.
- ★ Non-rechargeable batteries are not to be recharged.
- ★ Rechargeable "AA " batteries are to be removed from the toy before being charged.
- ★ Packaging materials must be removed by an adult.
- ★ Different types of batteries or new and used batteries are not to be mixed.
- ★ Only batteries of the same as equivalent type as recommended are to be used.
- ★ Batteries are to be inserted with the correct polarity.
- ★ Exhausted batteries are to be removed from the toys.
- ★ The supply terminals are not to be short-circuited.
- ★ Rechargeable batteries may only be charged under the supervision of an adult.
- ★ Do not dispose of batteries in fire, batteries may explode or leak.

RADIO INTERFERENCE

When your R/C Vehicle runs erratically or loss of control, the problem is due to being in an area near High Tension Wires, Telephone Poles with High-Voltage Transformers, CB Radios, even certain Building or other R/C Vehicle running close by on the same frequency as yours, you may have to choose different location.
